

INTRODUCTION

1. This is the fourth annual report on the implementation status of actions taken by Headquarters divisions, regional bureaux and country offices in response to evaluation recommendations. It covers recommendations arising from evaluations presented to the Board in 2008, 2009, 2010, 2011 and 2012.

2. The report has five sections: i) a brief description of the method; ii) an overview of relevant evaluation reports, recommendations and management actions; iii) an overview of the quantity and geographical distribution of recommendations; iv) analysis of implementation status, by evaluation type and region; and v) a summary and conclusions.

METHOD

- 3. The Performance Management and Monitoring Division tracks management's actions and responses to determine the implementation status and required follow-up. The implementation status categories are the same as used in the 2011 report:
 - ➤ **Implemented**: Action completed by 31 December 2012.
 - **Outstanding:** Action not completed by 31 December 2012.
 - Not applicable: Action not implemented because of changing circumstances or contexts.

EVALUATIONS PRESENTED TO THE BOARD

- 4. Since 2008, 57 evaluation reports with management responses have been presented to the Board. The evaluation categories established by the Office of Evaluation (OEV), and the type of action each category includes are:
 - operation evaluations, recommending specific actions;
 - **country portfolio evaluations,** suggesting principles to guide WFP country offices;
 - > strategic evaluations, suggesting approaches or courses of action; and
 - **impact evaluations,** making recommendations that influence current and future actions.
- 5. Of 57 evaluation reports, 37 percent were operation evaluations (21), strategic evaluations accounted for 32 percent (18), country portfolio evaluations for 21 percent (12) and impact evaluations for 10 percent (6).
- 6. Over the last five years, 33 percent of the actions contained in evaluation recommendations pertain to operation evaluations, 30 percent to strategic evaluations, 26 percent to country portfolio evaluations, and 11 percent to impact evaluations.

¹ In 2008, the Secretariat prepared management responses to the recommendations to strategic evaluation reports only; starting in 2009 all evaluation reports presented to the Board were accompanied by management responses.

QUANTITY AND GEOGRAPHICAL DISTRIBUTION OF RECOMMENDATIONS

- 7. Since 2008, OEV has issued 492 recommendations in 57 evaluation reports. The number of recommendations made each year increased from 57 in 2008 to 154 in 2010, falling to 112 in 2011 and 78 in 2012. The average number of recommendations per evaluation decreased from 14 in 2008 to six in 2012.
- 8. In response to all the recommendations issued from 2008 to 2012, management agreed to implement 798 actions; 178 of these were from 2012. Most actions 66 percent are for field offices; 34 percent are for Headquarters. In 2012, management agreed to implement an average of 15 actions per evaluation.

9. The geographical breakdown of actions shows that an increasingly greater share is for the East and Central Africa region. Headquarters has the highest number of actions overall.



IMPLEMENTATION STATUS OF ACTIONS FROM 2008 TO 2012

10. The following analyses cover 52 evaluation reports² with 728 actions. Of these, 469 actions were either implemented or no longer applicable at 31 December 2012:

- ➤ 421 were implemented by 31 December 2012 (58 percent);
- ➤ 48 were deemed not applicable (6 percent);
- ➤ 259 are outstanding (36 percent).
- 11. Of the 728 actions, 535 were due by 31 December 2012; this was the implementation target for 2012.

IMPLEMENTATION RATES BY TYPE AND REGION

12. Implementation rates varied significantly by type of evaluation (Table 4): while 80 percent of all agreed actions from operation evaluations were implemented by the end of 2012, the equivalent figure for country portfolio evaluations was 91 percent; figures for strategic and impact evaluations were 72 and 66 percent respectively. These figures reflect the greater complexity of implementing actions stemming from strategic and impact evaluations, which often require more coordination and involve policy issues and collaboration across WFP and beyond. This applies particularly to impact evaluations, which by definition imply depth, breadth and a longer perspective in the recommendations they make. Timelines for implementing actions stemming from these recommendations are often over-optimistic and underestimate the external factors that need to be considered to enable implementation.

13. In the Asia region, 85 percent of the 107 actions due at 31 December 2012 were implemented; in the Southern Africa region, 93 percent of 27 actions were implemented; and in the East and Central Africa region, 83 percent of 93 actions were implemented (Table 5). The implementation rate for Headquarters is lower than the average implementation rate for country offices and regional bureaux; Annex II shows implementation rates by entity.

SUMMARY AND CONCLUSIONS

14. From 2008 to 2012, 81 percent of the actions with a deadline of 31 December 2012 from 57 evaluation reports were fully implemented; 66 actions remain pending. While an 81 percent implementation rate is higher than that of comparable organizations, WFP is committed to increasing this rate for 2013. Each action has a timeline; managers are held accountable for action, and for sharing reports with the Board. WFP tracks the implementation of evaluation recommendations continuously, and reports on performance in achieving targets in its Annual Performance Report.
