POLICY ISSUES

EB.1/2007 (19–21 February)

Annual Report for 2006 to ECOSOC and FAO Council (A)

The Annual Report to ECOSOC and FAO Council is presented at the First Regular Session every year in accordance with the Board's 2004 decision on streamlining corporate reporting to the Board and WFP parent bodies (WFP/EB.A/2004/5-F). The report provides a comprehensive picture of WFP's engagement in United Nations system-wide activities, organized according to the common format for United Nations funds and programme reports to ECOSOC and taking into account the comments expressed by the WFP Board on the desired content of the report. This report is presented to the Board for approval.

Ending Child Hunger and Undernutrition Initiative (A)

At its Second Regular Session in 2006, the Board asked the Secretariat for additional information about the Ending Child Hunger and Undernutrition Initiative (ECHUI). This paper and its annexes include clarifications of WFP's role and estimated budget for its participation in the ECHUI workplan, the status of the Partners Group, milestones for 2007–2008, a draft workplan and timetable and terms of reference for the Steering Group and Secretariat. This report is submitted for approval; the revised draft of the Global Framework for Action is presented as an addendum to the report.

➤ An Update on WFP Interventions in Disaster Preparedness and Mitigation (I)

This paper, for information, summarizes WFP's existing policy framework for implementing measures to mitigate the impact of natural disasters. The paper also provides an update to the Executive Board on the range of programmes and actions undertaken by WFP to support preparedness and mitigation efforts in countries facing recurrent natural disasters.

EB.A/2007 (4-8 June)

➤ Annual Performance Report for 2006 (A)

General Rule VII.2 states: "Each year the Executive Director shall submit to the Board for its approval an Annual Report and other reports as directed by the Board". Governance recommendation (h), approved by the Board at its Third Regular Session in 2000 (decision 2000/EB.3/1—Follow-up to Executive Board decision 2000/EB.A/6 on Governance), states: "An Annual Performance Report should be developed" based on the Biennial Management Plan previously approved.

The Annual Performance Report for 2006 aims to present a relevant and evidence-based analysis of WFP's performance, reflecting the commitments made for the year as defined in the Strategic and Management Plans.

Progress Report on the Implementation of the Management Response to the External Evaluation of WFP's Enabling Development Policy (C)

At its Second Regular Session in 2005, the Board took note of the "Response to the Evaluation of WFP's Enabling Development Policy" (WFP/EB.2/2005/4-A), and noted that WFP would require enhanced support from donors and national governments to implement the actions proposed in the document. The Board undertook to review progress on implementation of the response at a future session. This document, for consideration, will provide an overview of progress on the actions proposed or initiated set out in the document.

Time to Deliver – An Update on WFP's response to HIV and AIDS (I)

At its First Regular Session in 2003, the Board asked to be informed annually about the status of WFP HIV/AIDS activities and relations with the Joint United Nations Programme on HIV/AIDS (UNAIDS). The update is therefore submitted to the Board for information.

Comprehensive Policy on Human Resources (C)

As requested by the Board at its Second Regular Session in 2006, the Secretariat will provide a Comprehensive Policy on Human Resources to the Board for consideration.

> Emergency Needs Assessment: Final Progress Report on the Implementation Plan and Next Steps (1)

At its Second Regular Sessions in 2005 and 2006, the Board took note of the progress made in strengthening WFP's emergency needs assessments under the 30-month implementation plan (July 2004–December 2006), and was apprised of plans for a 12-month transition period (January–December 2007) to evaluate the outcomes and lay the groundwork for mainstreaming essential components into WFP's regular budget. This document, submitted to the Board for information, provides a final progress report on the implementation plan and outlines WFP's proposed strategy for maintaining core emergency needs assessment, analysis and preparedness capacities into the Biennial Management Plan (2008–2009).

➤ Update of Consolidated Framework of WFP Policies (I)

At its Annual Session in 2000, the Executive Board approved the recommendations contained in the Report on the Working Group on Governance (decision 2000/EB.A/6). Governance recommendation (d) established that WFP policy statements should be codified in a compendium. The "Consolidated Framework of WFP Policies" was first submitted to the Board at its Annual Session in 2002. A hard copy of the update of the Consolidated Framework is submitted to the Board for information. (An electronic update is available at the WFP website www.wfp.org)

Update on WFP's Engagement in Poverty-Reduction Strategies (I)

This paper, for information, updates the Board on progress in WFP's engagement with poverty reduction strategies. Following approval in 2006 of the WFP policy paper "Engagement in Poverty Reduction Strategies" (WFP/EB.A/2006/5-B), a number of initiatives have been undertaken to provide guidance to country and regional offices in their efforts to engage in poverty reduction strategy processes. This paper describes these initiatives and outlines emerging strategic issues and challenges facing WFP.

The Annual Performance Report for 2007 aims to present a relevant and credible analysis of WFP's performance in terms of the commitments made for the year as defined in the Strategic and Management Plans for 2006–2009.

> Strategic Plan (2008–2011) (A)

The Strategic Plan is the second of the governance tools agreed upon in 2000 to be presented to the Executive Board. The Strategic Plan guides all WFP activities by setting out the direction and objectives of WFP's work and the investment priorities for all organizational functions. This document is submitted to the Board for approval.



Gender Policy (2008–2012) (A)

A new/revised Gender Policy will be developed on the basis of the results and recommendations of the Enhanced Commitments to Women comparative follow-up survey and the final evaluation of the Gender Policy 2003–2007. This document is submitted for approval.

ightharpoonup Food for Work (A/C)

One of WFP's strategic objectives - SO2 - is to protect livelihoods in crisis situations and enhance resilience to shocks. Food-for-work initiatives are central activities under this objective. Food-for-work schemes have long been employed by WFP to preserve essential assets during crises, to support recovery from crisis, to develop key physical and human assets, and as components of national safety-net programmes. This policy paper, submitted for consideration, provides a systematic review of design, implementation, and impacts of food-for-work activities within WFP. Based on this review, and on broad consultations within WFP and with partners, the paper also outlines key policy issues and challenges facing WFP in employing food for work to meet Strategic Objective 2.

➤ Food for Training (A/C)

This paper examines lessons learned from experience, including implementation of the commitment to ensure that women and adolescent girls constitute at least 70 percent of the participants in food-assisted training activities, articulated in the Gender Policy approved by the Board at its Third Regular Session of 2002.

► Food for Education (A/C)

This paper highlights the role that food aid interventions (including school feeding) can play in support of food for education objectives. The paper also clarifies the difference between food for education and school feeding.

> Annual Update on HIV/AIDS (I)

At its First Regular Session in 2004, the Board requested to be kept informed each year on the status of WFP HIV/AIDS activities and relations with UNAIDS. This annual update is submitted to the Board for information at its Annual session.

EB.2/2008 (27-31 October)

EB.1/2007 (19–21 February)

Summary Report of the Evaluation of Darfur EMOP 10339.0/1 (C)

The evaluation covers the two initial phases of emergency operation (EMOP) 10339.0/1 and examines EMOP operations from April 2004 to December 2005. The evaluation was implemented in two phases, beginning in November 2005, including a first design phase undertaken by Tufts University. The evaluation builds on earlier evaluations, including an OCHA-led inter-agency real-time evaluation of humanitarian assistance to Darfur. This document is submitted to the Board for consideration.



> Summary Report of the Mid-Term Evaluation of the India Country Programme (2003-2007) (C)

The evaluation was conducted in April 2006 by a team of three independent international consultants. It assesses the extent to which the current CP, as implemented, has provided the best possible modalities for reaching the intended objectives, on the basis of results to date. The main purpose of the evaluation was to draw lessons from the capacity and model-building initiatives and advocacy efforts for the design of future WFP assistance to India, as well as for the design and planning of similar efforts in other countries and regions.

Evaluation of Indonesia Special Operation 10498.0 (I)

At the request of the WFP Ocean Transport Services, this evaluation was conducted in July/August 2006 by two independent consultants. The WFP shipping service for Aceh and Nias in Indonesia was set up in October 2005 to facilitate delivery by sea and logistics coordination of material, in particular shelter material, for rehabilitation and reconstruction of people's livelihoods following the tsunami. The purpose of the evaluation was primarily to learn from the current operation and opportunities emerging from its implementation as well as to inform the design of any new phase.

EB.A/2007 (4-8 June)

Summary Report of the Thematic Evaluation of School Feeding in Emergency Situations (C)

The thematic evaluation of WFP school feeding in emergencies establishes the extent to which current practices are relevant and effective; identifies most common pitfalls, and proposes suggestions for improving future implementation. The evaluation is based on a combination of desk research and field-based case studies among WFP's ongoing PRROs and EMOPs. The latter were conducted between October and December 2006.

Summary Report of the Mid-Term Evaluation of the Southern Africa Regional PRRO 10310.0 (C)

The evaluation of the Southern Africa regional PRRO - "Assistance to Populations in Southern Africa Vulnerable to Food Insecurity and the Impact of AIDS" took place during November-December 2006 and covered seven countries. Its main findings included: (a) the need for a more assured funding base for assistance to the longer-term HIV-AIDS caseload of infected and affected persons; (b) that consideration be given to developing a social protection approach on an individual country PRRO basis in future and (c) the need for stronger technical support in several areas, including to HIV-AIDS interventions, particularly through developing stronger partnerships.

Summary Report of the Evaluation of PRRO Indonesia 10069.1 (C)

In addition to accountability of results, the evaluation of this PRRO, undertaken in September 2006, contributed to the design of the future phase. Evaluation results show that the effectiveness of the operation could be increased by (i) encouraging greater convergence with related national programmes for health, education and infrastructure supported by bilateral and multilateral donors, and (ii) as a greater cohesion between PRRO programme components. WFP's commendable work on early-warning systems and on mapping for the Food Security Atlas and nutritional surveillance was highlighted as it contributes to an increased knowledge base and advocacy to influence government policy. WFP's efficient and timely responses to natural disasters suggest that it should maintain a presence in Indonesia which is prone to disasters.

EB.2/2007 (22–26 October)

➤ Evaluation of the Strengthening Emergency Needs Assessment Implementation Plan (C)

This evaluation is being undertaken at the request of the Emergency Needs Assessment Branch (ODAN). The main objective of the evaluation is to provide an external assessment of the progress made to improve the utility, credibility, transparency and quality of the ENA undertaken in WFP.

➤ Evaluation of Haiti PRRO (C)

The evaluation of this PRRO is planned for the fourth quarter of 2006. It will examine whether the intervention approach has adequately addressed the immediate food needs of those most affected by crises and helped them to recover their food security.

Evaluation of the Kenya Country Portfolio (C)

This evaluation will provide a mid-term review of WFP's country programme in Kenya as well as a summative assessment of the 2004-2006 phase of the EMOP. It will be conducted in Kenya over the period February-March 2007, by a team of three international and two Kenyan national consultants. The objectives of the evaluation are three-fold: accountability, guidance and learning.



Evaluation of Ethiopia PRRO (C)

The mid-term evaluation of the Ethiopia PRRO scheduled for November 2006 will examine, inter alia, the effectiveness of the intervention approaches and their potential impact on people's livelihood, including graduation from chronic vulnerability. The Ethiopia PRRO is currently one of WFP's largest operations globally.

EB.1/2008 (4-8 February)

➤ Peer Review of the Evaluation Function in WFP (C)

An external peer review of WFP's evaluation function will be conducted in 2007, taking into account the lessons learned from the recent peer reviews of the UNDP and UNICEF evaluation functions. The Office of Evaluation will be working with the United Nations Evaluation Group (UNEG) in late 2006/early 2007 to develop the framework and Terms of Reference for this peer review.

Evaluation of Algeria PRRO (C)

The evaluation of the PRRO 10172.1 in support of the Western Saharan refugees in Algeria is scheduled for the second half of 2007 and will assess the extent to which the operation's goals and objectives are being achieved. This will be the first OEDE evaluation of this long-running operation.

> Evaluation of Colombia PRRO (C)

The evaluation of this PRRO in support of internally displaced persons in Colombia is planned to contribute to the preparation of a possible new PRRO. Together with the country office and key stakeholders, a concept paper has been developed and a preparatory mission undertaken to identify the key issues. The evaluation mission will take place in February 2007.

EB.A/2008 (9-13 June)

➤ Annual Evaluation Report (C)

In the context of strengthening the evaluation function in WFP, the Annual Evaluation Report (AER) prepared by the Office of Evaluation, was introduced in 2005 for the Annual Informal Consultation on Evaluation. It provides a synthesis of findings from all evaluations completed in a given year, i.e. both by the Office of Evaluation and the regional bureaux and country offices and thus allows for an insight into generic and corporate issues that go beyond individual project evaluations. As it was considered an important and useful tool, Board members expressed the wish to discuss it more formally at the Annual Board Session and suggested to include the AER in the Board session's agenda. The AER is presented for consideration.

Thematic Evaluation of WFP's Response to Management of Emergencies (C)

Following the meta and thematic evaluations of the Country Programme (2002) and PRRO (2004) programme categories, the Office of Evaluation plans to undertake a thematic evaluation of the EMOP programme category in 2007. This evaluation will look at generic issues relating to WFP's emergency interventions and will examine corporate progress made since 1999, when OEDE published a report entitled "Thematic Study of Recurring Challenges in the Provision of Food Assistance in Complex Emergencies".

End-of-term Evaluation of WFP's Enhanced Commitments to Women (C)

In line with the Gender Policy (2003–2007), an end-of-term evaluation of WFP's enhanced commitments will be undertaken in late 2007/early 2008 and will assess the extent to which the gender policy has been applied and commitments implemented in WFP's operations. (Note: It is possible that this evaluation report may be postponed to EB.2/2008 if more time is required to finalize the field work).

➤ Thematic Evaluation of WFP's HIV/AIDS Interventions (C)

This thematic evaluation will take place during 2007 and intends to take stock of WFP's growing experience with regard to food assistance to HIV/AIDS affected populations, in order to identify best practices. The focus will be on strategic and operational approaches with regard to prevention, care and treatment. Targeting issues, particularly with regard to orphans and children will also be assessed.
