At its Second Regular Session of 2001, the Board asked to be regularly informed about emergency operations (EMOPs) approved either jointly by the Executive Director and by the Director-General of the Food and Agriculture Organization of the United Nations (FAO) or under the delegated authority of the Executive Director.

- 2. The first report on EMOPs approved in the previous semester was presented at the Board's Second Regular Session of 2002. Subsequently, this information has been provided twice a year.
- 3. This report covers EMOPs approved between 1 January and 30 June 2006. The next report, covering the second half of 2006, will be submitted to the First Regular Session in February 2007.
- 4. All the EMOPs approved in the first semester of 2006 are shown in the attached tables. Table A lists EMOPs with a food commitment value of more than US\$3 million, approved jointly by the Executive Director and the Director-General of FAO. Table B lists those approved by the Executive Director with a food value of less than US\$3 million. Table C lists immediate-response EMOPs with a total individual value of less than US\$500,000 approved by country or regional directors under the authority delegated to them by the Executive Director.
- 5. During the period under review, 11 EMOPs were approved: three jointly by the Executive Director and the Director-General of FAO; two by the Executive Director; and six immediate-response EMOPs by country or regional directors. These operations represent a commitment of 814,886 mt of food, to assist 9.2 million people at a total food cost of US\$186.7 million and an overall combined operational and support cost to WFP of US\$796.8 million.
- 6. The EMOPs jointly approved by the Executive Director and the Director-General of FAO were for the Sudan, the Philippines and the United Republic of Tanzania. These aimed to assist a total of 8.8 million people at an overall cost to WFP, including transport and support costs, of US\$789.8 million.
- 7. The two EMOPs approved by the Executive Director were for Bolivia and Nepal, to assist a total of 270,000 people at an overall cost to WFP of US\$5.1 million.
- 8. WFP country directors approved immediate-response EMOPs in Algeria, Bolivia, Ecuador, Egypt, Guinea-Bissau and Indonesia, assisting 157,000 people at a total overall cost to WFP of US\$1.9 million.

EMOPS APPROVED JOINTLY BY THE EXECUTIVE DIRECTOR AND THE DIRECTOR-GENERAL OF FAO

9. EMOP Sudan 10503.0 "Food Assistance to Population Affected by Conflict" was the first EMOP approved this year, on 5 January. It accounts for more than 90 percent in value of the total approvals in the semester. This one-year EMOP for January - December 2006 includes all WFP emergency food assistance to the country. It continues assistance provided under two previous EMOPs – 10048.3 for the South, the Three Areas and the East, and 10339.1 for Darfur, both of which ended on 31 December 2005. A total of 6.1 million beneficiaries are planned for 2006 – 2.7 million for Darfur, 1.9 million for the South and 1.5 million in the Three Areas and the East – at an overall cost to WFP of US\$746 million.

10. WFP has resumed assistance to the Philippines supporting conflict-affected people in Mindanao, returning internally displaced people and expanding food-based safety net programmes. The one-year EMOP 10489.0 "Assistance to Conflict-Affected in Mindanao" was approved to assist 2.1 million beneficiaries from March 2006 to February 2007, at a total cost to WFP of US\$27.2 million.

11. EMOP 10519.0 "Assistance to Drought-Affected Persons in Tanzania" assisted 565,000 people from May to September 2006. The United Republic of Tanzania requested assistance to complement its own drought-relief efforts. The total cost of the operation to WFP is US\$16.6 million.

EMOPS APPROVED BY THE EXECUTIVE DIRECTOR

- 12. Bolivia requested international assistance with major flooding in early 2006. EMOP Bolivia 10517.0 "Assistance to Highly Food-Insecure Flood Victims" follows the immediate-response EMOP approved by the country director and provides assistance to 45,000 people for ten months at a total cost to WFP of US\$1.9 million.
- 13. Western Nepal requested WFP assistance with a severe winter drought. EMOP 10523.0 "Food Assistance to Drought-Affected People" provided a two-month food ration to 225,000 beneficiaries at a total cost to WFP of US\$3.2 million.

IMMEDIATE-RESPONSE EMOPS APPROVED BY COUNTRY DIRECTORS

- 14. The six immediate-response EMOPs approved during the period under review were only a fraction of the total approved value of EMOPs, but provided a timely response to the needs of people affected by sudden emergencies. In Guinea-Bissau, WFP provided short-term assistance to people internally displaced by conflict. In Algeria and Egypt, WFP provided short-term assistance to refugees affected by exceptional difficulties. Flood victims were assisted in Bolivia and Ecuador. WFP provided assistance to earthquake victims in Indonesia.
