

POLICY ISSUES

EB.1/2006 (20–23 February)

➤ *Targeting in Emergencies (A)*

This paper, submitted to the Board for approval, reviews and assesses WFP's targeting policies and practices in emergency situations, updates the Board on the latest trends in this area and the Board wish to. This document and the access are prepared in response to the Board's request, its discussion of the first "Consolidated Framework of WFP Policies" at its 2002 Annual Session, that the Secretariat present proposals for policy topics to be discussed at future sessions, with on topics related to emergencies.

➤ *Humanitarian Access and its Implications for WFP (I)*

This paper informs the Board of processes that clarify WFP's approach, in collaboration with its United Nations partners, to securing safe and unhindered access to people affected by emergencies, and to seeking guidance where needed. The paper is prepared in response to the Board's request, in its discussion of the first "Consolidated Framework of WFP Policies" at its 2002 Annual Session that the Secretariat present proposals for policy topics to be discussed at future sessions, with particular focus on topics related to emergencies.

➤ *Annual Report for 2005 to ECOSOC and the FAO Council (A)*

The Annual Report to the Economic and Social Council (of the United Nations) (ECOSOC) and the Food and Agriculture Organization of the United Nations (FAO) Council is presented at the First Regular Session every year in accordance with the Board's 2004 decision on streamlining corporate reporting to the Board and WFP parent bodies (WFP/EB.A/2004/5-F). The report provides a comprehensive picture of WFP's engagement in United Nations system-wide activities, organized according to the common format for United Nations funds and programme reports to ECOSOC and taking into account the comments expressed by the WFP Board on the desired content of the report. This report is presented to the Board for approval.

➤ *Food Procurement in Developing Countries (C)*

This paper, for consideration, clarifies WFP's procurement of food commodities and its potential for making a positive contribution in developing countries.

➤ *Ending Child Hunger and Undernutrition Initiative: Progress Report (I)*

This will be an oral presentation, made to the Board for information. It will summarize further progress made in the design and development of the Initiative internal to WFP, with UNICEF and the World Bank, and with partners.

EB.A/2006 (12–16 June)

➤ *Annual Performance Report for 2005 (A)*

General Rule VII.2 states: "Each year the Executive Director shall submit to the Board for its approval an Annual Report and other reports as directed by the Board". Further, Governance recommendation (h), approved by the Board at its Third Regular Session in 2000 (decision 2000/EB.3/1—Follow-up to Executive Board Decision 2000/EB.A/6 on Governance), states: "An Annual Performance Report should be developed" based on the Biennial Management Plan previously approved. An interim Annual Performance Report (APR) for 2003 (WFP/EB.A/2004/4-A) was submitted for consideration in 2004 and the Board recognized that it "reflected in its substance the scope and function of the new governance arrangements" (WFP/EB.A/2004/9). It was also noted that the APR, which meets the requirements set out in General Rule VII.2, will replace the Annual Report of the Executive Director, commencing with the APR 2004 (WFP/EB.A/2004/5-F).



The APR 2005 is the major accountability tool for monitoring and reporting on annual performance compared with the plans set out in the 2004–2007 Strategic and the 2004–2005 Biennial Management Plans. Part I of the APR discusses the strategic context in which WFP works and main challenges faced in 2005, as requested by the Board (Bureau meeting, December 2004). Part II provides highlights of WFP performance in 2005 with a focus on main results by strategic priority and five main operations. Part III highlights achievements for the five Strategic Priorities, including outcome-level results, and for the nine Management Priorities. Lessons are incorporated throughout the document in addition to a more in depth discussion of lessons in Part IV. The Annexes presents WFP's performance framework, and additional data on staffing, contributions and donors, food procurement, operational expenditures by region, country and category for 2005.

➤ *Harmonized Country Programme Approach (C)*

The United Nations Development Group (UNDG) has developed options for improving the harmonized country programme approval process, in response to General Assembly resolutions calling for greater coherence of United Nations development activities at the country level. The Board decided at its Second Regular Session in 2005 that it would return to the Common Country Programme Approach at its Annual Session in 2006 at the latest, and invited the Bureau to examine with the assistance of the Secretariat how the Board's oversight and budget responsibilities could be safeguarded under this new approach. A document responding to this request and reflecting consultations among all the UNDG Executive Committee funds and programmes will be submitted to the Board **for approval**.

➤ *Engagement in Poverty Reduction Strategies (C)*

The paper, for consideration, considers the experience with and options for WFP engagement with Poverty Reduction Strategies on the basis of its comparative advantages. It places participation in the context of the ongoing reform of the United Nations system towards joint programming, harmonization and simplification and recommends options for further consideration.

➤ *The Role and Application of Economic Analysis in WFP (C)*

The paper, **for consideration**, defines the role and application of economic analysis in WFP; this includes formulating country programmes and operations, and designing sectoral strategies. It draws lessons from ongoing initiatives, including ensuring that WFP's activities support Poverty Reduction Strategy Papers and national sectoral development programmes and applying market analysis to the emergency needs assessment process.

➤ *Reports on HIV/AIDS:*

○ *Five Years Later: An Update on WFP's response to HIV/AIDS*

At its First Regular Session in 2004, the Board asked to be informed annually about the status of WFP HIV/AIDS activities and relations with the Joint United Nations Programme on HIV/AIDS (UNAIDS). The update is therefore submitted to the Board **for information**.

○ *Global Task Team Recommendations on Improving AIDS Coordination among Multilateral Institutions and International Donors*

In 2005, the UNAIDS Executive Board urged all governing bodies of its co-sponsors to consider and endorse the recommendations of the Global Task Team (GTT) on improving AIDS coordination among multilateral donors and international donors. The Recommendations of the Global Task Team are submitted to the Executive Board for endorsement. These recommendations have already been endorsed by the Executive Boards of all ten co-sponsoring agencies, and that of The Global Fund to Fight AIDS, Tuberculosis and Malaria.

➤ *Progress Report on the Ending Child Hunger and Undernutrition Initiative (I)*

This paper, **for information**, summarizes further progress made in the design and development of the initiative between WFP, the United Nations Children's Fund (UNICEF) and other partners.

➤ *Management Response to the Evaluation of Mother and Child Nutrition Interventions (I)*

The Summary Report of the Thematic Review of WFP-Supported Mother-and-Child Nutrition Interventions was discussed at the Board in February 2006 (WFP/EB.1/200/7-C). The Board requested a more detailed management response to the recommendations made in the report. This revised management response is therefore submitted to the Board **for information**.



➤ *Management Response to the Thematic Evaluation on Targeting (I)*

The Summary Report of the Thematic Review of Targeting in Relief Operations was discussed at the Board in February 2006 (WFP/EB.1/2006/7-B). The Board requested a more detailed management response and implementation timeframe for the review recommendations. This revised management response is therefore submitted to the Board **for information**.

➤ *Update on WFP Food Procurement (I)*

This report, presented **for information**, (i) provides statistics on food procurement in the first quarter of 2006, (ii) an update on food procurement capacity and the cost of beginning to augment this capacity, (iii) an analysis of the cereals markets in the eastern part of Africa from October 2005 to April 2006 and the interplay between local, regional and international procurement and (iv) information on the studies and analytical tools being developed to enhance understanding of the nature of food procurement activities.

EB.2/2006 (6–10 November)

It will be the basis for WFP's operational follow-up and further development of the initiative.

This paper, for information, reviews trends in the availability and sources of food aid, and the implications of those trends for WFP.

➤ *Status Report on Emergency Needs Assessment (I)*

- *Food for Education (C)*

This paper, for consideration, highlights the role that food aid interventions (including school feeding) can play in support of food for education objectives. The paper also clarifies the difference between food for education and school feeding.

- *Food for Training (C)*

This paper, for consideration, examines lessons learned from experience, including implementation of the commitment to ensure that women and adolescent girls constitute at least 70 percent of the participants in food-assisted training activities, articulated in the Gender Policy approved by the Board at its Third Regular Session of 2002

EB.1/2006 (20–23 February)

The evaluation document submitted under this item is presented to the Board for consideration. The Board is requested to take note of the report and the associated information note summarizing the action taken so far by management in implementing the recommendations.

➤ *Evaluation of WFPs Assistance to China (1979-2005)*

The evaluation took place between May 2004 and October 2005 including a preparatory mission in June 2004 and a three-week field mission in May 2005. As WFP is ending operational activities in China in December 2005, the summary report includes a desk review of the period 1979–2000 as well as an evaluation of the last country programme in order to resume findings and lessons to be learned from the entire period. The report focuses on the results achieved and the partnerships with the Government of China and other partners, particularly the International Fund for Agricultural Development (IFAD).

➤ *Thematic Evaluation of Targeting in Relief Situations*

In cooperation with the Strategy, Policy and Programme Support Division (PDP), OEDE will undertake in 2004–2005 a thematic evaluation on challenges and constraints facing WFP in the effort to ensure efficient and effective targeting. The evaluation results should support new corporate policy formulation, especially in relation to relief targeting. It will focus on selected relief situations that are on-going or that have recently been completed.

➤ *Summary Report of the Thematic Review of WFP-supported Mother-and-Child Nutrition Interventions*

As a follow-up to the “Desk Review of Mother-and-Child Nutrition (MCN) Activities” undertaken in 2002, the Nutrition Service (PDPN) has requested OEDE to carry out a thematic review of current approaches in WFP-supported nutrition interventions, based on four case studies in different geographical regions. The review, carried out between January and August 2005, assessed the extent to which the four principles essential for the success of MCN programmes have been applied and their effectiveness in reaching programme objectives.

➤ *Joint UNHCR-WFP Evaluation of the Pilot Food Distribution Projects*

The main objective of the evaluation jointly undertaken by the Office of the United Nations High Commissioner for Refugees (UNHCR) and WFP was to assess the effectiveness of the new arrangement under which WFP assumes responsibility for food distributions in refugee operations, piloted in five countries. Evaluation findings should facilitate future decisions by UNHCR and WFP on whether food distributions should be handed over to WFP.

EB.A/2006 (12–16 June)

The evaluation documents submitted under this item are presented to the Board for consideration. The Board is requested to take note of the reports and the associated information note summarizing the action taken so far by management in implementing the recommendations.

➤ *Mid-term Evaluation of CP Bhutan 10133.0 (2002-2007)*

The evaluation of Bhutan’s first country programme in September/October 2005 reviews achievements at mid-term and suggests ways to enhance the impact of the programme, providing guidance for the future direction of WFP activities in Bhutan.

➤ *Evaluation of WFP’s Response to the Crisis in Niger*

The evaluation of WFP’s Response to the Niger Emergency, EMOP 10398.0 “Assistance to Populations Affected by the Drought and Locust Infestations in 2004”, makes the distinction between the period before the humanitarian crisis (Harvest 2004 to July 2005) and the worsening of the crisis, and its management until December 2005.

➤ *Evaluation of the PRRO Somalia 10191.0*

The evaluation of the Somalia PRRO focuses on the relevance and effectiveness of intervention approaches in responding to vulnerability in the Somali environment. Issues such as gender, protection, monitoring and evaluation (M&E) and partnerships are also examined.



➤ *Evaluation of CP Yemen 10137.0 (2002-2007)*

The evaluation of the current country programme in Yemen, which aimed to assess on the basis of results to date the extent to which the programme as designed and implemented, has provided the best possible modalities of reaching intended objectives. With respect to findings regarding relevance, efficiency, effectiveness and sustainability, the evaluation provided leads for designing the next country programme.

➤ *Evaluation on the Business Process Review*

The Board will have before it a report evaluating the implementation of the Business Process Review (BPR) to date.

EB.2/2006 (6–10 November)

The evaluation documents submitted under this item are presented to the Board for consideration. The Board is requested to take note of the reports and the associated information note summarizing the action taken so far by management in implementing the recommendations.

➤ *Evaluation of the Darfur EMOP*

The evaluation of the first phase of WFP's EMOP in Darfur will cover the period January to December 2005. Scheduled for implementation in early 2006, it follows a 2004 evaluation of WFP's emergency activities in the Sudan, and will draw heavily on this as well as several key partner evaluations undertaken in 2005.

➤ *Synthesis Report of the Tsunami Evaluation Coalition Main Findings (I)*

At the Board's Second Regular Session in 2005, delegates agreed to a proposal from the Office of Evaluation that an information paper should be presented to the Second Regular Session of 2006 on the main findings of the five thematic evaluations being managed by the Tsunami Evaluation Coalition (TEC) on coordination, needs assessment, local capacities, linking relief, rehabilitation and development (LRRD) and the funding response.

➤ *Evaluation of the Central American PRRO*

The evaluation took place between November 2004 and November 2005 including a preparatory mission in November 2004 and a four-week field mission to all four countries included in the PRRO in April 2005. The evaluation assesses progress towards results with the purpose of contributing to the design of the next phase of the PRRO, particularly as with regards nutrition interventions and food-for-work activities.

EB.1/2007 (19–23 February)

The evaluation document submitted under this item is presented to the Board for consideration. The Board is requested to take note of the report and the associated information note summarizing the action taken so far by management in implementing the recommendations.

➤ *Evaluation of the India CP*

The evaluation is planned to take place in the first half of 2006 in order to contribute to the preparation of a possible new country programme. At the time of writing, a concept paper is being developed and a preparatory mission will take place in early November 2005 to identify the key issues of the evaluation in collaboration with the country office and key stakeholders. It is anticipated that the evaluation will focus on the country office's efforts to build partners' capacity in food aid management and advocate for food security. The evaluation mission will take place in April 2006.

➤ *Thematic Evaluation of School Feeding in Emergency Situations*

The Office of Evaluation will undertake a thematic evaluation of its school feeding programme in emergencies, with the aim of assessing its relevance, effectiveness and sustainability in such contexts. The evaluation should be based on a combination of desk research and field-based case studies among WFP's ongoing PRROs and EMOPs.

➤ *Evaluation of the Sierra Leone CP*

This is a mid-term evaluation of Sierra Leone's first CP, which is a continuation of the two ongoing development projects dealing with mother-and-child health and nutrition and primary school feeding. Particular emphasis will be given to the effectiveness of recovery strategies to rehabilitate, create and maintain assets, facilitating the transition towards peace. The evaluation is tentatively scheduled for the second half of 2006.



➤ *Evaluation of Haiti PRRO*

The evaluation of this PRRO is tentatively planned for the first half of 2006. It will examine whether the intervention approach has adequately addressed the immediate food needs of those most affected by crises and helped them to recover their food security.

➤ *Evaluation of the Colombia PRRO*

The evaluation of this PRRO in support of internally displaced persons in Colombia is planned to take place in the first half of 2006 in order to contribute to the preparation of a possible new PRRO. Together with the country office and key stakeholders, a concept paper will be developed and a preparatory mission will take place to identify the key issues. The evaluation mission will take place in April 2006.

EB.A/2007 (4–8 June)

The evaluation document submitted under this item is presented to the Board for consideration. The Board is requested to take note of the report and the associated information note summarizing the action taken so far by management in implementing the recommendations.

➤ *Evaluation of the Palestinian Territory PRRO*

As in the case of the Sierra Leone CP, the Palestinian Territory PRRO will be subjected to a mid-term evaluation tentatively scheduled for the second half of 2006. It shall look at progress towards stated objectives and factors that have positively or negatively affected this progress.

➤ *Evaluation of Ethiopia PRRO 10362.1*

The mid-term evaluation of the Ethiopia PRRO tentatively scheduled for the second half of 2006 shall examine in particular the effectiveness of the intervention approaches and their potential impact on people's livelihood, including graduation from chronic vulnerability.

➤ *Evaluation of the Southern Africa Regional PRRO*

The evaluation of the Southern Africa regional PRRO — "Assistance to Populations in Southern Africa Vulnerable to Food Insecurity and the Impact of Aids" is on OEDE's programme of work for the second time (the first evaluation took place in 2002) in view of the size and scope of this PRRO (US\$404.5 million). It is planned for the second half of 2006. Among other things, the findings will serve as an input to the thematic evaluation of WFP's HIV/AIDS interventions.

➤ *Evaluation of the Indonesia PRRO*

The evaluation of this PRRO is planned to take place in the second half of 2006 in order to contribute to the preparation of a possible new PRRO. Together with the country office and key stakeholders, a concept paper will be developed and a preparatory mission will take place to identify the key issues.

➤ *End-of-term Evaluation of WFP's Enhanced Commitments to Women*

In line with the Gender Policy (2003–2007), an end-of-term evaluation of WFP's enhanced commitments will be conducted in the first half of 2007. This evaluation will assess the extent to which the gender policy has been fully applied and commitments implemented, as well as the difference they have made on institutional mechanisms.

EB.2/2007 (22–26 October)

The evaluation document submitted under this item is presented to the Board for consideration. The Board is requested to take note of the report and the associated information note summarizing the action taken so far by management in implementing the recommendations.

➤ *Evaluation of Emergency Needs Assessment in WFP*

The evaluation of the Strengthening of Emergency Needs Assessment Capacity project (SENAC) will be undertaken at the request of the Emergency Needs Assessment Branch (ODAN) and SENAC's steering committee, including the European Community Humanitarian Office (ECHO) and other donors. The report was originally scheduled to be presented to the Board's Second Regular Session in 2006, but the September 2005 interim review recommended rescheduling the evaluation to the first half of 2007.



➤ *Evaluation of WFP's HIV/AIDS Interventions*

This evaluation, tentatively planned for 2007, intends to take stock of WFP's growing experience with regard to HIV/AIDS in order to identify best practices. The focus will be on strategic and operational approaches with regard to prevention, care and treatment. Targeting issues, particularly for orphans and children will also be assessed.

➤ *Meta-Evaluation of EMOPs*

Following the thematic evaluation of the CP (2002) and PRRO (2004) programme categories, the Office of Evaluation plans to undertake a meta evaluation of the EMOP programme category in the first half of 2007. This evaluation will look at generic issues.

➤ *Evaluation of Southern Sudan PRRO*

At time of writing, the exact vehicle (EMOP/PRRO) for continued assistance to Southern Sudan in the first full year following the 2005 peace agreement is not yet determined. However, WFP activities are certain to include significant efforts to reintegrate long-term refugees and displaced people, as well as to rebuild, enhance and protect their livelihoods. Last evaluated in 2004, OEDE will lead a fresh evaluation of these critical efforts by late 2007.

➤ *Comprehensive Human Resources Review (I)*

At its First Regular Session in 2004 and during discussions on the WFP Policy on Staff Recruitment and Geographical Representation of Member States, the Board was informed about WFP methodology in establishing appropriate representation among international professional staff, and requested (decision 2004/EB.1/3) that its opinions be taken into account in the context of a human resources management review. The Comprehensive Human Resources Review, which also includes recruiting and hiring policies, will be presented to the Board for information.

➤ *Report on Aviation Safety (I)*
