- 1. At the Third Regular Session of 2001, the Board asked to be regularly informed about emergency operations (EMOPs) approved either jointly by the Executive Director and the Director-General of the Food and Agriculture Organization of the United Nations (FAO) or under the delegated authority of the Executive Director.
- 2. The first such report on EMOPs approved in the previous semester was provided to the Board at the Second Regular Session of 2002. Subsequently, this information has been provided twice a year.
- 3. This report covers EMOPs approved between 1 July and 31 December 2005. The next report, covering the first half of 2006, will be submitted to the Second Regular Session in November 2006.
- 4. All the EMOPs approved in the second semester of 2005 are shown in the attached tables. Table A lists EMOPs with a food commitment value of over US\$3 million, approved jointly by the Executive Director and the Director-General of FAO. Table B lists those approved by the Executive Director with a food value below US\$3 million. Table C lists immediate-response EMOPs with a total individual value of less than US\$500,000, approved by country or regional directors under the authority delegated to them by the Executive Director.
- 5. During the period under review, ten EMOPs were approved, of which three were approved jointly by the Executive Director and the Director-General of FAO, two were approved under the delegated authority of the Executive Director and five immediate response EMOPs were approved by country or regional directors under the authority delegated to them by the Executive Director. These ten operations represent a commitment of 172,000 mt of food to assist 2.5 million people at a total food cost of US\$49 million and an overall combined operational and support cost to WFP of US\$99 million.
- 6. The EMOPs jointly approved by the Executive Director and the Director-General of FAO were for Guatemala, Pakistan and Russia to assist a combined total of 1.5 million people. The overall cost to WFP, including transport and support costs, was US\$92.1 million.
- 7. Two EMOPs were approved by the Executive Director under his delegated authority: an EMOP for Cameroon and a regional EMOP for Benin, Ghana and Togo. These operations were to assist a combined total of 304,200 people at an overall cost to WFP of US\$5.0 million.
- 8. WFP country directors used their delegated authority to approve three immediate-response EMOPs in Benin, Cuba and Guatemala and two for Pakistan. The five operations assist 648,100 people at an overall cost to WFP of US\$1.9 million.

# EMOPS APPROVED JOINTLY BY THE EXECUTIVE DIRECTOR AND THE DIRECTOR-GENERAL OF FAO

9. The first EMOP approved during this semester is to assist the victims of the Pakistan earthquake of 8 October that claimed the lives of 82,000 people; this EMOP 10491.0 followed an immediate-response EMOP. Both were approved within days of the disaster. EMOP 10491.0 provides emergency assistance for 1 million beneficiaries at an overall cost to WFP of US\$55.9 million, including transport and support costs.



- 10. Hurricane Stan hit Guatemala in the first week of October, causing flooding and landslides that claimed the lives of over 600 people. EMOP 10497.0 was approved on 21 October to follow an immediate-response EMOP that had been approved earlier in the month. EMOP 10497.0 provides food assistance for 285,000 beneficiaries who lost access to their livelihoods. The overall cost to WFP is US\$ 14.1 million, including transport and support costs.
- 11. The conflict in the Russian Republic of Chechnya continues at a low level. Over the years, it has destroyed much of the economic and social infrastructure and left many people without access to their livelihoods. The expansion of EMOP 10128.2 for a further 12 months provides assistance for 249,000 beneficiaries at an overall cost to WFP of US\$22.2 million, including transport and support costs.

### EMOPS APPROVED UNDER THE DELEGATED AUTHORITY OF THE EXECUTIVE DIRECTOR WITH FOOD COMMODITIES VALUED AT LESS THAN US\$3 MILLION

- 12. As a result of severe drought in the northern provinces of Cameroon, the provinces of Logone and Chari have suffered a prolonged food crisis. A joint mission by FAO, the United Nations Children's Fund (UNICEF) and WFP recommended emergency food assistance. This EMOP provided food for 237,700 beneficiaries for one month.
- 13. After the elections in Togo at the end of April, violence created internal and cross-border population displacements. Refugees sought shelter in neighbouring Benin and Ghana. EMOP 10465.0 provided assistance for 66,500 refugees and internally displaced people in Benin, Ghana and Togo. Preceding this regional EMOP, three immediate-response EMOPs had been approved during the previous semester to assist the displaced populations.

#### IMMEDIATE RESPONSE EMOPS APPROVED BY COUNTRY DIRECTORS

- 14. Hurricane Dennis hit Cuba on 8 July, affecting 12 of the 14 provinces; many people lost their homes and livelihoods. WFP's assistance complemented the Government's assistance and provided a ration for pregnant women, children under 5 and elderly people. EMOP 10473.0 provided assistance for 110,900 beneficiaries.
- 15. Heavy winter snowfalls followed by high summer temperatures resulted in severe flooding in many districts in the Northern Areas and North West Frontier Province of Pakistan. EMOP 10472.0, in coordination with the Government and other agencies, assisted 44,400 beneficiaries who had temporarily lost their source of livelihood.
- 16. A combination of the food crisis in Niger, irregular rainfall and the demand on host families resulted in food shortages in the northern region of Benin during the last quarter of the year. EMOP 10485.0 provided food assistance for 32,800 beneficiaries during this period.
- 17. EMOP 10490.0 was WFP's immediate response to assist the victims of the earthquake that struck Pakistan on 8 October. The EMOP provided high-energy biscuits to the areas worst affected, providing short-term relief for 400,000 beneficiaries. This immediate-response EMOP was followed by EMOP 10491.0.



- 18. Hurricane Stan hit Guatemala and other countries in Central America on 4 October, causing death and destruction; over 600 lives were lost. This immediate-response EMOP 10492.0 provided high-energy biscuits for 60,000 beneficiaries in southern coastal and western highland areas; it was followed by the larger EMOP 10497.0 approved later in October.
