ABSTRACT

1. The Central African Republic has been affected by ten years of internal conflict: riots in 1996, a failed coup d'état in 2001, continuous armed conflicts in 2002 and the coup d'état on 15 March 2003. Public infrastructures and private resources have been destroyed or looted. There has been an improvement in the security situation since the 2003 coup, but recurring insecurity continues, characterized by arms trafficking, acts of violence and hostage-taking by armed bandits. Since 2002, 42,000 Central Africans have found refuge in neighbouring Chad. The Government's minimal resources are such that back-payment of civil servants' salaries presents a serious problem.

- 2. The population is estimated at 3.5 million people, with a growth rate of 2.5 percent per year. The Central African Republic is a least-developed food-deficit country ranked 168th of the 175 countries in UNDP's 2003 Human Development Index; 67 percent of the population live on less that US\$1 per day. Life expectancy has declined from 49 years in 1995 to 39 years in 2004; the HIV/AIDS prevalence rate of 15 percent is the highest in the region. There is a notably high level of malnutrition: chronic malnutrition is 39 percent, food habits do not favour food diversification, and cases of malnutrition among women are common.
- 3. The goals of the current PRRO are (i) to save lives, (ii) to reinforce the food security of vulnerable people living in a post-conflict situation and (iii) to contribute to the country's socio-economic recovery. The **relief component**, which accounts for 71 percent of WFP's food assistance, consists of assisting 89,000 beneficiaries: 32,000 returnees, 23,000 vulnerable people and 34,000 beneficiaries living with or affected by HIV/AIDS. The **recovery component**, which accounts for 20 percent of WFP's food assistance, consists of assisting 115,000 beneficiaries: 90,000 people benefiting from food-for-work activities and 25,000 benefiting from food-for-training activities. Throughout the project, WFP will ensure that recovery operations are in line with the Millennium Development objectives.
- 4. WFP will work with other United Nations institutions. A monitoring and evaluation plan based on the project's logical framework will be established. This PRRO is based on an optimistic scenario of positive developments in the crisis in the Central African Republic. Contingency planning has been done for less optimistic scenarios. During implementation of the PRRO and in accordance with positive developments in the country, WFP will gradually reduce its relief activities and direct them towards recovery to encourage the strengthening of coping mechanisms and the recovery of local economies.
