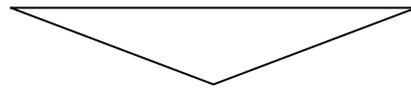

POLICY ISSUES

EB.1/2005 (31 January–2 February)

➤ *Definition of Emergencies (A)*

This document, submitted **for approval**, reviews WFP's existing definition of emergencies in the light of the definitions in use by other United Nations agencies and partners and current emergency trends. This paper is prepared in response to the Board's request, in its discussion of the first "Consolidated Framework of WFP Policies" at its 2002 Annual Session that the Secretariat present proposals for policy topics to be discussed at future sessions, with particular focus on topics related to emergencies.

➤ *Exiting Emergencies (A)*

This document reviews lessons learned from WFP experiences in exiting from emergency responses. It stresses the importance of exit strategies and sets out recommendations to guide future organizational practice in exiting. The paper is prepared in response to the Board's request, in its discussion of the first "Consolidated Framework of WFP Policies" at its 2002 Annual Session that the Secretariat present proposals for policy topics to be discussed during the next biennium, with particular focus on policy gaps related to emergencies. "Exiting emergencies" was presented as a policy topic at the Third Regular Session in 2003. This paper is presented **for approval**.

➤ *Annual Report to the United Nations Economic and Social Council (ECOSOC) and the FAO Council (A)*

With regard to streamlining corporate reporting to the Executive Board and WFP parent bodies (WFP/EB.A/2004/5-F), the Board decided at its Annual Session in 2004 that the Annual Report to ECOSOC and the FAO Council would be presented at its First Regular Session every year, starting in 2005. The report combines three previous reports — Section II of the former "Annual Report of the Executive Director", the "Report on Follow-Up to General Assembly and ECOSOC Resolutions" and the "Progress Report on General Assembly Resolution A/RES/56/201, Triennial Comprehensive Policy Review" — into a single report that provides a comprehensive picture of WFP's engagement in United Nations system-wide activities and responses to relevant United Nations General Assembly and ECOSOC resolutions. This report is presented **for approval**.

EB.A/2005 (6–10 June)

➤ *Annual Performance Report for 2004 (A)*

General Rule VII.2 states: "Each year the Executive Director shall submit to the Board **for its approval** an Annual Report and other reports as directed by the Board". Further, Governance recommendation (h), approved by the Board at its Third Regular Session in 2000 (decision 2000/EB.3/1—Follow-up to Executive Board Decision 2000/EB.A/6 on Governance), states: "An Annual Performance Report should be developed" based on the Biennial Management Plan previously approved.

The Annual Performance Report for 2004 aims at presenting a relevant and credible analysis of WFP's performance vis-à-vis the commitments made for the year as defined in the Strategic and Management Plans for the period 2004–2007.

➤ *Strategic Plan (2006–2009) (A)*

At its Third Regular Session in 2000 the Executive Board approved the recommendations contained in the Report on the Working Group on Governance (decision 2000/EB.A/6). Governance recommendation (b) establishes that the current Strategic and Financial Plan should be adapted into a Strategic Plan, notably by the incorporation of results-based objectives. The Strategic Plan was first presented at the Third Regular Session of 2003. This document is submitted to the Board **for approval**.



➤ *Information Note on the Progress of Implementation of the WFP Gender Policy (2003–2007) (I)*

WFP's mission is to provide access to food for hungry people in situations of acute and chronic food insecurity, thus contributing to the Millennium Development Goal of halving the number of hungry people by 2015. In this context, WFP has developed a Gender Policy for 2003–2007, which was approved by the Board in 2002. The mid-term review will report on the status of implementation of the major initiatives that operationalize and mainstream the Gender Policy. These programme support initiatives include baseline surveys, guidelines, training in implementation of the Enhanced Commitments to Women and field research. The document is presented to the Board **for information**

➤ *Answering the Call to Action: An Update on WFP's Response to HIV/AIDS (I)*

A Progress Report on the Implementation of the WFP Policy on HIV/AIDS will be presented **for information** in response to the decision of the Board at its First Regular Session, 2003 (WFP/EB.1/2003/10) to request a progress report on the implementation of the policy to be submitted to the Board in 2005.

➤ *Report on the Management of Evaluation (C)*

The report on the management of evaluation is submitted **for consideration**. It has been prepared by the Secretariat following discussions with the Steering Group on Governance, in line with the decision taken by the Board at EB.3/2003. The paper has been conceived in the context of further strengthening the evaluation function in WFP.

EB.2/2005 (7–11 November)

➤ *Update of Consolidated Framework of WFP policies (I)*

At its Annual Session in 2000, the Executive Board approved the recommendations contained in the Report of the Working Group on Governance (decision 2000/EB.A/6). Governance Recommendation (d) established that the WFP policy statement should be codified in a compendium. The "Consolidated Framework of WFP Policies" was first submitted to the Board at its Annual Session in 2002. A hard copy of the update of the Consolidated Framework is submitted to the Board **for information**.

➤ *Humanitarian Access (C)*

This paper informs the Board of processes that clarify the Programme's approach, in collaboration with its United Nations partners, to securing safe and unhindered access to people affected by emergencies, and seek guidance where needed. The paper is prepared in response to the Board's request, in its discussion of the first "Consolidated Framework of WFP Policies" at its 2002 Annual Session that the Secretariat present proposals for policy topics to be discussed at future sessions, with particular focus on topics related to emergencies. This paper will be **for approval or consideration**, depending on whether or not the conclusions of the paper require Board approval of any specific policy changes in the "Consolidated Framework of WFP Policies".

➤ *Targeting Food Aid in Emergencies and Protracted Crises (A)*

This paper reviews and assesses WFP's targeting policies and practices, updates the Board on the latest trends in this area, and identifies issues or areas upon which the Board might wish to focus particular attention. This paper would be **for approval or consideration**, depending on whether or not the conclusions of the paper require Executive Board approval of any specific policy changes in the "Consolidated Framework of WFP Policies".

➤ *Food Aid Sources (C)*

This paper, **for consideration**, reviews trends in the availability and sources of food aid, and the implications of those trends for the Programme.

➤ *Follow-Up Report on Right to Food Guidelines (C)*

Following approval of the internationally negotiated Voluntary Guidelines on the Right to Food, in Sept 2004, by the Committee on World Food Security and the FAO Council, and pursuant to discussions held at the Third Regular Session of the Board, in October 2004, the Board will have before it, **for consideration**, an information note outlining the relevance of these guidelines to the work of WFP.

➤ *Local Purchases and Procurement (C)*

This paper, **for consideration**, clarifies WFP's purchase and procurement of services and commodities and these efforts' potential for making a positive contribution in developing countries.



➤ *Status Report on Results-Based Management (I)*

At its Annual Session and Third Regular Session in 2003, the Secretariat presented information notes on the status of RBM implementation in WFP and anticipated the next steps. The Executive Board requested that another status report be provided at some time in the 2004–2005 biennium, and asked the Secretariat to propose the timing for such a report. The Secretariat proposed the Third Regular Session of 2005, so that sufficient time could be given for training, for developing performance information systems, and for completing baseline studies, as well as for completing two Annual Performance Reports (for 2003 and 2004) upon which to assess progress. The document is submitted **for information**.

➤ *Update on the Implementation and Achievements of the MOU between WFP and NEPAD (I)*

The paper is prepared in response to the Board's request made during its discussions at its 2004 First Regular Session (23–26 February 2004) of item 4 f) Information Note on WFP's support for the New Partnership for Africa's Development (NEPAD), including the Memorandum of Understanding established on 19 November between NEPAD and WFP, that the secretariat submit, at least on a biennial basis, a progress report on implementation of the MoU, with particular focus on priorities selected for early action. The document is submitted **for information**.

➤ *Annual Update on School Feeding (I)*

At its Third Regular Session in 2004, the Board requested to be kept informed each year at its Second Regular session on the status of WFP school feeding activities. This annual update is submitted to the Board **for information**.

➤ *Progress Report on Emergency Needs Assessment Implementation Plan (I)*

At its Third Regular Session in 2004, the Executive Board took note of the proposed 30-month implementation plan for strengthening WFP's emergency needs assessments. This document provides an overview of progress and achievements to date and provides an outlook on the steps planned for the remaining period of this initiative. This document is submitted to the Board **for information**.

➤ *Food for Training (C)*

This paper, **for consideration**, examines lessons learned from experience, including implementation of the commitment to ensure that women and adolescent girls constitute at least 70 percent of the participants in food-assisted training activities, articulated in the Gender Policy approved by the Board at its Third Regular Session of 2002.

➤ *Response to the Evaluation of WFP's Enabling Development Policy (C)*

In May 2005, the Executive Director officially received an independent evaluation of WFP's Enabling Development policy, which concludes that the policy is a sound one whose principles are worth further support and implementation. It also contains observations and recommendations on how to improve the quality and relevance of WFP's assistance. The Response to the Evaluation of WFP's Enabling Development policy, which is submitted to the Board for consideration, reflects the follow-up management intends to give to the recommendations.

➤ *Report on the Governance Project (C)*

At its last meeting in April 2005, the Steering Group on Governance decided to produce, jointly with the Executive Director, a final report that would review the work done in the field of governance since 2000. Such document will be presented to the Board for consideration.

➤ *Annual Report to ECOSOC and the FAO Council (A)*

With regard to streamlining corporate reporting to the Board and WFP parent bodies (WFP/EB.A/2004/5-F), the Board decided at EB.A/2004 that the Annual Report to ECOSOC and the FAO Council would be presented at the First Regular Session every year, starting in 2005. The report combines three previous reports—Section II of the former Annual Report of the Executive Director, the Report on Follow-Up to General Assembly and ECOSOC Resolutions and the Progress Report on General Assembly Resolution A/RES/56/201, Triennial Comprehensive Policy Review—into a single report that provides a comprehensive picture of WFP's engagement in United Nations system-wide activities and responses to relevant United Nations General Assembly and ECOSOC resolutions. This report is presented to the Board **for approval**.



➤ *Local Purchases and Procurement (A)*

This paper, **for approval**, clarifies WFP's purchase and procurement of services and commodities and these efforts' potential for making a positive contribution in developing countries.

➤ *Aligning WFP Activities with National Poverty Reduction Strategies and Sector Programmes (C)*

This document describes measures undertaken by WFP to ensure its activities are determined by and supportive of national poverty reduction strategies and sector programmes. This paper will be **for consideration**.

EB.A/2006 (12–16 June)

➤ *Annual Performance Report for 2005 (A)*

General Rule VII.2 states: "Each year the Executive Director shall submit to the Board **for its approval** an Annual Report and other reports as directed by the Board". Governance recommendation (h), approved by the Board at its Third Regular Session in 2000 (decision 2000/EB.3/1—Follow-up to Executive Board decision 2000/EB.A/6 on Governance), states: "An Annual Performance Report should be developed" based on the Biennial Management Plan previously approved.

The evaluation is taking place in 2004 and assesses the extent to which the four principles essential for the success of MCN programmes have been applied and their effectiveness in reaching programme objectives.

➤ *Thematic Evaluation of Key Targeting Challenges and Opportunities for Reaching the Needy in Relief Situations (C)*

In cooperation with the Strategy, Policy and Programme Support Division (PSP), OEDE will undertake in 2004-2005 a thematic evaluation on challenges and constraints facing WFP in the effort to ensure efficient and effective targeting. The evaluation results should support new corporate policy formulation, especially in relation to relief targeting. It will focus on selected relief situations that are on-going or that have recently been completed.

➤ *United Nations Joint Logistics Centre (UNJLC) Evaluation Synthesis Report (C)*

The evaluation synthesis summarizes major findings and conclusions of the reviews of the UNJLC field operations in Afghanistan, Iraq and Liberia. It contains a list of emerging issues arising from these reviews requiring further inter-agency discussion with a view to defining options for the future direction of the UNJLC.

➤ *Angola Portfolio of Activities (C)*

The evaluation of Angola’s portfolio of activities composed of the PRRO and related special operations (SOs) will be a follow-up to the evaluation undertaken in late 2001 and should yield interesting results in view of the political changes that have taken place in the country since then.

➤ *Joint UNHCR-WFP Evaluation of the Pilot Food Distribution Projects (C)*

The main objective of the evaluation jointly undertaken by the Office of the United Nations High Commissioner for Refugees (UNHCR) and WFP, is to assess the effectiveness of the new arrangement under which WFP assumes responsibility of food distributions in refugee operations, piloted in five countries. Evaluation findings should facilitate future decisions by UNHCR and WFP on whether food distributions should be handed over to WFP.

➤ *People’s Republic of China Phase-out Impact Evaluation (C)*

The evaluation is planned for October/November 2004 and will have a dual purpose: (i) a review of WFP’s assistance to China since the start of operations in 1979 and (ii) an evaluation of the current country programme and the phase-out process. Particular attention will be paid to the WFP/IFAD/Ministry of Agriculture partnership in China.

➤ *Real-time Evaluation of the Tsunami operation (C)*

OEDE is undertaking a real-time evaluation of WFP’s response to the Indian Ocean tsunami emergency, covering the period December 2004 to June 2005. The evaluation considers such issues as preparedness, needs assessment, targeting, coordination, effectiveness and the appropriateness of the response

As a direct follow-up to Board’s recommendations, the Report on Post-Delivery Losses outlines the measures that the Secretariat put in place.

- *Information Note on the WFP Commodity Tracking System (I)*

As a result of the Board’s request at its last session, an information note on commodity tracking will be presented. The note will highlight progress made in (i) commodity tracking, in particular recording and reporting losses, (ii) how the corporate commodity tracking system is contributing to programme management and (iii) challenges in the area of commodity tracking.

At its Third Regular Session in 2004, the Board approved an increased delegation of authority to the Executive Director to 20 million dollars (food value) for PRROs and budget revisions to PRROs; the re-establishment of a mechanism for Board approval by correspondence; the elimination of the 10 percent food value ceiling for budget revision approval and the delegation to the ED to approval all Special Operations. At the same time, the Board requested that such delegation of authority be reviewed after two years of implementation at the Third Regular Session of the Board in 2006 to determine whether this procedure would be continued. This document, which contains an analysis of the situation over the past two years and a recommendation to the Board, is submitted **for approval**.
