At the Third Regular Session of the Executive Board in 2001, the Board members requested to be regularly informed about emergency operations (EMOPs) approved either under the delegated authority of the Executive Director, or jointly by the Executive Director and the Director-General of the Food and Agriculture Organization of the United Nations (FAO).

- 2. The first such report was provided to the Board at the Second Regular Session of 2002, reflecting the period of the previous year. The information then started to be provided twice a year, with the report covering the first half of 2002 provided at the Third Regular Session of 2002. At this current session of the Board, the report is being provided for the period 1 July–31 December 2002. The next report, covering the first half of 2003, will be shared at the Third Regular Session of the Board in 2003, in October.
- 3. To inform the Executive Board members adequately without duplicating information already provided through other sources, this report includes the list of all approved emergency operations with the main project statistics and a brief overview of figures and key trends.
- 4. A total of 17 EMOPs were approved from 1 July through 31 December 2002, to assist more than 9.2 million vulnerable people in urgent need of food aid, in 22 countries. Among these operations, five EMOPs were approved jointly by the Executive Director and the Director-General of FAO and 12 operations were approved under the delegated authority of the Executive Director, including ten immediate-response EMOPs approved locally, by Country Directors, under the authority delegated to them by the Executive Director. These 17 operations represent a commitment of almost 700,000 metric tons (mt) of food, with a food cost of US\$178 million and an expected overall operational and support cost to WFP of almost US\$286 million.
- 5. Appropriate information for all emergency operations approved in the second half of 2002 has been listed in the attached tables, organized by the EMOPs' approval level.
- 6. The Executive Director and the Director-General of FAO jointly approved five emergency operations with an individual value of committed food in excess of US\$3 million, in: the Democratic People's Republic of Korea (DPRK), Madagascar, Western Sahel (Mauritania, Cape Verde, Senegal, Gambia and Mali), Pakistan and the Russian Federation. Almost 8 million vulnerable people are expected to receive WFP relief assistance through these EMOPs, which have a cumulative food commitment of over 684,400 mt, valued at US\$172.8 million. The overall cost of these operations to WFP, including transport and support costs, is expected to be over US\$276.7 million, representing 92 percent of the value of all EMOPs approved.
- 7. Two emergency operations with an individual food value under US\$3 million were approved under the delegated authority of the Executive Director to meet the needs of two regional crises: "Civil Strife in Côte d'Ivoire and Regional Implications" (Côte d'Ivoire, Ghana, Mali, Burkina Faso) and "Emergency Pre-positioning of Food Commodities for the Iraq Crisis" (Iraq, Iran, Jordan, Syria and Turkey). These two regional EMOPs will help almost 1 million vulnerable people in immediate need of food aid. The food value of these operations is US\$4 million, representing a commitment of nearly 9,900 mt of food. The overall cost to WFP of these EMOPs is expected to reach US\$7.2 million.
- 8. WFP Country Directors used the authority delegated to them by the Executive Director to approve ten immediate-response EMOPs, each with an overall cost of up to

US\$200,000, in: Albania, Burkina Faso, Côte d'Ivoire, Cuba, Ecuador, Ghana, Haiti, Mali, Niger and Iran. 257,700 vulnerable people were assisted through the WFP immediate-response EMOPs. The food value of these projects was just over US\$1.2 million, representing a commitment of over 4,250 mt of food. The overall cost to WFP of these operations was over US\$1.7 million. The beneficiaries in Burkina Faso, Ghana, Côte d'Ivoire and Mali have also received subsequent WFP assistance through the above-mentioned regional EMOP 10244.0, approved under the delegated authority of the Executive Director.

- 9. Of the 17 emergency operations approved (in 22 countries), eight operations were in Africa (in ten countries), three in Latin America (in three countries), three in the Mediterranean, Middle East and Central Asia region (in six countries), two in Eastern Europe (in two countries) and one in Asia (in one country). Africa remains the continent with the highest number of emergency operations.
- 10. While WFP's focus during the first half of 2002 was on the six countries of the Southern Africa region, 70 percent of all the emergency resources approved during the second half of 2002 related to a single emergency operation in the DPRK. The other main emergency operations of WFP approved between July and December 2002 included: Western Sahel (representing 10 percent of the overall emergency requirements), Pakistan (8 percent), Russian Federation (5 percent) and Madagascar (3 percent).
- 11. Around 80 percent of the overall emergency food needs have resulted from natural disasters, mostly drought and crop failures, including those in DPRK and Western Sahel. WFP was also called upon to assist people affected by earthquakes in Iran, floods in Albania, hurricanes in Cuba and volcano eruptions in Ecuador. WFP's emergency resources required in response to conflict situations represented 18 percent of emergency needs, mainly in Pakistan (Afghan refugees), Northern Caucasus (internally displaced and conflict-affected from Chechnya) and Côte d'Ivoire. In some countries, the food crisis was the result of a combination of factors. In Madagascar, WFP has been assisting populations affected by a combination of natural disasters and political and economic disturbances. In DPRK, the food crisis caused by the drought was exacerbated by the country's economic downturn.
- 12. While, WFP's early projections for the whole of 2002 indicated that an estimated 1.9 million mt would be required for approved emergency operations, the Programme actually appealed for over 2.8 million mt from January to December 2002. However, it was already anticipated in early 2002 that the requirements would increase during the year due in part to expected large-scale needs in DPRK and a looming crisis in the Sahel region. In addition, unforeseen emergencies such as the violent upsurge of civil unrest in Côte d'Ivoire have resulted in higher requirements.
- 13. The emergency food aid requirements in 2002 have also exceeded WFP's emergency requirements approved during the year 2001. In terms of the overall costs, WFP has been appealing for US\$1.4 billion in 2002, compared with US\$1.1 billion in 2001, representing a 27-percent increase. This noticeable increase in the emergency food aid appeals reflects WFP's commitment to maintaining strong response capacity to the increasing number and range of emergencies and people affected.
