#### Adoption of the Agenda

The Executive Board adopted the agenda as proposed (Annex I).

# Election of the Bureau of the Executive Board and Appointment of the Rapporteur

In accordance with the Rules of Procedure adopted by the Board in 1999, the Executive Board elected H.E. M. Saeed Nouri-Naeeni (Islamic Republic of Iran, List B) as President for a one-year term.

The Board elected Ms U.M. Finskas-Aho (Finland, list D) as Vice-President. The representatives of Burundi, Mr Gaspard Kabura (List A); Haiti, Ms Suze Percy (List C); and Hungary, Ms M. Kóvacs (List E) were elected members of the Bureau, as representatives of the other three WFP electoral lists.

In keeping with the established methods of work, the Board appointed Mr. Ioan Pavel (Romania) Rapporteur of the First Regular Session of 2000.

#### FINANCIAL AND BUDGETARY MATTERS

#### 2000/EB.1/1 Report on WFP Chartered Flight KSV 3275 to Kosovo

In considering the Report on WFP Chartered Flight KSV 3275 to Kosovo (WFP/EB.1/2000/3/1), the Executive Board extended its deep sympathy to the families of the victims of the accident, and expressed great appreciation to the staff and the Executive Director of WFP for their very efficient and compassionate handling of this tragic situation. The Executive Board also thanked the Italian Government for its exceptional support.

The Board looked forward to the publication of the final report on the circumstances of the accident, to addressing the conclusions that come forward from that report and to regular updates by the Secretariat on the status of charges made to the Special Account and insurance-related issues. It endorsed the recommendation of the Advisory Committee on Administrative and Budgetary Questions (ACABQ) made in its report (WFP/EB.1/2000/3/2) to take steps towards developing a United Nations-wide standard operating procedure to address such type of crisis in the future.

The Executive Board



- a) took note of the actions taken by the Secretariat in the handling and management of the crisis; and
- b) authorized on a *post facto* basis that the un-earmarked balance of the General Fund of the Programme be used to fund the KSV 3275 Disaster Special Account.

#### **POLICY ISSUES**

## 2000/EB.1/2 Disaster Mitigation: A Strategic Approach

The Board endorsed the general approach of the document (WFP/EB.1/2000/4-A) which nevertheless remains open. It recommended that the Secretariat proceed to implement the strategy in a selected group of countries, taking into account a balanced geographic distribution, in order to learn from experiences and provide feedback on best practices, given specific country contexts. The Secretariat will inform the Board of its findings and lessons learned from these pilot experiences. The Board will decide how these should be integrated into the future policy approach.
