## Budget increases to protracted relief and recovery operations approved by the Executive Director (1 January–30 June 2017)

- 1. This paper outlines protracted relief and recovery operations (PRROs) and budget increases approved by the Executive Director under his delegated authority between 1 January and 30 June 2017.
- 2. In accordance with Board decisions, the Executive Director's delegated authority with regard to the PRRO programme category includes:
  - ▶ approval of PRROs and budget increases for PRROs whose food value does not exceed USD 20 million – note that the total of increases for a given country in a calendar year may not exceed USD 40 million; any further increase in a calendar year requires approval by the Board; and
  - ➤ approval of budget revisions to PRROs incorporating cash-based transfers with an overall increase in food value not exceeding USD 20 million.

#### **Budget Increases**

- 3. Between 1 January and 30 June 2017, the Executive Director approved 21 budget increases within his delegated authority for PRROs previously approved by the Board. The total food value of these increases was USD 114 million; the total cost to WFP was USD 342 million. Detailed budget figures and reasons for each increase are given in the attached table.
- 4. Comparing the 2017 increases with those approved during the same period in 2016, the Executive Director approved three more budget increases between January and June 2017. This amounted to a decrease of USD 13 million in food value and an increase of USD 123 million in terms of the total cost to WFP.
- 5. Most of the budget revisions resulted from extensions in time, the inclusion of additional beneficiaries, increases in food requirements and in capacity development and augmentation (CD&A) activities, increase in the landside transport, storage and handling (LTSH) costs and the introduction or increase of cash-based transfers (CBT) modality.
