Management response to the recommendations in the summary report on the evaluation of the country strategic plan for China (2017–2021)

Background

- 1. This document presents the management response to the recommendations in the summary report on the evaluation of the country strategic plan (CSP) for China (2017–2021).
- 2. The evaluation was conducted between August 2020 and December 2020 and covered the WFP China office strategy, activities, systems and partnerships for 2017–2020.
- 3. Taking a utilization-focused and consultative approach, the evaluation served the dual purpose of accountability and learning and is expected to inform the preparation of the next CSP for China.
- 4. The evaluation made two strategic recommendations and two operational recommendations. Sub-recommendations describe how each recommendation can be implemented.
- 5. The matrix below sets out whether WFP agrees, partially agrees or disagrees with the evaluation recommendations and sub-recommendations. It presents the actions taken or to be taken and the related responsibilities and timelines for implementation of the recommendations.
