Resilience building has the potential to limit the toll of humanitarian crises and avert humanitarian food assistance needs by helping people, communities and systems better absorb, adapt and transform in the face of shocks. Generating evidence around resilience supports strategic decision-making, promoting effective resilience-building interventions for WFP partners.
