## **Norms and standards for PSEA**

#### **Overall, WFP is aligned with UN and IASC commitments on PSEA**:

- **Explicit PSEA commitments in** WFP Strategic Plan (2022-2025)
- Increasing **inclusion of PSEA** in CSPs and WFP policies
- Significant refresh of PSEA commitments with 2023 ED Circular on PSEA

#### But there is a need for:

- Greater clarity on zero tolerance to inaction and the victim centred approach
- **Clear strategy** for implementing PSEA commitments



# Systems, structures and programming for delivering on PSEA commitments



#### **Progress on PSEA:**

- **Spearheading from Ethics Office** with global PSEA focal points
- **High levels of compliance** with PSEA requirements
- **Development of guidance** for PSEA
- Introduction of PSEA indicators in corporate results framework



#### **Operationalization of PSEA limited by:**

- Human and financial **resources**
- Limited reporting and data for decision making
- **Staff confidence** in reporting, investigations and feedback mechanisms

## **Partnerships for PSEA**



#### Strengths:

- Increasing contributions to UN and inter-agency PSEA platforms
- Inter-agency work to enhance cooperating partners' PSEA capacity
- **Compliance with contractual requirements** in partnerships

#### **Opportunities and challenges:**



- Taking on **leadership** within cluster and inter-agency engagement
- Lack of guidance for PSEA within government partnerships
- **Underestimation of SEA risk exposure** across partnership types (e.g. private sector, financial service providers)

## **PSEA** in a changing operational environment



#### **Progress toward IASC vision:**

- Executive Director role as IASC PSEAH Champion
- Commitment to Victim Centred Approach
- Promoting culture change
- Mandatory PSEA training for all staff



#### Areas for further attention:

- Resourcing and support to victims
- Mechanisms, capacity, and resources for PSEA in priority contexts
- Considering SEA risk amidst resource uncertainty
- Inclusion of PSEA in donor dialogue
