- 1. The corporate results framework for 2026–2029, due to be presented to the WFP Executive Board in November 2025 for approval, includes a commitment to setting annual targets for corporate output indicators, where the attribution of WFP's impact is more direct. In most cases, these targets will be aligned with expected funding levels and will reflect WFP's highly operational and resource-dependent context.
- 2. Once the corporate results framework has been approved, the corresponding targets and baseline values will be published in the annex of the management plan. Actual values achieved against these indicators will be reported annually in the annual performance report.
- 3. The list and content of standard outputs and output indicators presented below remain subject to change, in line with the ongoing informal consultations and review process leading up to the final submission of the corporate results framework to the Board in November 2025. Baseline values established for 2024 will be updated to reflect 2025 data during the first quarter of 2026. As a result, targets for 2026 may also be reviewed and adjusted based on this updated baseline information. This approach ensures that planning figures remain aligned with the most recent performance data and contextual realities.
