- 1. This paper outlines protracted relief and recovery operations (PRROs) and budget increases approved by the Executive Director under her delegated authority between 1 January and 30 June 2015.
- 2. In accordance with Board decisions, the Executive Director's delegated authority with regard to the PRRO programme category includes:
  - approval of PRROs and budget increases for PRROs whose food value does not exceed USD 20 million – note that the total of increases for a given country in a calendar year may not exceed USD 40 million; any further increase in a calendar year requires approval by the Board; and
  - approval of budget revisions to PRROs incorporating cash-based transfers with an overall increase in food value not exceeding USD 20 million.

#### **Budget Increases**

- 3. Between 1 January and 30 June 2015, the Executive Director approved 28 budget increases within her delegated authority for PRROs previously approved by the Board. The total food value of these increases was USD 127 million; the total cost to WFP was USD 264 million. Detailed budget figures and reasons for each increase are given in the attached matrix.
- 4. Comparing the 2015 increases with those approved during the same period in 2014, the Executive Director approved six more budget increases between January and June 2015, amounting to an increase of USD 117 million in food value and USD 91 million in terms of the total cost to WFP.
- 5. Most of the budget revisions resulted from extensions in time of the operations, the inclusion of additional beneficiaries, increase in food requirements and/or the expansion of cash-based transfers.

### **New Operations**

6. Between 1 January and 30 June 2015, the Executive Director approved two new PRROs under her delegated authority: these were for Djibouti and Rwanda. The total food value of these new operations is USD 25.6 million; the total cost to WFP was USD 74.5 million. Summaries of these operations are contained in separate documents.
