#### INTRODUCTION

- 1. This is the third annual report on the implementation status of actions taken by Headquarters divisions, regional bureaux and country offices in response to evaluation recommendations. It covers recommendations arising from evaluations presented to the Board in 2008, 2009, 2010 and 2011. In response to observations by the Board and recommendation 4 of the Office of Evaluation (OE) 2011 Annual Evaluation Report, which urged organizational learning, this report analyses the implementation status in greater depth than did previous reports: it introduces geographical analysis, presents trends, establishes an annual implementation target to enable reporting against a benchmark, and provides a breakdown for the WFP six regions and relevant entities along with Headquarters.
- 2. The objective of the enhanced analysis is to identify challenges and best practices for WFP's implementation of the recommendations. It also improves accountability and transparency, enables targeted follow-up and identifies emerging patterns.
- 3. The report has four sections: i) a brief description of the method; ii) an overview of relevant evaluation reports, recommendations and management actions; iii) analysis of implementation status, by evaluation type and region; and iv) a summary and conclusions.

### Method

- 4. The Performance and Accountability Management Division (RMP) tracks the management actions and the responses made to determine the implementation status and follow-up as required. The implementation status categories are the same used in the 2010 report:
  - > **Implemented**: Action completed by 31 December 2011.
  - > Outstanding: Action not completed by 31 December 2011.
  - Not applicable: Actions not implemented because of changing circumstances or contexts.

#### **EVALUATIONS PRESENTED TO THE BOARD**

- 5. Since 2008, 45 evaluation reports with management responses have been presented to the Board.<sup>1</sup> The evaluation categories established by OE, and the type of action each category includes are:
  - > Operation evaluations, with recommendations proposing specific actions;
  - > Country portfolio evaluations, with related principles guiding WFP country offices;
  - Strategic evaluations, with suggested approaches or course of actions; and
  - > Impact evaluations, with recommendations that influence current and future actions.

6. During the last four years, 44 percent of evaluations that included management responses were operation evaluations. Strategic evaluations accounted for 27 percent, country portfolio evaluations for 20 percent and impact evaluations for 9 percent. As explained in the Annual Evaluation Report 2011, the number of operation evaluations has declined, while the number of impact and strategic evaluations has increased (Table 1).

# QUANTITY AND GEOGRAPHICAL DISTRIBUTION OF RECOMMENDATIONS

- 7. Since 2008, OE has issued 414 recommendations in 45 evaluation reports. The number of recommendations made each year increased from 57 in 2008 to 154 in 2010 and dropped to 112 in 2011. The average number of recommendations per evaluation decreased from 14 in 2008 to 9 in 2011.
- 8. In response to all recommendations issued from 2008 to 2011, management agreed to implement 620 actions; 193 of these were from 2011. In 2008 just 69 were added, while in 2010 there were 211 actions added. Most actions 69 percent are for field offices, while 31 percent are for Headquarters. In 2011 management agreed to implement an average of 15 actions per evaluation.

The geographical breakdown of actions shows that there is an increasingly greater share 9. for the East and Central Africa region; it also has the highest number among the regions. Headquarters has the highest number of actions overall.

## **IMPLEMENTATION STATUS OF ACTIONS FROM 2008 TO 2011**

- The following analyses cover 40 evaluation reports with 543 actions; 77 actions were 10. either implemented or no longer applicable at 31 December 2010 and were excluded. Of the 543 actions:
  - 339 were implemented by 31 December 2011 (63 percent);  $\triangleright$
  - $\triangleright$ 165 are outstanding (30 percent);
  - $\succ$ 39 were deemed not applicable (7 percent).
- 11. Of the 543 actions, 426 were due by 31 December 2011; this was the implementation target for 2011. WFP implemented 339 actions, an 80 percent implementation rate for 2011 and a 3 percent improvement over 2010.

## IMPLEMENTATION RATES BY TYPE AND REGION

12. Implementation rates varied significantly by type of evaluation (Table 4): while 91 percent of all actions from country portfolio evaluations had been implemented by the end of 2011, for strategic evaluations it was only 66 percent. This reflects both the higher number of actions stemming from strategic evaluations and the complexities of addressing them: they often require more coordination, involve policy issues and collaboration across WFP units and beyond. Timelines set for implementing strategic evaluation actions are often too optimistic; careful consideration is required to ensure that targets and deadlines can be met.

13. In the Asia region, 86 percent of 93 actions were implemented, while in the East and Central Africa region 76 percent of 71 actions due at 31 December 2011 had been implemented (Table 5). The implementation rate for Headquarters is lower than the average implementation rate for country offices and regional bureaux; Annex II shows implementation rates by entity.

#### **SUMMARY AND CONCLUSIONS**

- 14. From 2008 to 2011, 80 percent of actions from 40 evaluation reports have been fully implemented; 87 actions remain pending. While an 80 percent implementation rate is higher than other comparable organizations,<sup>2</sup> WFP is committed to increasing the implementation rate for 2012. Each action has a timeline; managers are held accountable for action, and for sharing reports with the Board. RMP will also work with OE to create cross-functional processes and teams to address evaluation findings and responding to both internal and external opportunities. A lower average number of recommendations per evaluation paired with a focus on issuing practical recommendations will help to ensure that actions are implemented in a timely manner and that they achieve the intended changes.
- 15. This report provides more quantitative analysis and insights than previous reports; it signals trends and contributes to accountability and transparency. However, management recognizes that it is only the first step toward enhancing organizational effectiveness and efficiency. The 2011 Annual Evaluation Report mentions a number of initiatives taken by WFP to enhance learning through evaluation. Closing the learning loop will require further steps to exploit the full value of evaluations. RMP will work with OE and with the Policy, Planning and Strategy Division to incorporate conclusions from evaluations into planning and review processes, enable informed management decisions and assess how implemented actions have changed the way WFP works.
