

The Board takes note of "Emergency Operations Approved by the Executive Director or by the Executive Director and the Director-General of FAO (1 July–31 December 2010)" (WFP/EB.1/2011/10).

1. At its Third Regular Session of 2001, the Board asked to be regularly informed about emergency operations (EMOPs) approved jointly by the Executive Director (ED) and the Director-General (DG) of the Food and Agriculture Organization of the United Nations (FAO) or under the delegated authority of the Executive Director. Since the Second Regular Session of 2002 this information has been provided twice a year.

- 2. This report covers EMOPs approved between 1 July and 31 December 2010, as shown in the attached tables. Table A lists projects with a food value of more than US\$3.0 million approved jointly by the Executive Director and the Director-General of FAO. Table B lists projects with a food value of less than US\$3.0 million approved by the Deputy Executive Director (DED) and Chief Operating Officer (COO) under the delegated authority of the Executive Director. Table C lists EMOPs with an individual value of US\$500,000 or less approved by Regional Directors or country directors under the authority delegated to them by the Executive Director.
- 3. During the period under review, 24 EMOPs were approved: 7 by the Executive Director and the Director-General of FAO, 6 under the delegated authority of the Deputy Executive Director and Chief Operating Officer, and 11 by Regional Directors or country directors (CDs). These operations provide food assistance to 24.5 million people at a food cost of US\$813.0 million. The total costs to WFP were US\$1.7 billion.

EMOPS APPROVED JOINTLY BY THE EXECUTIVE DIRECTOR AND THE DIRECTOR-GENERAL OF FAO

- 4. Kyrgyzstan EMOP 200161 (July 2010–June 2011) is a response to the food needs of the conflict-affected populations in Osh and Jalal-Abad. The EMOP assists 560,000 beneficiaries through general and targeted food distributions at a cost of US\$23.1 million.
- 5. Niger EMOP 200170 (August 2010–July 2011) is a response to severe drought affecting half of the population. The operation focuses on: i) nutritional activities for children under 5 and pregnant and lactating women; and ii) food assistance for severely food-insecure populations. The project targets 7.9 million beneficiaries at a cost of US\$279.4 million.
- 6. Pakistan EMOP 200177 (August 2010–July 2011) responds to the floods in the Indus valley that started in July 2010. The operation targets 7.3 million vulnerable people affected by the flooding with emergency food assistance at a cost of US\$596.8 million. A smaller EMOP targeting 479,500 people and costing US\$3.7 million that was approved as soon as the floods began under the delegated authority of the Deputy Executive Director and Chief Operating Officer was incorporated into EMOP 200177, which was approved by the Executive Director and the Director-General of FAO.
- 7. Yemen EMOP 200039 (August 2010–July 2011) provides food assistance for 315,000 internally displaced people (IDPs), returnees and people affected by conflict in northern Yemen at a cost to WFP of US\$47.9 million.
- 8. Chad EMOP 200060 (January 2011–December 2011) provides food assistance for 869,000 Sudanese refugees, IDPs and members of host populations in the eastern regions at a cost of US\$133 million.

9. Sudan EMOP 200151 (January 2011–December 2011) ensures humanitarian assistance for 6.8 million people in areas affected by conflict. The activities include assistance to meet the immediate food needs of vulnerable populations through general food rations, food-based nutrition programmes for malnourished children and pregnant and lactating women, and targeted food-for-assets activities to improve access to food and offset seasonal hunger in vulnerable areas. The cost of the operation is US\$628.2 million.

10. Democratic Republic of the Congo EMOP 200186 (January 2011–December 2011) assists IDPs, returnees, refugees, repatriating refugees and other vulnerable groups in host communities in Bas and Haut-Uélé districts. The operation will support 377,000 people at a total cost of US\$25.0 million.

EMOPS APPROVED UNDER THE DELEGATED AUTHORITY OF THE DEPUTY EXECUTIVE DIRECTOR AND CHIEF OPERATING OFFICER¹

- 11. Burkina Faso EMOP 200196 (October 2010–January 2011) provides food assistance for people severely affected by floods in July and August 2010. The operation targets 77,000 beneficiaries at a cost to WFP of US\$2.8 million.
- 12. Guinea EMOP 200216 (October 2010–December 2010) supported preparedness activities in view of political instability and deteriorating food security. The operation cost US\$94,000.
- 13. Asia Regional EMOP 200205 (October 2010–February 2011) supports preparedness simulations by the regional bureau in three locations at high risk of earthquakes: Jakarta, Kathmandu and Manila. The cost to WFP is US\$114,000.
- 14. Philippines EMOP 200206 (November 2010–December 2010) responds to the Government's request for WFP assistance to increase its capacity to respond to natural disasters, particularly disaster risk-reduction. The cost to WFP is US\$200,000.
- 15. Côte d'Ivoire EMOP 200224 (December 2010–February 2011) is intended to reinforce WFP's response capacity following the election crisis through targeted emergency preparedness measures. The cost to WFP is US\$199,000.
- 16. Liberia EMOP 200227 (January 2011–March 2011) aims to augment the capacity of the country office and the Saclepea sub-offices to respond promptly to an influx of refugees from Côte d'Ivoire. The cost to WFP is US\$198,000.

EMOPS APPROVED UNDER THE DELEGATED AUTHORITY OF REGIONAL DIRECTORS OR COUNTRY DIRECTORS²

- 17. Burkina Faso EMOP 200178 (August 2010–November 2010), which responded to flooding in rural areas, assisted 65,000 people at a cost to WFP of US\$483,000; it was followed by EMOP 200196 described above.
- 18. Benin EMOP 200210 (October 2010–November 2010) assisted 50,000 people affected by flooding with family food rations at a cost of US\$497,000.

19. The Gambia EMOP 200213 (November 2010–January 2011) provided food assistance for 13,635 displaced people and rice farmers affected by floods at a cost to WFP of US\$496,000.

- 20. Guinea EMOP 200214 (November 2010–February 2011) provides emergency food assistance for 41,000 beneficiaries displaced by flooding. The operation includes assistance for 4,000 children under 5 suffering from moderate acute malnutrition at a cost to WFP of US\$458,000,
- 21. Indonesia EMOP 200218 (November 2010–January 2011) provides food assistance for 11,000 people affected by the Mentawai tsunami in West Sumatra at a cost to WFP of US\$496,000.
- 22. Nicaragua EMOP 200204 (October 2010–January 2011) meets the needs of 15,000 people suffering from food scarcity following floods and heavy rains caused by La Niña through emergency food assistance at a cost of US\$499,000.
- 23. Togo EMOP 200171 (July 2010–October 2010) provided emergency assistance for Ghanaian refugees in the Savannah region who arrived in late April following violence in Ghana. The operation targeted 9,500 beneficiaries at a cost of US\$431,000.
- 24. Togo EMOP 200220 (December 2010–February 2011) meets the needs of farmers who have lost stock and agricultural assets in floods in Maritime region; many have also lost their homes and are either living in IDP centres or with host families. The operation provides food assistance for 50,000 people at a cost of US\$472,000.
- 25. Colombia EMOP 200221 (November 2010–February 2011) addresses the needs of 31,000 people affected by flooding and landslides at a cost of US\$500,000.
- 26. Côte d'Ivoire EMOP 200226 (December 2010–February 2011) addresses the immediate food needs of 18,000 people affected by violence following the recent electoral stalemate. The operation is valued at US\$499,000.
- 27. Liberia EMOP 200227 (December 2010–February 2011) addresses the immediate food needs of 15,000 refugees from Côte d'Ivoire and vulnerable members of the host population. The operation is valued at US\$500,000.

TREND ANALYSIS

28. Emergency operations valued at US\$2.4 billion were approved between January and December 2010, an increase of 47 percent over 2009, when EMOPs valued at US\$1.7 billion were approved. Most of the increase for 2010 resulted from large EMOPs in response to the crises in Haiti, Pakistan and Niger.
