**TABLE 1: GENERAL ASSEMBLY RESOLUTIONS FROM THE SIXTY-FOURTH SESSION THAT MENTION WFP
AS A FOLLOW-UP AGENCY**

Resolution	Timing	Title	Action by WFP/Results
A/RES/64/84	Completed	Assistance in mine action	WFP has supported the work of the United Nations Mine Action Team. Under Special Operation 103680, WFP removed 200,000 mines and unexploded ordnance along 1,500 km of roads in the Sudan between 2005 and the end of 2008. In 2009, WFP handed over the demining activity to the United Nations Mine Action Office, which took over mine clearance, along with vehicles, an armoured support truck, back hoes, detectors and other equipment. In 2010, WFP's demining equipment in the Sudan was transferred to the United Nations Mine Action Service in Somalia. Open routes have facilitated the return of displaced people and the resumption of trade, business, humanitarian delivery and re-positioning of WFP food assistance in areas that had been inaccessible during rainy seasons. WFP now delivers most of its food assistance in Southern Sudan by road, for example, and resorts to air-drops only when road access has been cut by floods. This approach results in more cost-effective use of resources.
A/RES/64/145	Ongoing	The girl child	WFP approved a new gender policy in 2009 (WFP/EB.1/2009/5-A/Rev.1), on the basis of which it continued to give attention to gender equality and empowerment in its interventions. WFP also adopted a life-cycle approach in age-specific interventions that form a virtuous cycle from the adolescent girl to the womb, infancy, early childhood and school age. Results in 2009 include the fact that 52 percent of WFP's 101.8 million beneficiaries were women and girls, including 47 percent of the 20.7 million schoolchildren who received school meals and/or take-home rations; 3.1 million girls were assisted through mother-and-child health and nutrition and food for training interventions. WFP has implemented a protection project since 2005 with a view to enabling WFP staff and cooperating partners to understand and respond more effectively to the protection concerns of beneficiaries and their communities. To date, 2,000 WFP and partner staff in 25 country offices have been trained to integrate protection issues into the delivery of food assistance, including measures for women and girls. Under this protection project, in September 2010 WFP launched activities aimed at improving prevention of and responses to sexual and gender-based violence and sexual exploitation and abuse in food-assistance contexts: countries for implementation include Burundi, Chad, the Democratic Republic of the Congo, Haiti and Kenya; other countries will eventually be included.

A/RES/64/159	Ongoing	The right to food	WFP supports the right to food and country-led efforts to adopt right-to-food approaches in line with the Millennium Declaration to reduce poverty and promote human development and human rights and with its Strategic Plan (2008–2013). Through joint FAO/WFP crop and food supply assessment missions, emergency food needs assessments and WFP/UNHCR joint assessment missions, WFP helped to identify people whose food needs were not being met. WFP also supported country-led work to develop sustainable food-security frameworks and effective food-assistance responses for people whose right to food was not being met. WFP's humanitarian and development food assistance was expected to reach 100 million people in 2010, with specific attention to gender equality and empowerment. Resource shortfalls, however, meant that continued prioritization of responses was required.
