#### **BACKGROUND**

1. In the WFP evaluation policy (EB.2/2008/4-A) the Secretariat made a commitment to inform the Board about how it intends to foster learning as part of the evaluation process by "preparing management responses to evaluation recommendations, implementing follow-up actions and reporting on them". This is the first such report to the Board. It provides information about the extent to which the recommendations arising from evaluation reports prepared in 2008 and 2009 have been implemented by Headquarters divisions, regional bureaux and country offices.

#### **METHOD**

- 2. To ensure consistent and systematic follow-up of actions to implement evaluation recommendations, the actions indicated in the management response matrices are entered into a central database, ACE Project, which is managed and maintained by the Performance and Accountability Management Division (RMP).
- 3. RMP sends regular requests to the respective directors, asking them to provide written updates describing progress achieved in implementing the recommendations. On receipt of these updates, RMP records the response actions in the database.
- 4. The responses are reviewed to ascertain their accuracy and assess whether the progress reported has been timely and matched the agreed actions. These reviews, which include both documentation and discussion, provide a moderate level of assurance.
- 5. In cases where actions to implement recommendations have not been taken, the following steps may be taken:
  - > a revised implementation date for outstanding actions is agreed upon;
  - concerns are raised through the management structure to make senior management aware of the lack of progress; and
  - as a last resort, the RMP Director seeks prompt action from the relevant manager.
- 6. This report uses the following categories:
  - ➤ **Implemented**: Action was fully implemented by 31 December 2009.
  - ➤ Outstanding: Action was not yet initiated, or initiated but not fully completed by 31 December 2009.
  - Not applicable: The action was not implemented owing to changes in the operating environment, or for other reasons.

#### **SUMMARY OF RESULTS**

7. Since 2008, the Secretariat has presented management response matrices to the Board simultaneously with their respective evaluation reports. In 2008 and 2009, 17 evaluation reports were presented to the Board with formal management responses. <sup>2</sup> Table 1 shows



that 53 percent were evaluations of operations, 35 percent strategic evaluations, and 12 percent evaluations of country portfolios.

- 8. The findings on implementation status are:
  - There were 148 recommendations made in the 17 evaluation reports. The Secretariat agreed to carry out 216 actions to address these recommendations.
  - ➤ Of the 216 agreed actions, 155 72 percent were to be implemented by 31 December 2009.
  - ➤ Eighty-four 54 percent of these agreed actions were implemented by 31 December 2009, while 44 percent remained outstanding; 2 percent of the actions were deemed not applicable (see Figure 1 and Annex).
  - ➤ Progress has been made to implement the recommendations, but some timelines for implementation were unrealistic and led to delays in taking action to address them.

9. Table 2 shows that 68 percent of the actions related to evaluations of operations were completed, compared with 44 percent for strategic evaluations. Because the



recommendations related to evaluations of country portfolios are for the longer term, their implementation dates had not been reached and they are not included in the analysis.

#### **EFFORTS NEEDED TO ADDRESS OUTSTANDING RECOMMENDATIONS**

- 10. The following efforts are envisaged to improve the implementation rate:
  - ➤ Offices will be encouraged to use evaluation information to improve project design and identify corporate priorities. A corporately agreed forum will be established to discuss common issues arising from evaluation recommendations.
  - ➤ Guidance will be provided to help offices set realistic implementation deadlines that take into consideration competing demands on resources.
