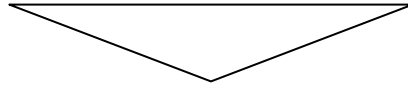

DRAFT DECISION*



The Board takes note of “Report of the Executive Director on the Utilization of Contributions and Waivers of Costs (General Rules XII.4 and XIII.4 (g))” (WFP/EB.A/2006/6-J/1).

INTRODUCTION

- Information is provided to the Board in accordance with General Rules XII.4 and XIII.4 (g) on: (i) the use of unrestricted cash resources to purchase commodities (General Rule XII.4); (ii) contributions of commodities or services only from governments of developing countries, countries with economies in transition and other non-traditional donors (General Rule XIII.4 (e)); and (iii) waivers of ISC for contributions in-kind to cover direct support costs (DSC) (General Rule XIII.4 (f)).

Use of Unrestricted Cash Resources to Purchase Commodities (General Rule XII.4)

- For the purpose of this report, multilateral contributions of cash for the development programme (DEV) category have been considered as unrestricted cash resources, even though these resources may be used in some instances to purchase commodities in the donor country. The resources have been utilized to meet annual requested/allocated commitments under DEVs.
- In 2005, US\$94.7 million (2004: US\$73.6 million) unrestricted cash was available, of which US\$40.2 million (2004: US\$38.3 million), or 42.4 percent (2004: 52.9 percent), was utilized to purchase commodities from developing countries and US\$ 54.5 million (2004: US\$34.7 million), or 57.6 percent (2004: 47.1 percent), for purchases from developed countries. Details are shown in Table 1.
- Further information on purchases of commodities from developing countries from all cash resources and under all programme categories is included in the Annual Performance Report (APR).

Contributions for Commodities or Services (General Rule XIII.4(e))

5. In 2005, the value of contributions of commodities or services only that were received from governments of developing countries, countries with economies in transition and other non-traditional donors under General Rule XIII.4 (e) was US\$52,780,019. Cash contributions of US\$38,702,438 from other donors and US\$3,506,874 from WFP's resources were utilized in support of the contributions. US\$1,137,845 of indirect support costs (ISC) was waived on contributions, as shown in Table 2.

Waivers of ISC for In-Kind DSC (General Rule XIII.4 (f))

6. The total value of waivers of ISC granted on US\$21,987,331 of contributions made in kind for DSC amounted to US\$1,539,113 for 2005. Table 3 provides the details by donor, recipient country, value and ISC waiver.
