APPROVED PROTRACTED REFUGEE AND DISPLACED PERSON PROJECTS FOR WHICH BUDGETARY INCREASES WERE AUTHORIZED BY THE EXECUTIVE DIRECTOR WITHIN HER DELEGATED AUTHORITY BETWEEN 1 JULY AND 31 DECEMBER 1995

1. Between 1 July and 31 December 1995, the Executive Director authorized six budgetary increases within her delegated authority for approved projects. The food value of these increases amounts to 3.5 million dollars¹ and the total cost to WFP to 5.2 million dollars. Detailed budgetary figures and reasons for each increase appear in the annex to this report.
