ABSTRACT

Close to 5,250 indigent families live in isolated highland watersheds which constitute the buffer zones of four national parks in Colombia. These families cultivate potatoes, maize and beans on kitchen gardens, rarely hold title to the lands they occupy, are isolated from markets, have no formal employment and cut down trees for illicit sale of lumber. Their lives are periodically disrupted by a variety of armed rural groups of different political persuasions. WFP and the Ministry of the Environment (MOE) propose to initiate a series of training sessions geared towards introducing the mountain dwellers to self-help productive agricultural packages, combined with improved environmental practices and upgraded health and education infrastructure. MOE will provide national and regional staff to catalyze the participating communities, other government institutions, United Nations agencies and NGO partners, as well as institutional and technical support and follow-up. WFP will distribute 86 family rations annually for each of the 5,250 families for three years to motivate participation and provide food while they are engaged in self-help work and training. Careful beneficiary registration and application of entitlement criteria will be implemented to ensure that assistance reaches the poorest and, among these, women and children in particular. The six commodities in the ration have been carefully selected to meet daily energy and protein requirements, and coincide with local tastes and availability in local markets. WFP-imported wheat will be exchanged for local products: maize, dried green peas, canned fish, vegetable oil, fortified pasta and a sugar-cane drink known locally as *agua de panela*. The ration to be distributed has a local market value equivalent to nearly 50 percent of the minimum daily wage for agricultural labour.

WFP resources will be used for direct food distribution. In addition, a small food security fund will be made available by the Government to individuals and communities who have received the training course and need seed capital to initiate a productive activity. This project, which joins the efforts of WFP and MOE, has been prepared following the deliberations of Conference on Environment and Development held in Rio de Janeiro in 1992.
