Annotated provisional agenda

1. Adoption of the agenda

Pursuant to Rule III of the rules of procedure of the Executive Board, the Executive Director hereby presents, **for approval**, the provisional agenda of the 2018 second regular session. During the session, the Board may, by a two-thirds majority of the members present and voting, amend the agenda by deletion, addition or modification of any item.

2. Appointment of Mr Marc Mankoussou, Deputy Permanent Representative of the Republic of the Congo, as Rapporteur, nominated by List A

Pursuant to Rule XII and in keeping with the established methods of work, the Board may appoint a Rapporteur from among the representatives.

3. Opening remarks by the Executive Director

Under this item, the Executive Director will make an oral presentation to the Board on current and future strategic issues facing WFP.

His Excellency Alberto Beltrame, Minister for Social Development of Brazil, will deliver a statement with a particular focus on how South–South and triangular cooperation will contribute to the achievement of the Sustainable Development Goals.

4. Annual reports

a) <u>Annual report of the Office of the Ombudsman and Mediation Services for 2017 and</u> <u>management note) – POSTPONED TO THE 2019 FIRST REGULAR SESSION</u>

The annual report of the Office of the Ombudsman will be presented to the Board **for its consideration**. The report will cover the work of the Office of the Ombudsman in each area of its mandate for the period from 1 January to 31 December 2017 and will provide information about its activities. A management note to the report will also be presented **for consideration**.

5. Policy issues

a) Update on the Integrated Road Map

Following the approval of the Integrated Road Map at the second regular session of 2016, the Secretariat will present an update on the implementation of its various components and will report on progress and on any needed adjustments. This item is presented **for approval**.

The Board will also have before it, **for information**, the comments and recommendations of the Advisory Committee on Administrative and Budgetary Questions (ACABQ) and the Food and Agriculture Organization of the United Nations (FAO) Finance Committee.

b) Revised Corporate Results Framework (2017–2021)

At its second regular session in 2016, the Board approved the Corporate Results Framework (2017–2021). To take due account of lessons learned through the implementation of the Integrated Road Map, the Secretariat will submit a revision of the Corporate Results Framework. This item is presented **for approval.**

c) 2018 Enterprise Risk Management Policy

As agreed during Board informal consultations on oversight matters held in 2017, the Secretariat will present an updated Enterprise Risk Management policy **for approval.**

d) <u>Update on WFP's implementation of United Nations General Assembly resolution</u> <u>72/279 (repositioning the United Nations development system)</u>

The Board will have an opportunity to dialogue within the membership and to receive an update from the WFP Secretariat on the implementation of the United Nations General Assembly resolution on repositioning the United Nations development system to deliver on the 2030 Agenda. This item is presented to the Board **for consideration**.

e) Update on collaboration among the Rome-based agencies^{*}

At its second regular session in 2010, the Board asked the Secretariat to report annually on Rome-based agency collaboration as a follow-up to the document entitled "Directions for Collaboration among the Rome-based Agencies" (WFP/EB.2/2009/11-C). The report provides a comprehensive overview on the collaboration, along with any new areas of collaboration, initiatives and partnerships for food and nutrition security. This item is presented **for information**.

f) <u>Compendium of policies relating to the Strategic Plan</u>*

At its annual session in 2000, the Board approved the recommendations contained in the Report of the Working Group on Governance (decision 2000/EB.A/6). Governance recommendation (d) established that WFP policy statements should be codified in a compendium. At the Board's request in 2010, the compendium was reorganized to focus on policies relating to the goals of the Strategic Plan. This item is presented **for information**.

The work plan covers financial, performance and compliance audits as well as quality reviews and individual audit assessments. This item is presented **for information**.

a) <u>Summary evaluation report of the strategic evaluation of the pilot country strategic</u> plans (2017–mid-2018) and management response

This evaluation will provide an analysis and assessment of the country strategic plan pilots implemented since the beginning of 2017. The evaluation findings and recommendations will inform the strategic direction, planning and programme implementation in future country strategic plans. b) <u>Summary report on the evaluation of the WFP regional response to the Syrian crisis</u> (January 2015–March 2018) and management response

Evaluations of Level 3 humanitarian emergency response will continue with a two-pronged approach: all Level 3 emergency responses will be evaluated either through an inter-agency humanitarian evaluation or by the Office of Evaluation in a separate evaluation of WFP's response. This evaluation will consider WFP's response to the Syria+5 crisis. This item is presented **for consideration**.

c) <u>Summary report on the evaluation of the Mali country portfolio (2013–2017) and</u> <u>management response</u>

The evaluations provide an analysis and assessment of the portfolios over a five-year period assessing: i) how well WFP is aligned with the context, people's needs, government policies and partner strategies; ii) the drivers and quality of strategic choices; and iii) the portfolios' performance and results. The evaluations' findings and recommendations will inform the country office's strategic direction, planning and programme implementation. This item is presented **for consideration**.
