1. Making reference to the draft full interim country strategic plan (ICSP) for Libya for the period 2019–2020, this short-term interim country strategic plan consists of activities that continue WFP's current projects in the country. It seeks the Executive Board's approval by vote by correspondence of the implementation of such activities during the period from January to March 2019 pending the Board's approval of the ICSP at its 2019 first regular session. This early start is necessary to provide operational continuity until the Executive Board's approval of the ICSP.

- 2. To ensure adequate governance and oversight, all strategic outcomes and activities under the short-term ICSP are based on previously approved projects and ongoing activities. The short-term ICSP will include no strategic outcomes or activities that do not stem from existing projects, and such outcomes and activities will be implemented only under the ICSP after its approval by the Executive Board. Once approved, the ICSP will supersede this shortterm ICSP.
- 3. Under the short-term ICSP WFP will assist the Government of Libya and partners in working towards the following two strategic outcomes through four activities:
 - > Strategic outcome 1: Crisis-affected vulnerable populations in Libya, including schoolchildren, have access to sufficient and nutritious food during and in the aftermath of crises (Sustainable Development Goal (SDG) 2.1)

Focus area: Crisis response

Key activity:

- Activity 1. Provide assistance to food-insecure and vulnerable people in Libya, including schoolchildren, and pilot complementary interventions that improve food security and nutrition.
- > **Strategic outcome 3:** The humanitarian community in Libya has strengthened capacity to assist vulnerable populations during and in the aftermath of crises (SDG 17.16)

Focus area: Crisis response

Key activities:

- Activity 3. Provide logistics sector services to humanitarian partners in Libya.
- Activity 4. Provide air services for personnel and light cargo (United Nations Humanitarian Air Service (UNHAS)).
- Activity 5. Provide common information and communications technology to humanitarian partners in Libya.
- 4. An additional activity under strategic outcome 2¹ (in the resilience building focus area) will not be implemented before the ICSP is approved and is therefore not part of the short-term ICSP.
- 5. WFP will reach beneficiaries under the short-term ICSP as summarized in table 1.

¹ Strategic outcome 2 – vulnerable populations across Libya have strengthened livelihoods and restored access to basic services all year; activity 2 – provide skills strengthening to vulnerable communities and enhance national and local safety nets.
