## Report of the Joint Inspection Unit: Multilingualism in the United Nations system

The Enterprise Risk Management Division presented a document on reports by the Joint Inspection Unit relevant to the work of WFP at the 2021 first regular session of the Executive Board, on 23 February 2021. During the session, Member States requested WFP to provide an update on the implementation of the recommendations made by the Joint Inspection Unit in its review of multilingualism in the United Nations system, which was issued after the reporting deadline. This document has been prepared in response to that request.

## **The Joint Inspection Unit**

- 1. The Joint Inspection Unit (JIU), established by United Nations General Assembly resolution 2150 (XXI) in 1966, is an independent external oversight body of the United Nations system mandated to conduct evaluations, inspections and investigations system-wide. The JIU is composed of 11 inspectors whose aim is to help improve management and methods, promote greater coordination among United Nations organizations and determine whether activities undertaken by participating organizations are carried out in the most economical manner.
- 2. The JIU's participating organizations are the United Nations and its affiliated bodies and specialized agencies. WFP is a participating organization through its constitutional ties to the United Nations and the Food and Agriculture Organization of the United Nations. Relevant JIU reports are addressed to the Executive Director for transmission to the WFP Executive Board.

## Review of multilingualism in the United Nations system

- 3. As part of its programme of work for 2019, the JIU performed a review of multilingualism in the United Nations system.
- 4. As the JIU noted in its report following the review, "the importance of multilingualism in achieving the goals of the United Nations, as set out in Article 1 of the Charter of the United Nations, and its contribution to the three pillars of the organization international peace and security, development and human rights has been consistently emphasized since the organization's establishment. Being an inherent part of the genetic code of the United Nations, multilingualism is both an asset and a shared commitment for all organizations in the United Nations system."
- 5. WFP welcomes the report of the JIU and its observations and accepts all the recommendations, with the exception of one the appointment of a single agency senior official as multilingualism coordinator which it partially accepts, given that the United Nations has appointed a system-wide coordinator at the Under-Secretary-General level with whom WFP will work to support a comprehensive and coordinated approach to multilingualism (see annex, remarks on recommendations 2 and 5). WFP recognizes the importance of multilingualism in the United Nations system to ensuring harmonious communication, effective participation and increased effectiveness in the work of the organization.
- 6. The annex to the present document sets out six of the seven recommendations in the JIU report, including three recommendations for action by the legislative body, and the responses suggested by the Secretariat. All six recommendations are proposed for closure, as multilingualism is embedded in WFP operational, administrative and governance processes, including human resources, conference services and interpretation, translation, programming and the WFP website. Furthermore, WFP will support any inter-agency initiatives resulting from the recommendations in the JIU report.

WFP notes that succession planning for language professional staff is limited, as the organization has no interpreter staff positions and only one translator/reviser and one proofreader staff position per language.		
4	The legislative or governing bodies of the United Nations system organizations should request the executive heads of their respective organizations that have not yet done so, to introduce, by the end of 2022, learning policies that encourage continuous learning and improvement of the language skills of their staff members in the official languages of the respective organizations as well as in other languages, as appropriate, securing sufficient funding for this.	Accepted	Implemented	Closed	<b>Focal point: HRM</b> WFP welcomes the recommendation and notes that multilingualism is a key factor in creating an environment of diversity and inclusion at WFP, in line with its core values. WFP continues to support the improvement of employees' language skills through various online and face-to-face learning resources, partial reimbursement of training expenses and granting of special leave with or without pay for language learning purposes. In early 2021, the Rosetta Stone online language learning platform was made available at no cost for the year to all personnel, irrespective of their contract type.
