# Achievements - Specific Examination Report requested by Executive Board



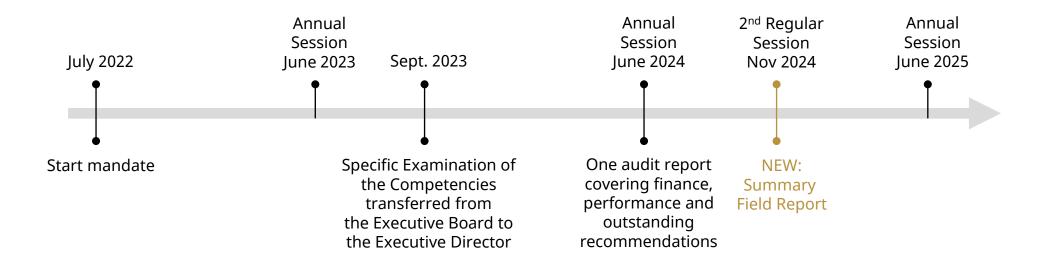


# Achievements - One comprehensive audit report with recommendations' assessment

#### Achievements - Audit impact

- Accounting policy aligned with IPSAS unmodified audit opinion
- Commodities distributed by partners WFP policy to be revised
- WFP budget definitions and processes under review and Management Plan amendments initiated
- Delegation of authority WFP review ongoing
- Financial Statements' informative value more detailed notes disclosures included, further disclosures required



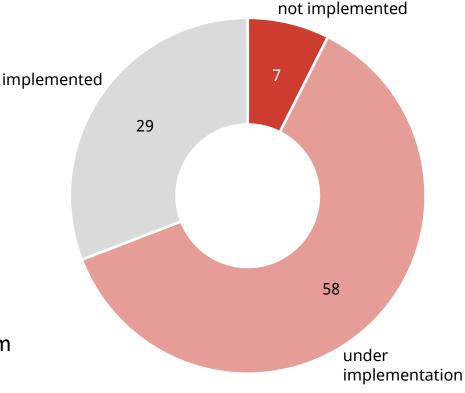
#### 2024 Audit - Reporting

- Audit Report Annual session
  - Contradictory procedure WFP comments included
  - 49 new recommendations
  - Focus areas: Finance, Human Resources, Cooperating Partner Management, Global Assurance Project, Cash-based Transfers and Information Technology
- Summary Field Report 2<sup>nd</sup> Regular Session



2024 Audit - Implementation status of audit recommendations

- External Audit
  - 94 recommendations from 2022-2024 reports
  - 65 recommendations remain open
- Internal Audit
  - Vital part of WFP's internal control system
  - 420 open internal audit recommendations
- → WFP needs to strengthen its internal control system





#### 2024 Audit - Key results

- Unmodified audit opinion for the 2024 Financial Statements
- Cooperating Partner Management
  - Expenses for partner commodity distributions not sufficiently disclosed, no partnerrelated accounting policy, accounting data insufficient to support audit trail
  - No clear responsibility for governmental partners at headquarters
- Global Assurance Project
  - Open recommendations still not implemented



### 2024 Audit - Key results (cont'd)

- Human resources management
  - Additional disclosures of staff costs required
  - New human resources management system procured but payroll process still fragmented
  - USD 11.6 million paid to 144 staff members on special leave with full pay
  - Ex-gratia payments of USD 9.2 million for termination indemnities without legal basis



#### 2024 Audit - ACABQ report

- External Auditor's findings
  - Essential pillar of WFP's oversight framework
  - Valuable tool to improve the management, efficiency and effectiveness
- External Auditor's recommendations
  - Executive Board's endorsement provides firm guidance to WFP
  - Full and timely implementation important



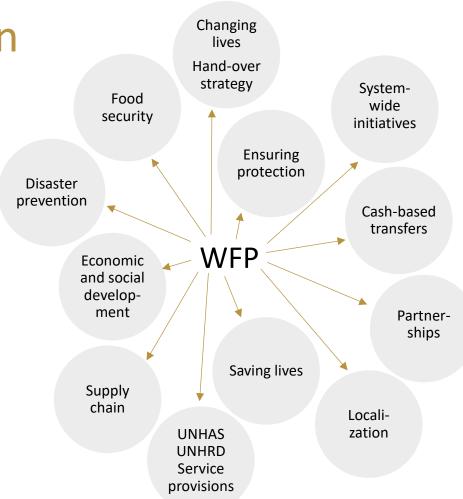
#### Outlook – WFP's response plan

- Planned reduction of 6,000 employees
  - Reduction of employees or abolishment of positions?
  - Costs of terminations/separations?
  - Terminations in line with regulatory framework?
- Roll-out of Global Headquarters cost savings?
- Closure of country offices?



## Outlook - Strategic direction and focus needed

- New Strategic Plan 2026-2029
  - Cooperation with other United Nations entities
- Increase efficiency
  - Standardization
  - Oversight
- Sharpen focus, prioritize
