1. At its Annual and Third Regular sessions of 2000, the Executive Board approved several recommendations for strengthening the governance of the World Food Programme. # ANNOTATED BIENNIAL PROGRAMME OF WORK OF THE EXECUTIVE BOARD (2004–2005)

(classified by subject and session)

## **POLICY ISSUES**

➤ Current and future strategic issues (C) (common to all sessions)

Under this item, the Executive Director will provide, for the Board's consideration, an oral presentation on strategic issues facing the Programme.

#### EB.1/2004 (23–27 February)

➤ Emergency Needs Assessments (C)

At its Third Regular Session in 2003, the Executive Board discussed the importance of improving emergency needs assessments. This document describes how WFP conducts needs assessments in emergencies, reviews lessons learned and outlines WFP's progress towards improving the quality, utility, transparency and credibility of its emergency needs assessments. The document focuses on efforts to refine methodologies, better integrate Vulnerability Analysis and Mapping data into emergency needs assessments, enhance market analysis capacities, train staff, strengthen partnerships and increase transparency and accountability. This document is submitted to the Board for consideration.

> Update on WFP's response to HIV/AIDS (I)

As announced at the 2003 Third Regular Session, WFP officially became the ninth co-sponsor of the Joint United Nations Programme on HIV/AIDS (UNAIDS) on October 16, 2003. This report, **for information**, will update the Board on WFP's involvement in the United Nations system response to the pandemic.

Follow-up to GA Resolution A/56/201 on TCPR (C)

The First Regular Session in 2002 requested the Secretariat to produce an additional and more detailed report on the follow-up action required from the Secretariat and the Board pursuant to General Assembly Resolution, A/RES/56/201: Triennial Policy Review of Operational Activities for development of the UN system. This document is submitted **for consideration**.

➤ WFP Policy on staff recruitment and geographical representation (C)

Taking into account the observations and issues raised by members during the discussion of this topic at EB.A/2003, the Executive Director proposed, and the Board accepted, to submit at a future session a new document on the same topic. This document is submitted to the Board **for consideration.** 

➤ Humanitarian Principles (A)

At the Third Regular Session 2003, the Board asked the Secretariat to clarify the humanitarian principles that guide the Programme in its work. The Executive Director agreed to prepare a Statement of Humanitarian Principles for the Board's review at its First Regular Session in 2004. Drawing on international humanitarian law, relevant United Nations resolutions, international efforts to standardize humanitarian principles and its own policies and experiences, this document proposes a Statement of Principles for the Board's **approval** and for incorporation in the Consolidated Framework of WFP Policies.

➤ Information Note on WFP's support for NEPAD (I)

The Executive Board will have before it, **for information**, a note outlining priority areas of possible cooperation identified by NEPAD (New Partnership for Africa's Development) and WFP (the United Nations World Food programme), together with the Memorandum of Understanding established between the two institutions on 19 November 2003.



## EB.A/2004 (24-28 May)

Annual Performance Report for 2003 (A)

General Rule VII.2 states: "Each year the Executive Director shall submit to the Board **for its consideration and approval** an Annual Report and other reports as directed by the Board". Further, Governance recommendation (h), approved by the Board at its Third Regular Session in 2000 (decision 2000/EB.3/1—Follow-up to Executive Board Decision 2000/EB.A/6 on Governance), states: "An Annual Performance Report should be developed" based on the Biennial Management Plan previously approved.

The Annual Performance Report for 2003 aims at presenting a relevant and credible analysis of WFP's performance vis-à-vis the commitments made for the year as defined in the Strategic and Financial Plan (2002–2005). In addition, it will take the first steps towards analyzing the programming performance over the past year in light of WFP's recently adopted Strategic and Management Priorities for the period 2004–2007. It will present also provisional conclusions about the extent to which WFP has already been addressing these priorities.

➤ Nutrition Issues (three papers proposed to be discussed together)(C)

The Secretariat proposes that the Executive Board focus the policy component of this session on nutrition, as this is one of the strategic priorities identified in the Strategic Plan and it has not been the subject of recent policy discussion by the Board. This agenda item would include the following three papers **for consideration**:

- A paper on nutrition and emergencies would seek to identify and document how WFP and its partners are
  presently addressing nutrition in emergency situations and suggest ways to enhance the nutritional impact of
  WFP activities.
- 2. A paper on **food for nutrition** would inform the Board of the Programme's ongoing review of food-assisted mother-and-child nutrition programmes and identify the key principles that underlie the design and implementation of effective nutrition interventions.
- 3. A paper on **food fortification** would clarify the importance of using food aid to address micronutrient deficiencies, outline WFP's experiences with micronutrient fortification and propose ways to expand micronutrient fortification efforts, including support for national capacities.
- Steering Group on Governance Report on Evaluation Policy (C)

At its Third Regular Session in 2003, the Board requested the Steering Group on Governance to prepare a paper on the evaluation policy. Specifically, the Steering Group was requested to focus its attention on three main issues i) the location of the office of evaluation, ii) the merits and practicability of establishing a sub-committee of the Board on evaluation and iii) the staffing movement for the Office of Evaluation. The paper, which was scheduled for submission early in 2004, is presented to the Board **for consideration**.

Steering Group on Governance Report on the Creation of an Audit Committee (C)

Following discussions on "Best Practices Oversight" paper at EB.3/2003, the Executive Board welcomed the Executive Director's proposal to discuss with the Steering Group on Governance the possibility of creating an External Audit Committee. The SG/G was requested to analyze the subject and prepare a report to be taken into **consideration** by the Board early in 2004.

## EB.3/2004 (11-14 October)

Update of Consolidated Framework of WFP Policies (I)

At its Annual Session in 2000, the Executive Board approved the recommendations contained in the Report of the Working Group on Governance (decision 2000/EB.A/6). Governance recommendation (d) established that WFP policy statements should be codified in a compendium. The "Consolidated Framework of WFP Policies" was first submitted to the Board at its Annual Session in 2002. A hard copy of the update of the Consolidated Framework is submitted to the Board for information. (An electronic update is available at the WFP web site www.wfp.org.)

Follow up to ECOSOC, GA and FAO Resolutions adopted in 2003 (C)

The Board will have before it, **for consideration**, a document outlining the relevant sections of ECOSOC, General Assembly and FAO resolutions adopted in 2003 as well as a report on the follow-up action taken or envisaged by the Secretariat.



#### ➤ Progress Report on School Feeding Exit Strategies (I)

A "Progress Report on School Feeding Exit Strategies" will be presented to the Board **for information** in response to its decision, at the First Regular Session in 2003 (WFP/EB.1/2003/10), to request a progress report on the implementation of the policy to be submitted to the Third Regular Session in 2004.

#### ➤ Food-based Safety Nets (A/C)

This paper would examine the potential role of food aid in the context of social protection and safety nets, including possible policy and programming ramifications for WFP. This paper will be **for approval or consideration**, depending on whether or not the conclusions of the paper would require Executive Board approval of any specific policy changes in the "Consolidated Framework of WFP Policies".

#### ► Building National and Regional Capacities (A/C)

This paper would engage the Board on possible ways to help ensure that national and regional capacities are established, strengthened and/or supported in the aftermath of an intervention by WFP. This paper will **be for approval or consideration**, depending on whether or not the conclusions of the paper require Executive Board approval of any specific policy changes in the "Consolidated Framework of WFP Policies".

#### EB.1/2005 (31 Jan-4 February)

#### > Definition of Emergencies (A)

This paper **for approval** would review the Programme's existing definition of emergencies in light of the definitions in use by other United Nations agencies and partners and current emergency trends. This paper is prepared in response to the Board's request, in its discussion of the first "Consolidated Framework of WFP Policies" at its 2002 Annual Session, that the Secretariat present proposals for policy topics to be discussed at future sessions, with particular focus on topics related to emergencies.

#### Food for training (C)

This paper, **for consideration**, would examine lessons learned from past experiences, including implementation of the commitment, articulated in the Gender Policy approved by the Board at its Third Regular Session of 2002, to ensure that women and adolescent girls constitute at least 70 percent of the participants in food-assisted training activities.

#### Exiting Emergencies (C)

This paper will review lessons learned from WFP and partner experiences in closing down emergency operations in countries where longer term activities were not deemed necessary. The paper, which would seek to engage the Board on potential policy options and approaches, is prepared in response to the Board's request, in its discussion of the first "Consolidated Framework of WFP Policies" at its 2002 Annual Session, that the Secretariat present proposals for policy topics to be discussed at future sessions with particular focus on topics related to emergencies. This paper will be **for consideration**, depending on whether or not the conclusions of the paper would require Executive Board approval of any specific policy changes in the "Consolidated Framework of WFP Policies".

#### EB.A/2005 (30 May-3 June)

#### ➤ Annual Performance Report for 2004 (A)

General Rule VII.2 states: "Each year the Executive Director shall submit to the Board **for its consideration and approval** an Annual Report and other reports as directed by the Board". Further, Governance recommendation (h), approved by the Board at its Third Regular Session in 2000 (decision 2000/EB.3/1—Follow-up to Executive Board Decision 2000/EB.A/6 on Governance), states: "An Annual Performance Report should be developed" based on the Biennial Management Plan previously approved.

The Annual Performance Report for 2004 aims at presenting a relevant and credible analysis of WFP's performance vis-à-vis the commitments made for the year as defined in the Strategic and Financial Plan (2002–2005). In addition, it will take the first steps towards analyzing the programming performance over the past year in light of WFP's recently adopted Strategic and Management Priorities for the period 2004–2007. It will present also provisional conclusions about the extent to which WFP has already been addressing these priorities.



#### Strategic Plan (2005–2008) (A)

At its Third Regular Session in 2000 the Executive Board approved the recommendations contained in the Report on the Working Group on Governance (decision 2000/EB.A/6). Governance recommendation (b) establishes that the current Strategic and Financial Plan should be adapted into a Strategic Plan, notably by the incorporation of results-based objectives. The Strategic Plan was first presented at the Third Regular Session of 2003. This document is submitted to the Board **for approval.** 

➤ Progress Report on the implementation of WFP Policy on HIV/AIDS (I)

A "Progress Report on the Implementation of the WFP Policy on HIV/AIDS" will be presented **for information** in response to the decision of the Board at its First Regular Session, 2003 (WFP/EB.1. 2003/10) to request a progress report on the implementation of the policy to be submitted to the Board in 2005.

➤ Food Aid Sources (C)

This paper, **for consideration**, would review trends in the availability and sources of food aid, and the implications of those trends for the Programme.

➤ Local Purchases and Procurement (C)

This paper, **for consideration**, would clarify WFP's purchase and procurement of services and commodities and these efforts' potential for making a positive contribution in developing countries.

#### EB.3/2005 (7–11 November)

➤ Update of Consolidated framework of WFP policies (I)

At its Annual Session in 2000, the Executive Board approved the recommendations contained in the Report of the Working Group on Governance (decision 2000/EB.A/6). Governance Recommendation (d) established that WFP policy statement should be codified in a compendium. The "Consolidated Framework of WFP Policies" was first submitted to the Board at its Annual Session in 2002. A hard copy of the update of the Consolidated Framework is submitted to the Board for information. (An electronic update is available on the WFP website www.wfp.org.)

➤ Humanitarian Access (A/C)

This paper would inform the Board of processes that clarify the Programme's approach, in collaboration with its United Nations partners, to securing safe and unhindered access to people affected by emergencies, and seek guidance where needed. The paper is prepared in response to the Board's request, in its discussion of the first "Consolidated Framework of WFP Policies" at its 2002 Annual Session, that the Secretariat present proposals for policy topics to be discussed at future sessions, with particular focus on topics related to emergencies. This paper will be **for approval or consideration**, depending on whether or not the conclusions of the paper require Executive Board approval of any specific policy changes in the "Consolidated Framework of WFP Policies".

Targeting (A/C)

This paper would review and assess WFP's targeting policies and practices, update the Board on the latest trends in this area, and identify issues or areas upon which the Board might wish to focus particular attention. This paper would be **for approval or consideration**, depending on whether or not the conclusions of the paper require Executive Board approval of any specific policy changes in the "Consolidated Framework of WFP Policies".

Follow-up report on the decentralization initiative (C)

During discussion of the Review of WFP's decentralization initiative, at the Third Regular Session of the Executive Board in October 2003, members requested that a follow-up review of decentralization be undertaken during 2005, with a focus on regional knowledge sharing, cost efficiency and the effect of programming on beneficiaries. It should also take into account other organizations' experience with decentralization. The paper being presented to the Board **for consideration** is the result of that request.

Status Report on Results-Based Management (I)

At its Annual Session and Third Regular Session in 2003, the Secretariat presented information notes on the status of RBM implementation in WFP and the next steps anticipated. The Executive Board requested that another status report be provided at some time in the 2004-2005 biennium, and asked the Secretariat to propose the timing for such a report. The Secretariat proposed the Third Regular Session of 2005, so that sufficient time could be given for training, the development of performance information systems, and completion of baseline studies, as well as the



completion of two Annual Performance Reports (for 2003 and 2004) upon which to assess progress. The document is submitted **for information**.

Follow-up to ECOSOC, GA and FAO Resolutions adopted in 2004 (C)

The Board will have before it, **for consideration**, a document outlining the relevant sections of ECOSOC, General Assembly and FAO resolutions adopted in 2004 as well as a report on the follow-up action taken or envisaged by the Secretariat.

## RESOURCE, FINANCIAL AND BUDGETARY MATTERS

## EB.1/2004 (23-27 February)

Business Process Review: pilot financing paper (A)

The report on BPR presents a proposal **for Board approval** of financing mechanisms for BPR pilot projects and provides a summary update of BPR work to date. BPR, which started in March 2003, addresses the inefficiencies evident in large unspent balances.

The Board will also have before it, **for information**, the comments and recommendations of the United Nations Advisory Committee on Administrative and Budgetary Questions (ACABQ) and the FAO Finance Committee.

► Basis for calculation of indirect support costs (ISC) on ocean transport costs (A)

This document describes the legislative requirement of the United States Government contributions to use vessels carrying the United States flag for the shipment of commodities donated by the United States and its practical implication on the cost of ocean transport of United States commodities. The document describes the agreement of the Executive Director with the United States Government for the exclusion of the premium portion of the ocean transport cost in the calculation of ISC and seeks the **Board's approval** for this decision of the Executive Director.

The Board will also have before it, **for information**, the comments and recommendations of the ACABQ and the FAO Finance Committee.

#### EB.A/2004 (24–28 May)

Comprehensive Financial Report (including Report of the Executive Director on the waivers of costs (General Rules XII.4 and XIII.4)) (C)

The Board will have before it, **for consideration**, a comprehensive report on various financial issues. The document will include, *inter alia*, a policy paper on the management of local funds (held in custody in decentralized offices) and the Report of the Executive Director on the Waivers of costs.

Audited Biennial Accounts 2002–2003, with comments of the ACABQ and FAO Finance Committee (including Report on the Status of the PSA Equalization Account) (A)

In accordance with General Regulation XIV.6 (b), the Executive Director will submit to the Board, **for approval**, the biennial financial statements of WFP, together with the reports of the External Auditor. The financial statements are submitted under cover of the Executive Director's statement on the biennial accounts.

In addition and as requested by the Board at its Third Regular Session in 2002, a report on the status of the PSA Equalization Account will be submitted together with the Audited Biennial Accounts.

➤ Report of the Inspector-General (C)

In accordance with WFP's General Regulations, Article VI.2 (b) (viii), the Report of the Inspector-General for the period 2002–2003 is hereby submitted to the Executive Board **for consideration**. The Board may wish to provide its comments, which together with the report will be forwarded to the United Nations Office of the Internal Oversight Services, as established by Board decision 1996/EB.3/3.



➤ WFP pledging target 2005–2006 (A)

The Board will have before it, **for approval**, a document presenting the Executive Director's proposed pledging target for the biennium 2005–2006, to be presented to the Pledging Conference jointly convened by the Secretary-General of the United Nations and the Director-General of FAO, to be held in the first week of November 2004.

#### EB.3/2004 (11–14 October)

- Follow-up on the Recommendations of the External Auditor (I)
  - ♦ Final Report on the Implementation of Recommendations in the 2000–2001 Report of the External Auditor
  - ♦ Progress Report on the Implementation of Recommendations in the 2002–2003 Report of the External Auditor
- ➤ Paper on Private Sector Engagement (I)

Following discussions at EB.3/2003 on (i) the WFP Strategic Plan 2004–2007 and (ii) the importance of broadening the donor base and engaging the private sector in order to achieve its objectives, the Board decided that a policy paper on private-sector engagement was needed.

Private-sector fundraising is a new area of emphasis in resource mobilization. It is important that WFP recipients and donors understand the objectives of engaging with the private sector and the safeguards established to control that engagement. The paper begins by setting out the opportunities to be converted from private-sector engagement and United Nations activities, and suggests guidelines for private-sector interaction. It then explains the steps that WFP will take to ensure transparency and justice in private-sector business relationships and to protect the integrity of membership governance. If changes are needed in WFP's rules and regulations, they will be set out and analyzed. The paper will compare the established practices of United Nations sister agencies with those adopted, or scheduled for adoption, by WFP management.

This paper is submitted to the Board for information.

➤ Amendments to Financial Regulations (A)

Pursuant to General Regulation XIV, the Board will have before it, **for approval**, proposed amendments to the Financial Regulations. These are required in line with the decisions of the Board on governance concerning the Strategic Plan and Management Plan.

Pursuant to General Regulation XIV.4, the Executive Director has forwarded the document for review to the ACABQ and the FAO Finance Committee. Their comments and recommendations will be submitted to the Board **for information**.

## EB.A/2005 (30 May-3 June)

Comprehensive Financial Report (including Statement on controls) (C)

The Board will have before it, **for consideration**, a document that presents various financial issues in a comprehensive report.

Pursuant to General Regulation XIV.4, the Executive Director will forward the document for review to the ACABQ and the FAO Finance Committee. Their comments and recommendations will be submitted to the Board for information.

#### EB.3/2005 (7–11 November)

Management Plan (2006–2007) including Evaluation Budget and Workplan for 2006–2007 (A)

At its Annual Session in 2000, the Executive Board approved the recommendations contained in the Report on the Working Group on Governance (decision 2000/EB.A/6). Governance recommendation (f) established that a Management Plan would be submitted to the Board each financial biennium. The first Management Plan was presented to the Board at the Third Regular Session, 2003 ((Management Plan 2004–2005). The document is submitted to the Board for approval.



➤ Risk Management Policy/Strategy (C)

The "Best Practices in Oversight Mechanisms" paper (WFP/EB.3/2003/5-D/1) presented to the Board at its Third Regular Session in 2003 identified risk management as an important best practice in governance. The Board looked forward to development of a policy and an associated action plan for its consideration in October 2005 (decision 2003/EB.3/9). The paper, **for consideration** by the Board, focuses on WFP's policy and strategy for implementing corporate risk management.

Follow-up on the Recommendations of the External Auditor (I)

Second Progress Report on the Implementation of the Recommendations in the 2002–2003 Report of the External Auditor is presented to the Board for information.

## **EVALUATION REPORTS**

## EB.1/2004 (23–27 February)

The Evaluation documents submitted under item "A" are presented to the Board **for consideration**. The Board is requested to take note of the report and the associated information note summarizing the action taken so far by management in implementing the recommendations. The UNJLC Iraq Review Information Note and the Information Note on WFP Assistance to Internally Displaced Persons in the Democratic Republic of the Congo are **for information**.

#### Sub-Item A)

> Thematic Evaluation on the Protracted Relief and Recovery Operation (PRRO) category (C)

The PRRO category was introduced in 1998, replacing the former more restricting protracted relief operation (PRO) category for refugees and displaced persons. The new category places greater emphasis on rehabilitation and recovery. This thematic evaluation looks at the relevance and efficiency of the PRRO programming category, particularly the added value of transforming former PROs and emergency operations into PRROs.

#### Sub-Item B)

> Information Note on the review of the UNJLC operation in Iraq (I)

At the request of the Surface Transport Service (OTL), a review of the Iraq United Nations Joint Logistics Centre was undertaken in September 2003. This review will allow comparisons with the earlier review of the Afghanistan UNJLC and will identify lessons for future UNJLCs. This document is presented **for information**.

➤ Information Note on WFP assistance to Internally Displaced Persons in the Democratic Republic of the Congo (I)

The DRC evaluation was undertaken in March-April 2003. It focused on the effectiveness of WFP relief operations for some 1.4 million displaced persons in the country and was based on geographical case studies that sought to capture the different realities in various parts of the country. A consciously participatory approach was adopted. This paper is presented **for information**.

#### EB.A/2004 (24–28 May)

Review of experience with the real time evaluation approach (C)

As mentioned during the discussion, during the Third Regular Session of the Executive Board, in October 2003, of the real time evaluation (RTE) of WFP's response to the crisis in Southern Africa, the Office of Evaluation was to undertake a review of its experience with the first pilot RTE, with a view to improving the methodology and approach. The paper being presented to the Board **for consideration** is the result of that work.



## EB.2/2004 (31 May-4 June)

The Evaluation document submitted under this item is presented to the Board for consideration. The Board is requested to take note of the report.

Evaluation of the Sahel drought emergency operation (C)

At the time of writing, the concept paper for this evaluation is being finalized. It is anticipated that the mission will take place in November 2003 and that three out of the five EMOP countries will be visited (Mali, Mauritania and Senegal or Gambia), which together represent over 90 percent of the planned beneficiaries. The evaluation will focus on the outcomes of the two main objectives (nutritional support and asset maintenance) of the planning document.

#### EB.3/2004 (11-14 October)

The Evaluation documents submitted under this item are presented to the Board **for consideration**. The Board is requested to take note of the reports and the associated information notes summarizing the action taken so far by management in implementing the recommendations.

#### Afghanistan PRRO

The Afghanistan PRRO evaluation will take place in early 2004 and will focus on the transition from emergency to recovery activities in the country, and on the role of food aid in the new Afghanistan context. The concept paper is being developed at the time of writing. A preliminary evaluation-planning workshop will take place in Kabul in November 2003.

#### > Eritrea relief portfolio

The Eritrea relief portfolio evaluation will take place in October/November 2003. It will focus on outcomes of the relief operations and emergency-to-recovery linkages.

#### West Africa Coastal PRRO

The West Africa Coastal PRRO is WFP's largest and longest-running relief operation in the West Africa region. It was last evaluated by OEDE in 1996. The concept paper for this new evaluation, which is expected to take place in early 2004, is currently being finalized. The evaluation may focus on IDPs, in view of renewed interest in this group in the region, and on the benefits and constraints of the regional approach.

United Nations inter-agency evaluation of contingency planning for the Iraq operation

Discussions of this proposed inter-agency evaluation commenced in the summer of 2003, but recent events in Baghdad may lead to a postponement of the mission and, consequently, a postponement of the submission of the evaluation report. OCHA is taking the lead in developing the concept paper and terms of reference for the mission, in which UNHCR, UNICEF and WFP, among others, may participate. The focus of the current draft concept paper is on contingency planning and its impact on the effectiveness of the operations.

Progress Report on Angola PRRO

#### EB.1/2005 (31 Jan-4 February)

The Evaluation documents submitted under this item are presented to the Board **for consideration**. The Board is requested to take note of the reports and the associated information note summarizing the action taken so far by management in implementing the recommendations.

#### > Thematic review on nutrition interventions

The thematic evaluation will review WFP's different approaches in nutrition interventions, based on a number of case studies in different geographical regions. The evaluation will take place in 2004 and is to be conducted in close collaboration with the Nutrition Service (PSPN), with whom the concept paper is currently being developed.



Real-time evaluation of a new emergency operation<sup>2</sup>

The emergency operation for this proposed second real-time evaluation has yet to be identified. The current plan is that it should be a single-country quick-onset emergency operation. (WFP's first real-time evaluation was of the six-country regional southern Africa emergency operation and took place during 2002–2003).

#### EB.2/2005 (6–10 June)

The Evaluation documents submitted under this item are presented to the Board for consideration. The Board is requested to take note of the report and the associated information note summarizing the action taken so far by management in implementing the recommendations.

- Bangladesh CP
- Chad CP
- Uganda CP

The above three country programme evaluations will follow individually tailored terms of reference rather than the previous generic terms of reference and will focus on the relevance and outcomes of the CP activities. Chad and Uganda are first-generation CPs; Bangladesh is a second-generation CP.

#### Rwanda portfolio

The Rwanda portfolio evaluation will examine WFP's relief operations and development activities in the country, including the linkages between the two.

> Thematic evaluation on targeting efficiency

At the time of writing, the concept paper for this thematic evaluation is being developed. It is anticipated that the evaluation will use earlier OEDE evaluations as resource material and will be based on number of new case studies. A particular focus of the evaluation will be targeting efficiency in relief operations.

#### ➢ OEDE Impact Study

An OEDE impact study will be presented **for consideration**. This study will examine the impact of OEDE-managed evaluations and recommendations, with a focus on the medium- to long-term follow-up on the most significant recommendations arising from evaluations undertaken in recent years.

## EB.3/2005 (7-11 November)

The Evaluation documents submitted under this item are presented to the Board **for consideration**. The Board is requested to take note of the report and the associated information note summarizing the action taken so far by management in implementing the recommendations.

> Thematic evaluation on food for assets

The evaluation should commence in the latter half of 2004 and focus on WFP's experience in creating sustainable assets. The concept paper will be developed in close consultation with the Policy and External Affairs Department (PED).

Angola PRRO

The Angola PRRO evaluation will be a follow-up to the evaluation undertaken in late 2001 and should yield interesting lessons in view of the political changes that have taken place in the country since then.

#### ➤ Colombia PRRO

The concept paper for the Colombia PRRO evaluation has yet to be developed. The evaluation should take place in early 2005.

People's Republic of China phase-out impact evaluation

The evaluation should take place in late 2004 or early 2005. Its focus will be the impact of WFP operations over the 20 years of WFP presence in the country, since the early 1980s.
