At the Third Regular Session of the Executive Board in October 2001, members requested that the Board be regularly informed of emergency operations (EMOPs) approved either under the delegated authority of the Executive Director when the value of the committed food was below US\$3 million, or jointly by the Executive Director and the Director-General of the Food and Agriculture Organization of the United Nations (FAO) when the food value was above US\$3 million.

- 2. The first such report is being provided at the Second Regular Session of 2002, reflecting the previous year.
- 3. In future, this information will be provided twice a year to Executive Board members. At the First Regular Session of the Board in February each year, a report will be provided covering the period July to December of the previous year. At the Board's Third Regular Session in October, a report will be provided for the period January to June of that year.
- 4. To inform Executive Board members without duplicating information already provided through other sources, this report will regularly include the list of approved emergency operations with the main project statistics and a brief overview of figures and developments. More detailed, country-specific information will not be provided, because it is already shared with Board members through the Yellow Pages document issued at each Board session.
- 5. In 2001, 41 EMOPs were approved, benefiting more than 28.8 million vulnerable people in urgent need of food aid. Among these operations, 16 EMOPs were approved jointly by the Executive Director and the Director-General of FAO; 25 operations were approved under the delegated authority of the Executive Director, including 13 immediate-response EMOPs locally approved by Country Directors under the authority delegated to them by the Executive Director. These 41 operations represented a commitment of almost 2.5 million tons of food, with a food cost of US\$452.5 million and an overall cost to WFP of over US\$1.1 billion.
- 6. The Executive Director and the Director-General of FAO jointly approved 16 emergency operations with a value of committed food of over US\$3 million: Afghanistan (three operations), the Democratic People's Republic of Korea, Pakistan, Sri Lanka, Palestinian Territory, Ethiopia, Eritrea (two operations), Sudan, Kenya, Zambia, Zimbabwe, Chad and El Salvador. The food value of these EMOPs was almost US\$434 million, representing a commitment of over 2.4 million tons of food. The cost to WFP of these operations, including transport and support, was over US\$1 billion, representing 97 percent of the value of EMOPs approved.
- 7. The Executive Director approved, by delegated authority, 12 emergency operations with a food value below US\$3 million: India, Bolivia, Peru, Namibia, Zambia, Central African Republic, Gabon, Malawi, Niger, Djibouti, Senegal and Cameroon. The food value of these EMOPs was just over US\$17 million, representing a commitment of approximately 64,700 tons of food. The cost to WFP of these operations was US\$31.77 million.



8. WFP Country Directors used the authority delegated to them by the Executive Director to approve immediate-response EMOPs with an overall cost of up to US\$200,000, which were funded through the Immediate Response Account (IRA). In 2001, 13 such operations were approved: India, Algeria, El Salvador, Ecuador (two operations), Peru, Belize, Cuba, Malawi, Niger, Gambia, Central African Republic and Cameroon. The food value of these projects was US\$1.5 million, representing a commitment of approximately 1,400 tons of food. The cost to WFP of these operations was US\$2.17 million.

- 9. EMOPs approved in 2001 are listed in the tables below according to their approval level. Of the 41 emergency operations approved, 22 were in Africa, 9 in Latin America, 6 in the Middle East and Central Asia and 4 in other parts of Asia. Africa remains the region with the highest number of emergency operations; the largest requirements are in eastern and southern Africa.
- 10. Requirements for emergency operations in seven countries represented over 90 percent of emergency needs in 2001. The main emergency operations included the three consecutive EMOPs for Afghanistan, representing 35 percent of emergency needs, the Democratic People's Republic of Korea, 19.5 percent; Sudan, 9.7 percent; Ethiopia, 8.1 percent; the two EMOPs for Eritrea, 7 percent; Kenya, 5.5 percent; and Zimbabwe, 5.4 percent.
