- 1. Since the first AIDS cases were identified in Rwanda in 1983, the disease has progressed dramatically, affecting people of all ages, especially women and children. The national prevalence rate has reached 11.2 percent: 10.8 percent male and 11.3 percent female. There is no significant difference between urban (11.6 percent) and rural (10.8 percent) prevalence rates. The 1997 population-based sero-survey, conducted by the Ministry of Health, revealed that the virus infects a large number of people between the ages of 15 and 49.
- 2. The Government of Rwanda is reorienting its approach towards HIV/AIDS from largely health-related activities to activities that address the socio-economic impact of the pandemic on significantly affected groups. Several donors, national and international, have initiated pilot activities exploring ways to improve the food security of these groups. WFP initiated this pilot project to support community-based activities that focus on vocational skills training and income generation. These activities are expected to strengthen coping mechanisms and to accelerate the reintegration of target groups into productive activities, thus mitigating the impact of HIV/AIDS on household food security. Food assistance is provided to participants in life-skills training and community-elected peer counselling to promote family and community care. Through such interventions, the project will contribute to breaking the vicious circle of poverty and infection. Take-home rations will be used as incentives and compensation for opportunity costs and as provision for family members to improve household food security.
- 3. The project will focus primarily on two of the five strategic priorities of WFP's Enabling Development policy:
 - to enable poor households to invest in human capital through education and training; and
 - ➤ to make it possible for poor households to gain and preserve assets.
- 4. The interventions are designed within the context of the United Nations Development Assistance Framework (UNDAF) and address the combined problem areas of HIV/AIDS and food insecurity. The target groups of this pilot project are similar to those identified by the Government and the United Nations system.
