#### FINANCIAL AND BUDGETARY MATTERS

#### 1999/EB.3/1 The WFP Biennial Budget for the Period 2000-2001

After consideration of WFP's biennial budget estimates for the period 2000-2001 as submitted by the Executive Director in document WFP/EB.3/99/3-A and the comments of the FAO Finance Committee and the Advisory Committee on Administrative and Budgetary Questions (ACABQ) (WFP/EB.3/99/3-A/1 and WFP/EB.3/99/3(A,B,C)/2), the Executive Board:

- a) **Took note** of the operational levels, including the projected expenditure components by programme and cost category as outlined in Table 2 (paragraph 48) of WFP/EB.3/99/3-A;
- b) **Approved** a net Programme Support and Administration (PSA) appropriation in the amount of *US\$193,882,000* based on an indirect support cost recovery rate of 7.8 percent for the purposes indicated below:

Programme Support: Regional and Country Offices 73,106,000
Programme Support: Headquarters 26,778,000
Management and Administration 93,998,000
Net Total 193,882,000

- c) **Authorized** the Executive Director to adjust the PSA component of the budget in accordance with any variation in volume of operations when such variations are more than 10 percent from the planned level;
- d) **Authorized** the Executive Director to re-cost the budget at the US\$/Lira exchange rate fixed by the FAO Conference for the 2000–2001 biennium; and



e) **Authorized** the Executive Director to allot up to US\$33 million for the purposes of advancing Direct Support Costs (DSC) under the DSC Advance Facility.

The Board commended the Secretariat for its serious and thorough follow-up of the implementation of the recommendations of the External Auditor and encouraged it to continue reporting progress in this manner.

- b) fund the accrued liabilities from the unearmarked balance of the General Fund; and
- c) provide for the current service costs for after-service medical coverage for 1998 and subsequent years from the biennial budget of the organization.

#### **REVISION OF WFP GENERAL RULE XIII.1: CONTRIBUTIONS**

#### Contributions may be:

- (a) pledged at conferences convened jointly by the Secretary-General and the Director-General and shall aim at such target and for such pledging periods as may from time to time be set by the Board;
- (b) announced during periodic resource consultations;
- (c) committed on an ad hoc basis by donor governments and bilateral institutions;
- (d) made in response to appeals;
- (e) through other fund-raising activities, including in the private sector; and
- (f) made in any other manner as may be determined by the General Assembly of the United Nations and the FAO Conference.
