EVALUATION REPORTS

1999/EB.2/1 Evaluation Reports

The Board considered the reports below, pointing to the need for better project design, clearer objectives, baseline data, measurable indicators, improved monitoring and evaluation, and an exit strategy. In line with the recommendations made in the reports, the Board stressed the need for WFP to seek partnerships with other donors, United Nations agencies and NGOs in order to ensure technical capacity in connection with food assistance.

The Board recommended that in future the Secretariat provide an overview of the measures taken in relation to recommendations made in evaluation reports. Furthermore, the Board urged the Secretariat to present evaluation reports in advance of Country Programmes, whenever possible.

a) Terminal Evaluation of Protracted Relief Operation (PRO) Mali 5804.00—Protracted Food Assistance for Malian Refugees, Returnees, Internally Displaced Persons and Those Affected by Conflict in Northern Mali (WFP/EB.2/99/3/2)

The Board considered the Summary Report of the terminal evaluation of PRO Mali 5804.00 and recommended that the lessons learned be integrated into future projects and activities.

b) Burkina Faso 4959.00—Supplementary Feeding for Vulnerable Groups (WFP/EB.2/99/3/1)

The Board considered the Summary Evaluation Report on Development Project Burkina Faso 4959.00 and requested that the Secretariat make available written information on how the recommendations made by this evaluation have been incorporated into the recently approved Burkina Faso Country Programme.

The Board considered the Summary Evaluation Report on Development Project Ecuador 4463.00 and commended the inclusion of an overview of follow-up measures taken since the mission in order to overcome the shortcomings in the implementation and improve the targeting of the project.
