ABSTRACT

The project, which falls under the Government's Three-Year Socio-Economic Development Programme, aims to support vulnerable groups in the city of Kinshasa and its outskirts—particularly women—with a view to helping them improve their living conditions. These vulnerable groups will engage in community sanitation works, the rehabilitation of rural service roads, and income-generation activities.

WFP will support the food-for-work component. The NGO World Vision is the implementing partner. This pilot experience is expected to constitute a starting point for a programme on a larger scale. Although approved on 13 August 1998, the project is not yet operational because of the conditions of insecurity prevailing throughout the country's territory.
