ABSTRACT

Because of the rugged terrain and low population density in Bhutan, for many children the nearest schools are too far away for daily commuting. In recognition of the food insecurity situation in the remote areas of Bhutan and the difficulty of bringing education within the reach of children living in remote areas, boarding schools are an essential feature of education in Bhutan. WFP approved this project to provide food aid as income transfer to families enrolling their children as boarders at primary and community schools and to provide a limited incentive for enrolment at primary day-schools.

The primary objectives of the project are: increasing the enrolment rate and preventing drop-out of students; assisting the Government in fully taking over the feeding of junior high and high school boarders; increasing the enrolment of girl boarders at selected junior high and high schools; and enhancing awareness of gender issues amongst school staff and community members.

During the entire project period, WFP will provide a total of 43,135,500 rations with a food combination of rice, kharang (maize grits), pulses and vegetable oil.

Under this project, in line with the Country Strategy Outline for Bhutan, food aid will be increasingly targeted to primary and community boarding schools where parents carry the full burden of boarding costs and, in the absence of WFP support, many children would be unable to attend school.

WFP will fund a study to examine the future need for primary boarding hostels and their financing options. This study would be followed by a midterm project review mission, during the second half of 2000. Starting in year one of this project expansion—in accordance with WFP and Government policy—food aid will be gradually phased out from secondary school hostels, where the Government already pays for part of the feeding of boarders, and from primary day-schools where food aid is no longer needed to attract children to enroll.

The project will enhance awareness of gender issues amongst headmasters and teachers as local change agents and address gender gaps in secondary education by improving hostel facilities for girls. The project also envisages the provision of fuel-efficient stoves to school kitchens.
