Agenda

The Executive Board adopted the agenda as proposed (Annex I).

24 March 1997

Appointment of the Rapporteur

In keeping with the established methods of work, the Board appointed Mr. Abdeljelil Ben Ajmia (Tunisia) Rapporteur of the Second Regular Session of 1997.

24 March 1997

1997/EB.2/1 WFP support to countries in establishing and managing national food assistance programmes

The Board endorsed the document (WFP/EB.2./97/3-A) and agreed with the proposed measures to carry out WFP's mandate of providing support to national food assistance programmes.

The Board noted the need for WFP to adopt a careful, demand-driven approach, taking into account the specific circumstances of individual countries.

24 March 1997

1997/EB.2/2 Report to the United Nations Economic and Social Council (ECOSOC) on the follow-up to its resolution 1995/56 - Strengthening of the coordination of emergency and humanitarian assistance of the United Nations

The Board took note of the report (WFP/EB.2/97/3-B) containing information on the follow-up to its decision relating to ECOSOC resolution 1995/56, taken at the Third Regular Session of 1996 (1996/EB.3/4). The Board supported the overall recommendations on coordination and requested the Secretariat to transmit them to ECOSOC through the Secretariat of the United Nations Department of Humanitarian Affairs (DHA).

24 March 1997

1997/EB.2/3 Progress report on the Revision of the Memorandum of Understanding (MOU) with UNHCR

The Board took note of the signature of the revised Memorandum of Understanding (MOU) (WFP/EB.2/97/3-C/Add.1).

24 March 1997

1997/EB.2/4 Progress report on WFP's Commitments to Women

The Board endorsed the strategies proposed in the document (WFP/EB.2/97/3-D and encouraged the Secretariat to continue its efforts to meet WFP's Commitments to Women and the relevant commitments of the World Food Summit.

24 March 1997

1997/EB.2/5 Report of the Open-ended Working Group on the Revision of WFP's General and Financial Regulations

The Board considered the report of the Open-ended Working Group on the Revision of WFP's General and Financial Regulations (WFP/EB.2/97/4), the proposed WFP General Regulations and Rules (WFP/EB.2/97/4/Add.1), and another report of the Working Group containing further recommendations (WFP/EB.2/97/4/Add.2).

After taking a decision on various issues referred to it by the Working Group, the Board decided by consensus:

a) to request the United Nations Economic and Social Council and the FAO Council to endorse and recommend for approval to the General Assembly and the FAO Conference the proposed General Regulations contained in Annex II to this document;

b) to approve provisionally the proposed General Rules subject to the final approval of the proposed General Regulations by both the General Assembly of the United Nations and the FAO Conference. The General Rules could be applied provisionally from that date and confirmed by the Board at its first session thereafter.

25 March 1997

1997/EB.2/6 Evaluation reports

a) General discussion

The Board recommended that evaluation reports continue to be presented before operational documents.

b) Thematic evaluation on forestry projects in India - food aid and



tribal people

The Board took note of the thematic evaluation summary report (WFP/EB.2/97/5/Add.1) on five of the WFP-supported projects that deliver assistance to tribal and scheduled caste people in the forest areas of India: India 2683 - Socio-economic development through forestry activities in Bihar; India 2685 - Socio-economic development and afforestation in Uttar Pradesh; India 2751 - Watershed development and afforestation in Uttar Pradesh; India 2773 (Exp.1) - Employment through forestry activities and tribal development in Rajasthan; and India 3227 - Rehabilitation of degraded forests and afforestation in Madhya Pradesh. It urged the Secretariat and the Government of India to incorporate the recommendations of the evaluations into future activities of this kind. The Board recommended that greater attention be given to improved targeting and needs assessment, monitoring - in particular of benefits and benefit sharing - beneficiary participation, and to alternative income-generating activities.

c) Ex-post evaluation of the impact and sustainability of selected WFPassisted projects in China

The Board took note of the summary evaluation report (WFP/EB.2/97/5/Add.2) of the four selected projects: China 2639 -Xingpuzichuang irrigation project, Jingyuan County; China 2697 -Irrigation in three counties; China 2744 - Improved land use of the Loess Plateau, Mizhi County, Shaanxi Province; and China 3146 - Improvement of low-yielding lands, Anshun Prefecture, Guizhou Province. The Secretariat acknowledged the methodological difficulties involved in distinguishing between the effects induced by the projects and those arising from the generally expanding economy of China. The Secretariat agreed to incorporate an assessment of environmental sustainability into future evaluations of agricultural productivity projects.

d) Thematic evaluation - Case study on WFP phasing-out experience: Brazil

The Board took note of the thematic evaluation report (WFP/EB.2/97/5/Add.3) on project Brazil 2732 (Exp.1) - Feeding of pre-school and primary schoolchildren in depressed areas, and urged the Secretariat to integrate the recommendations of the evaluation into its future work with school feeding programmes and activities. The Board endorsed the recommendation that phase-out plans and corresponding technical assistance should be incorporated into the original design of school feeding programmes. It recommended that the Secretariat integrate the findings of the evaluation into the ongoing formulation of WFP's strategy on school feeding.

e) Evaluation of WFP-assisted emergency relief operations in the Caucasus, including the CLAU operation



The Board took note of the summary evaluation report (WFP/EB.2/97/5/Add.4) in WFP-assisted emergency relief operations in the Caucasus (Georgia, Azerbaijan and Armenia), including the operation Caucasus Logistics Advisory Unit (CLAU), and acknowledged the positive findings. While recognizing the important role played by WFP, the Board stressed that the Secretariat should become involved in logistical exercises only in special food-assistance-related circumstances.

25 March 1997

1997/EB.2/7 Country Strategy Outline - Senegal

The Board welcomed the CSO for Senegal (WFP/EB.2/97/6/Add.1), and noted with satisfaction the WFP strategy proposed therein. The Board pointed out that concrete measures to increase community participation, especially of women, should be clearly defined. It recommended that the synergy between WFP assistance and support from United Nations multilateral and bilateral agencies (particularly the World Bank and FAO), be enhanced. The Board took note of the support given by the Government to the strategy proposed by WFP, and of the Senegalese authorities' firm intention to ensure community participation. The Board recommended that, in formulating a Country Programme, the Secretariat take into account the comments and suggestions made by representatives.

25 March 1997

1997/EB.2/8 Country Strategy Outline - Zambia

The Board welcomed the CSO for Zambia (WFP/EB.2/97/6/Add.2) and recommended that, in formulating a Contry Programme, the Secretariat take into account the comments and suggestions made by representatives.

26 March 1997

1997/EB.2/9 Development project for Executive Board approval - China 5717

The Board approved project China 5717 - Integrated agricultural development in Haidong Prefecture, Qinghai Province (WFP/EB.2/97/7-A/Add.2). It recommended that WFP keep under review the availability of resources.

25 March 1997

1997/EB.2/10 Development project for Executive Board approval - Sudan 531 (Exp.3)

The Board approved project Sudan 531 (Exp.3) - Assistance to primary



school students (WFP/EB.2/97/7-A/Add.1).

26 March 1997

1997/EB.2/11 Budget increase to a project approved previously, for Executive Board approval - Ethiopia 4929

The Board approved the proposed budget increase to project Ethiopia 4929 - Improving education through school feeding (WFP/EB.2/97/7-B/Add.1).

25 March 1997

1997/EB.2/12 Budget increase to a project approved previously, for Executive Board approval - Morocco 2288 (Exp.4)

The Board approved the budget increase to project Morocco 2288 (Exp.4) - School feeding in rural primary schools - second tranche: enrolment of rural girls (WFP/EB.2/97/7-B/Add.2). The Board received the assurance that Expansion 4 will be the final phase.

1997/EB.2/13 Protracted refugee and displaced person project (PRO) for Executive Board approval - Kenya 4961 (Exp.3)

The Board approved project Kenya 4961 (Exp.3) - Food assistance for Somali and Sudanese refugees (WFP/EB.2/97/8/Add.1).

1997/EB.2/14Protracted refugee and displaced person project (PRO) for Executive
Board approval - Mali Regional 5804

The Board approved project Mali Regional 5804 - Food aid for Malian refugees, returnees and conflict-affected persons (WFP/EB.2/97/8/Add.3).

1997/EB.2/15 Protracted refugee and displaced person project (PRO) for Executive Board approval - Sierra Leone 5802

The Board approved project Sierra Leone 5802 - Targeted food assistance and support to resettlement of internally displaced persons in Sierra Leone and of returning Sierra Leonian refugees (WFP/EB.2/97/8/Add.2).

1997/EB.2/16 Progress reports on approved projects

Welcoming the progress report on PRO Nepal 5324 (Exp.1) - Food assistance to Bhutanese refugees in Nepal, the Board recommended that:

a) The findings and recommendations of the joint WFP/UNHCR assessment mission, scheduled for April/May 1997, be reflected in the



project document for Nepal 5324 (Exp.2), to be presented to the Board at its Third Regular Session of 1997.

b) The continuation of the bilateral dialogue between the Governments of Nepal and Bhutan be encouraged, so as to ensure a durable solution to the problem of refugees.

1997/EB.2/17 Summary of the work of the First Regular Session of 1997 of the Executive Board

The Board endorsed the Summary of the Work of the First Regular Session (WFP/EB.1/97/13) and agreed to the inclusion of the following initial sentence in paragraph 6: "Some members of the Board expressed their concern on the delayed submission of the Cost Measurement Study, which impaired their preparation of the agenda item. They welcomed the Secretariat's assistance to prevent such situation in the future."

The Board will be subject to the general authority of the Economic and Social Council and the Council of FAO. 2. It shall, in particular: ensure implementation of the policies formulated by the General (i) Assembly and the FAO Conference and the coordination measures and guidance received from the Economic and Social Council and the Council of FAO; (ii) provide a forum for intergovernmental consultation on national and international food aid programmes and policies; review periodically general trends in food aid requirements and food (iii) aid availabilities, and the implementation of recommendations made on food aid policies; (iv) formulate proposals for improvements in and more effective coordination of multilateral, bilateral and non-governmental food aid policies and programmes, including emergency food aid; and (v) recommend new policy initiatives to the Economic and Social Council and the Council of FAO and, through them, respectively, to the General Assembly and FAO Conference as necessary; (b) The Board shall be responsible for the intergovernmental supervision and direction of the management of WFP. It shall, in particular: receive information from and give direction and guidance to the (i) Executive Director: ensure that the activities and operational strategies of WFP are (ii) consistent with the overall policy guidance set forth by the General Assembly and the FAO Conference, as well as the Economic and Social Council and the Council of FAO; (iii) monitor the performance of WFP, and review the administration and

General Rule VII.1: Responsibilities of the Executive Director for programmes,

The Executive Director shall be responsible for assuring that programmes, projects and other activities to be implemented are sound, carefully planned and directed towards valid objectives, for assuring the mobilization of the necessary technical and administrative skills, and for assessing the ability of recipient countries to carry out these programmes, projects and other activities. The Executive Director shall be responsible for assuring the supply of commodities and acceptable services as agreed. The Executive Director shall make arrangements for the evaluation of country programmes, projects and other activities. The Executive Director shall have the responsibility to seek, in consultation with recipient governments, correction of any inadequacies in the operation of programmes, projects and other activities, and may withdraw assistance in the event essential corrections are not

Each year the Executive Director shall submit to the Board for its consideration and approval an Annual Report and other reports as directed by the Board. These reports shall enable the Board to obtain a comprehensive view of the operational activities of WFP, its resource position, the results of programme and project evaluations, and progress in achieving targets and policies established by the Board. The Annual Report shall, inter alia:

- (a) include statistical and narrative information on: global food aid and issues affecting it: approved activities and their implementation: contributions, commitments and

- 2. Bilateral donors, United Nations agencies and non-governmental organizations may request WFP services for operations which are consistent with the purposes of WFP and which complement WFP's operations.
- 3. Requests for assistance to country programmes or development projects shall indicate that they have a clear relationship with the recipient country's development plans and priorities and include, as appropriate, a significant input of the recipient government's resources. WFP should also be assured that all efforts will be made, as feasible and appropriate, to have the objectives of the programmes and projects pursued once the operations of WFP have been phased out.

4. Requests for assistance or services shall be presented in the form indicated by the Executive Director and in accordance with general rules made pursuant to these General Regulations.

General Rule X.2: Country Programmes for development assistance

- (a) Within the framework of the Strategic and Financial Plan, the Executive Director shall submit to the Board for review and approval multi-year country programmes to be undertaken by WFP that are integrated with the development plans and priorities of the recipient countries.
- (b) To facilitate the preparation of a Country Programme, WFP shall develop, in consultation with the government and with the collaboration of the United Nations, FAO and other relevant organizations a Country Strategy Outline (CSO). The CSO should establish clear linkages with the Country Strategy Note or with activities of the United Nations system as a whole, as appropriate, including wherever possible, joint programming.
- (c) The Executive Director shall seek the advice of the Board on Country Strategy Outlines and its approval for Country Programmes.
- (*d*) Approval by the Board of a Country Programme shall constitute a delegation to the Executive Director to approve projects and activities within that Country Programme as set out in the Appendix to these General Rules.

General Rule X.3: Provision of information by recipient countries

Recipient countries should, as far as feasible, provide the Executive Director with any relevant information on other aid programmes that would assist WFP in coordinating its activities with such other programmes. When this is not possible, the donor countries or organizations may supply the relevant information.

General Rule X.4: Additional external technical or financial assistance

The recipient country shall be responsible for obtaining and arranging any additional external technical or financial assistance as may be available from multilateral and other sources. Before accepting a programme or project which requires such additional assistance to make them feasible, the Executive Director shall obtain assurance that such assistance is available.

General Rule X.5: Requests for assistance

Requests for assistance under Articles IX and X of the General Regulations should contain

- 5. In examining such requests and in formulating proposals thereon the Executive Director shall consult closely with the United Nations, FAO and other relevant agencies.
- 6. Decisions on requests shall be made in accordance with the powers and functions of the Board, including any delegation of authority made by the Board to the Executive Director. Decisions on requests for assistance to meet emergency needs which exceed the level of authority delegated to the Executive Director shall be made jointly by the Executive Director and the Director-General.

ARTICLE XI: ASSISTANCE AGREEMENTS

1. Upon approval by the Board or by the Executive Director on its behalf, of a request for a food aid programme or project, or for technical assistance to help

the basic information relating thereto.

General Rule X.6: Appraisal of requests

The Executive Director shall, upon receipt of requests, proceed to appraise them, and in doing so, seek to maximize the use of local and regional expertise and consult with and seek advice and cooperation from the United Nations, FAO and, as appropriate, other United Nations agencies and operating programmes, bilateral assistance programmes, and other relevant organizations according to their respective fields of competence.

General Rule X.7: Approval of requests

- (a) Proposals for development projects and projects for protracted relief operations shall be presented by the Executive Director to the Board for approval, except that the Executive Director may decide upon requests for projects within the limits of the Executive Director's delegated authority.
- (b) Requests for emergency assistance shall be approved in accordance with General Regulation X.6.

General Rule X.8: Availability of resources

The Executive Director shall ensure that development projects submitted to the Board for approval, and development projects and Country Programme activities approved under the Executive Director's delegated authority, can be implemented within estimated available resources. Resource availability shall take into account pledges and contributions expected for the current financial period, as well as resources which can reasonably be expected to be contributed during the two subsequent financial periods including resources which could be made available by the recipient government itself or by bilateral donors.

General Rule XI.1: Matters to be included in food aid programme and project agreements

In addition to other terms and conditions upon which the proposed activities are to be carried out in connection with an approved programme or project, the agreements shall indicate aid

a government establish or improve its own food assistance programme, an agreement shall be prepared by the Executive Director in consultation with the government concerned. All such agreements shall indicate the terms and conditions on which the proposed activities are to be carried out and the responsibilities of the government of the recipient country.

- 2. Upon approval of a request for emergency or protracted relief food aid, an agreement, which may be in the form of an exchange of letters, may be concluded forthwith between the Executive Director and the government of the recipient country and/or intergovernmental or non-governmental bodies concerned.
- 3. Upon approval of a request for services to bilateral donors, United Nations agencies and non-governmental organizations, the Executive Director may enter into an agreement with the government, or intergovernmental and/or non-governmental body concerned, specifying the services to be provided and the terms and conditions on which the proposed services are to be carried out.
- 4. Assistance agreements shall be signed by the Executive Director, or the Executive Director's representative, on behalf of WFP.

to be provided by other agencies or institutions, the terms of delivery of commodities, the obligations of the government with respect to the utilization of the commodities supplied. including the use and control of any local currencies generated from their sale, and with respect to the arrangements made for their storage, internal transportation and distribution: the responsibility of the government for all expenses incurred from the point of delivery, including the cost of import duties, taxes, levies, dues and wharfage; and such other relevant terms and conditions as may be mutually agreed upon as necessary for the execution and subsequent evaluation of the programme or project. Such agreements shall safeguard WFP's right to monitor all phases of programme and project operations from the receipt of commodities in the country to final utilization; provide for audits as necessary; and allow WFP to suspend or withdraw assistance in case of serious non-compliance. They shall also provide for the collection of data on the food distribution and its effects on the improvement of the nutritional status of the beneficiaries and the economic and social development of the country on a longer-term basis; for the maintenance of complete records, including transport and storage documents, concerning the utilization of assistance from WFP; and for the communication of such records to WFP upon request.

General Rule XI.2: Duration of agreements

Agreements may provide for programmes or projects under which assistance from WFP would be available for a maximum period of five years, provided that such agreements also carry the qualification that their full execution is conditional upon resources becoming available.

ARTICLE XII: IMPLEMENTATION

1. The primary responsibility for the execution of programmes, projects and activities shall rest with the recipient country, in accordance with the provisions of the relevant agreements and general rules made pursuant to these General Regulations. The Executive Director shall, however, be responsible for supervision and assistance in execution, and shall take the necessary measures for this purpose.

General Rule XII.1: Monitoring of operations by WFP personnel

As agreements are carried into effect, recipient governments shall give full cooperation to enable authorized personnel of WFP to monitor operations, to ascertain their effects, and to carry out evaluations and other missions to assess the results and impact of the programmes and projects. Any final report that shall be submitted to the Board should be shared with the recipient countries concerned for their comments prior to submission.



APPENDIX B TO THE GENERAL REGULATIONS

The distribution of seats of the Executive Board shall be as follows:¹

- (*i*) Nine members from the States included in list A, five members to be elected by the Economic and Social Council and four by the Council of FAO;
- Seven members from the States included in list B, four members to be elected by the Economic and Social Council and three by the Council of FAO;
- (iii) Five members from the States included in list C, two members to be elected by the Economic and Social Council and three by the Council of FAO;
- *(iv)* Twelve members from the States included in list D, six members to be elected by the Economic and Social Council and six by the Council of FAO;
- (v) Two members from the States included in list E, one member to be elected by the Economic and Social Council and one by the Council of FAO;
- (vi) One additional member alternating between the States included in lists B and C, starting with list C, to be elected by the Council of FAO.


¹ By its resolution 50/8 of 1 November 1995, the General Assembly recorded the understanding that this distribution of seats created no precedent for the composition of other United Nations bodies of a limited membership and that it should be reviewed within two years after the establishment of the Executive Board with a view to achieving its final outcome in accordance with paragraphs 25 and 30 and other relevant provisions of General Assembly resolution 48/162; the review being conducted in parallel by the Assembly and the Conference of the Food and Agriculture Organization of the United Nations, taking into account the relevant inputs of the Economic and Social Council and the Council of the Food and Agriculture Organization of the United Nations; and the results entering into force on 1 January 2000. In the event of a change in this distribution by the General Assembly and the FAO Conference the necessary changes will be made in this appendix by the WFP Secretariat.
