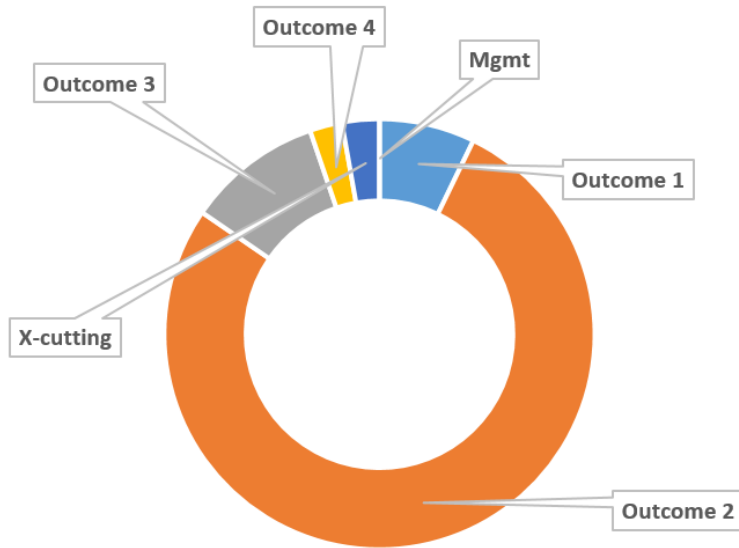

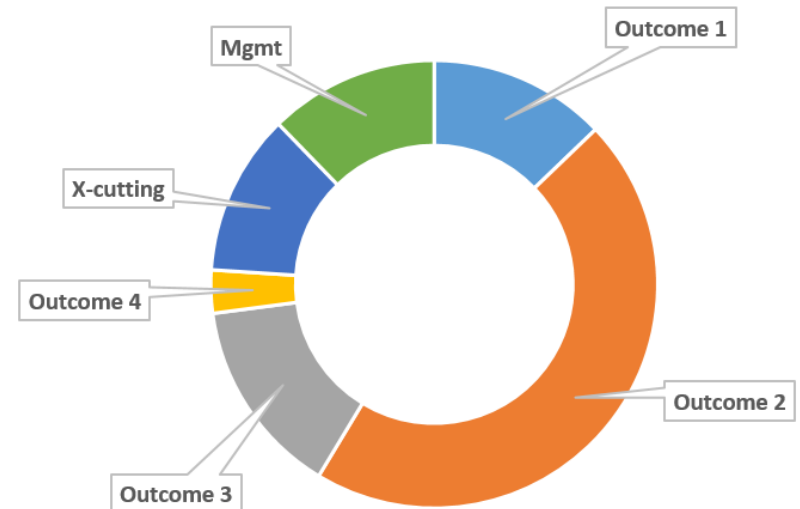

2017 OEV Financial & Human Resources by Outcome

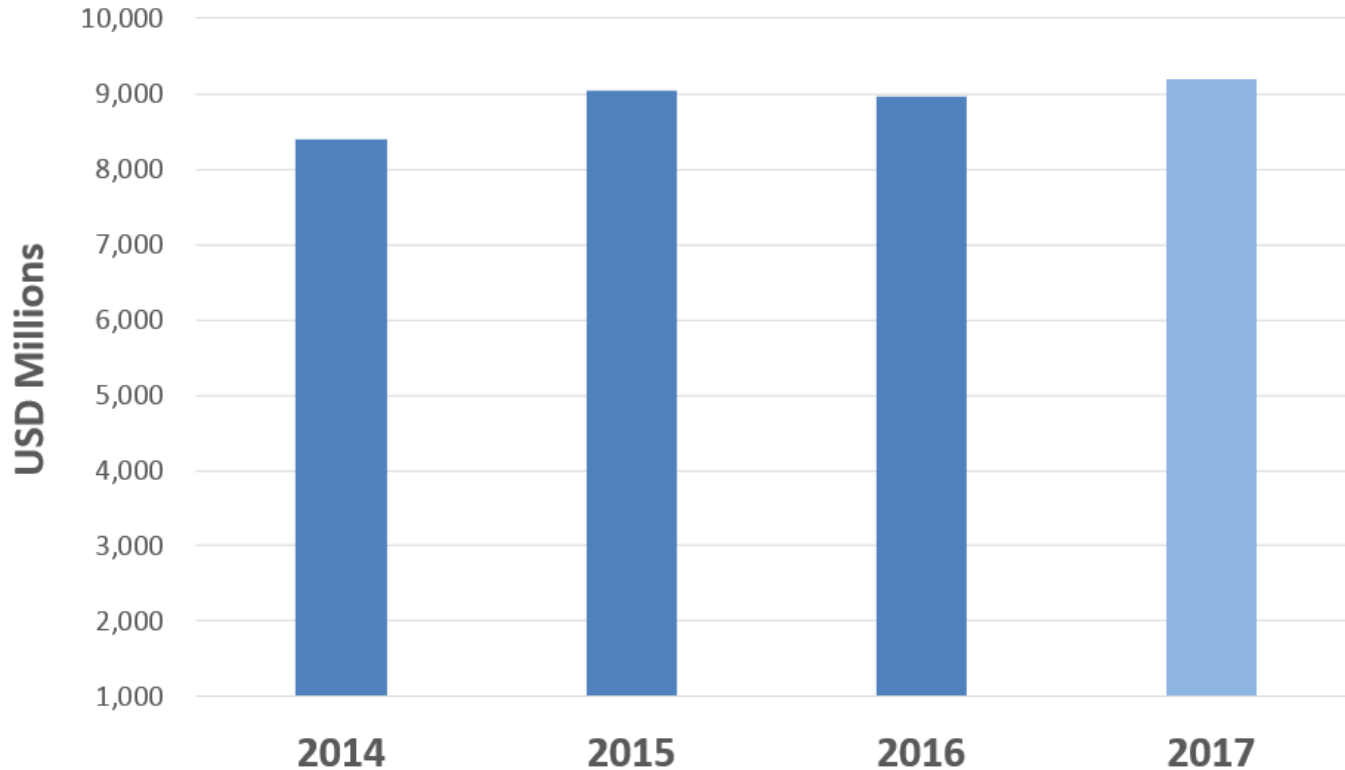


O1: Independent, credible & useful CEs & DEs
O2: Appropriate CE & DE coverage

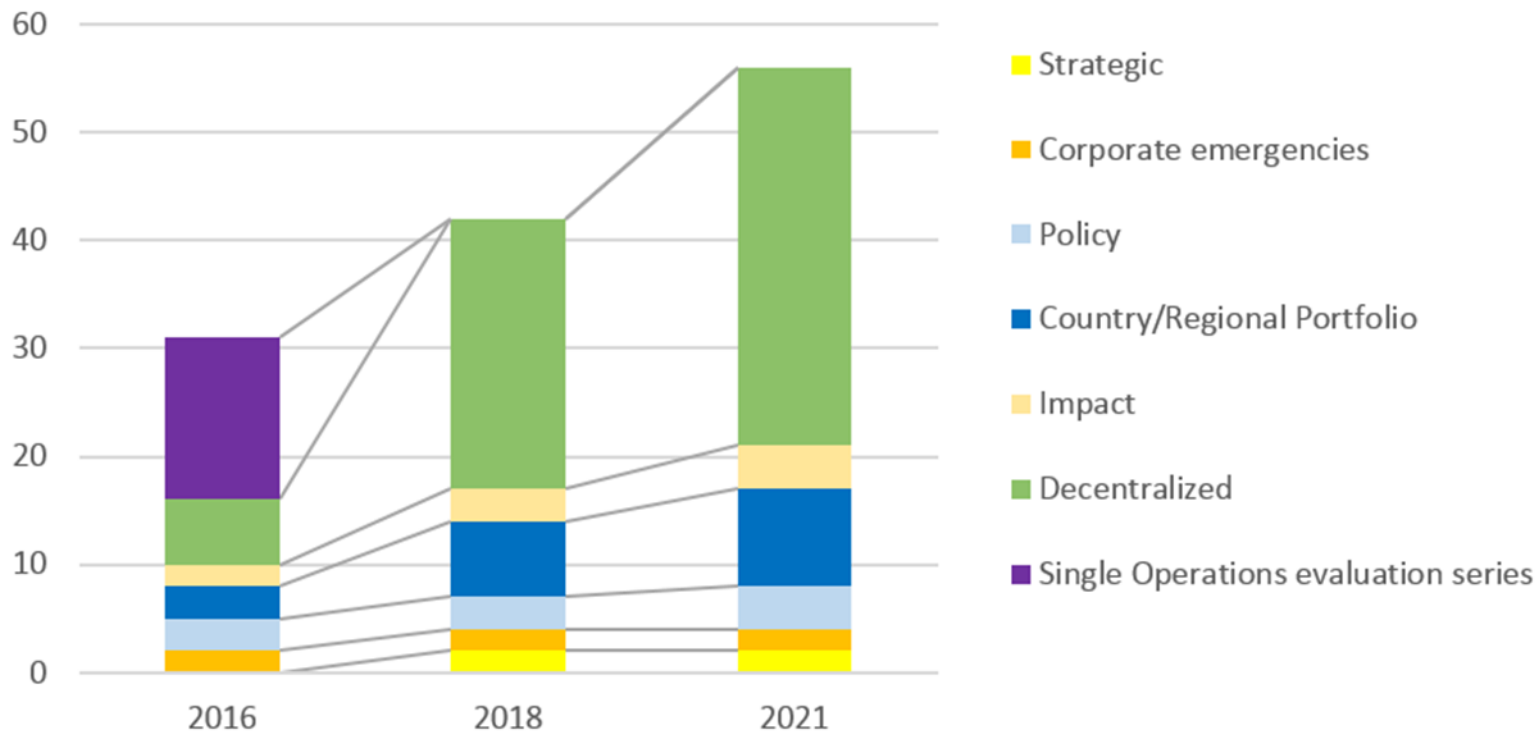
