1. Making reference to the draft full country strategic plan (CSP) for the Congo for the period 2019–2023, this short-term interim country strategic plan (ICSP) consists of activities that continue WFP's current projects in the country. It seeks the Executive Board's approval by vote by correspondence of the implementation of such activities during the period from January to March 2019 pending the Board's approval of the CSP at its 2019 first regular session. This early start is necessary to provide operational continuity until the Executive Board's approval of the CSP.

- 2. To ensure adequate governance and oversight, all strategic outcomes and activities under the short-term ICSP are based on previously approved projects and ongoing activities. The short-term ICSP will include no strategic outcomes or activities that do not stem from existing projects, and such outcomes and activities will be implemented only under the CSP after its approval by the Executive Board. Once approved, the CSP will supersede this short-term ICSP.
- 3. Under the short-term ICSP WFP will assist the Government of the Congo and partners in working towards the following three strategic outcomes through four activities:
  - ➤ **Strategic outcome 1:** Food-insecure people affected by shocks have access to adequate food all year round (Sustainable Development Goal (SDG) target 2.1).

Focus area: Crisis response

# Key activity:

- Activity 1. Provide unconditional and/or conditional food and nutrition assistance to people affected by shocks.
- > Strategic outcome 2: Equitable national social protection interventions effectively target vulnerable populations, including school-age children, with sustained access to safe and nutritious food (SDG target 2.1).

Focus area: Root causes

#### Key activities:

- Activity 2. Provide safe, adequate and nutritious school meals to targeted schoolchildren.
- Activity 3. Provide technical support to the Government for improved implementation of shock-responsive social protection interventions.
- > Strategic Outcome 3: Targeted smallholder farmers and communities benefit from productive and sustainable livelihoods that support nutrition value chains (SDG target 2.3).

Focus area: Resilience building

#### Key activity:

- Activity 4. Provide smallholder farmers with analytical and technical support and equipment aimed at encouraging market-oriented and climate-resilient production and livelihoods.
- 4. One additional activity under strategic outcome 4<sup>1</sup> (in the crisis response focus area) will not be implemented once the CSP is approved and is therefore not part of the short-term ICSP.

<sup>1</sup> Strategic outcome 4 – humanitarian and development actors and national systems have access to WFP expertise and services; activity 5 – provide on-demand supply chain services for partners.

5. WFP will reach beneficiaries under the short-term ICSP as summarized in table 1.
