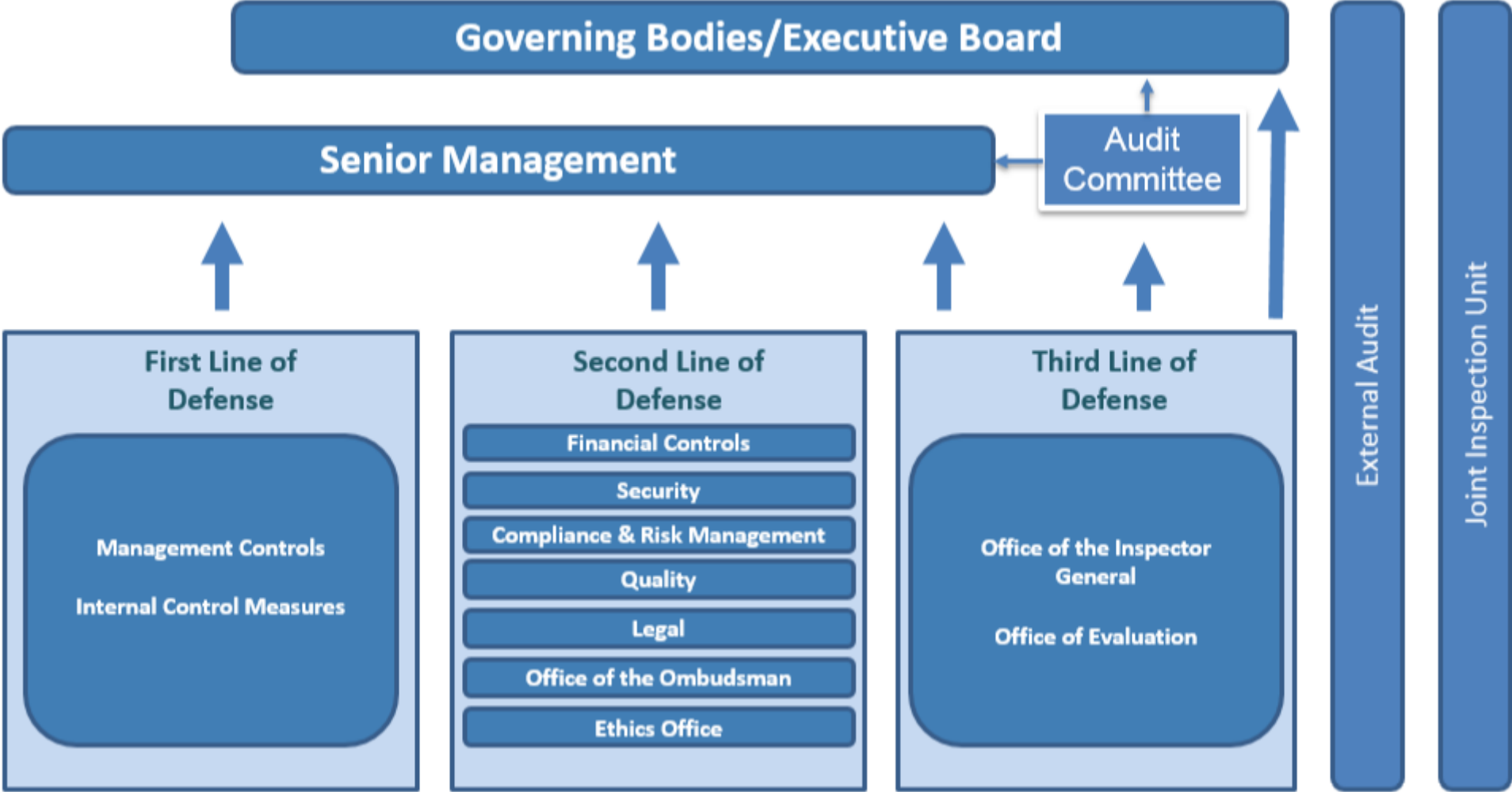

WFP's Three Lines of Defense model

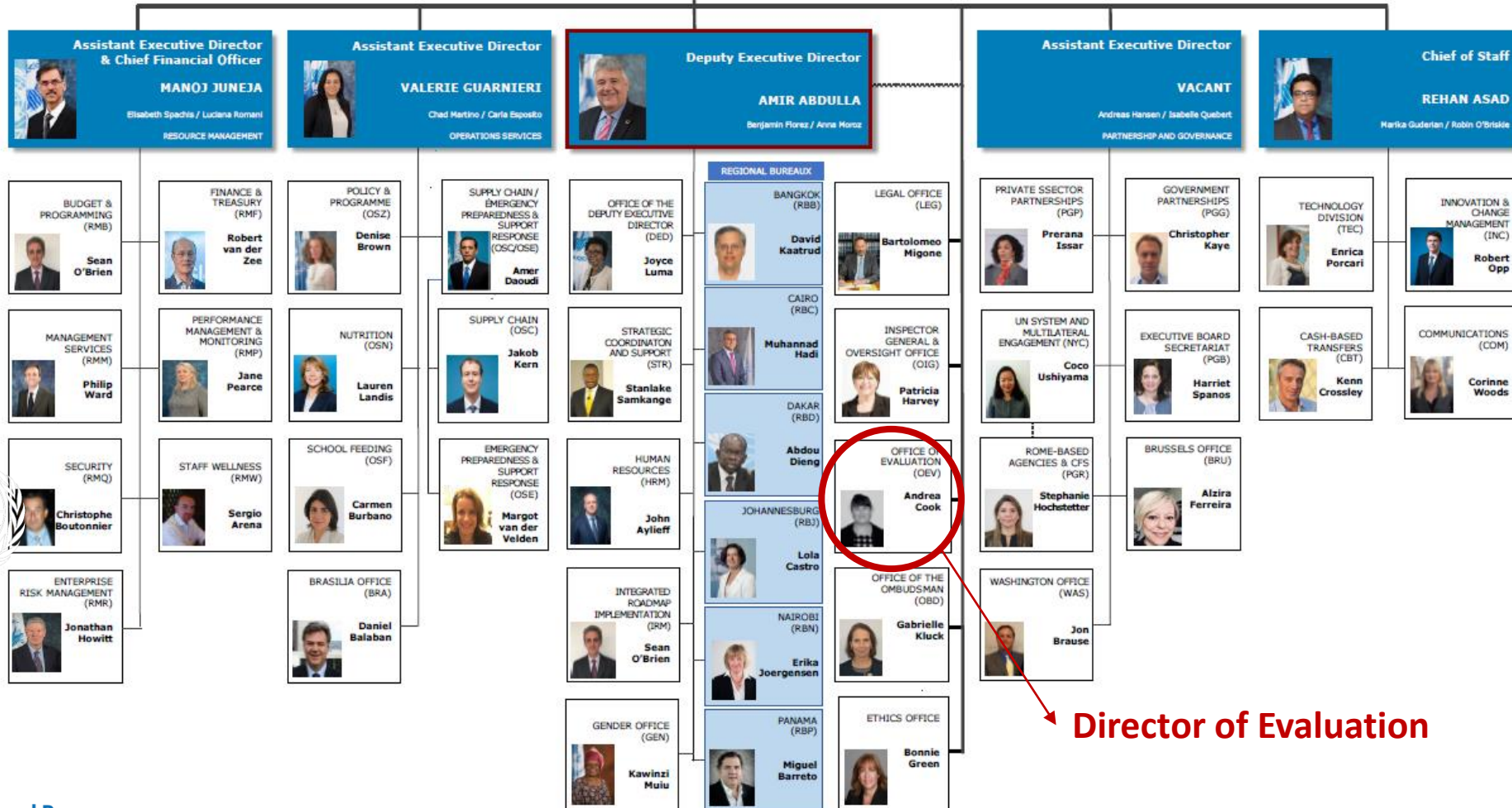


WFP Organizational Structure

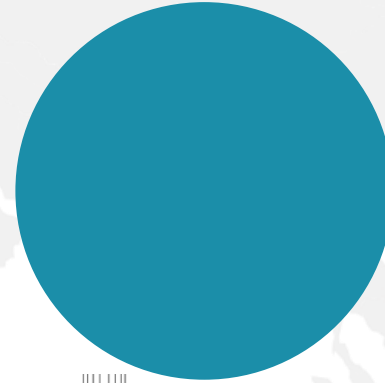

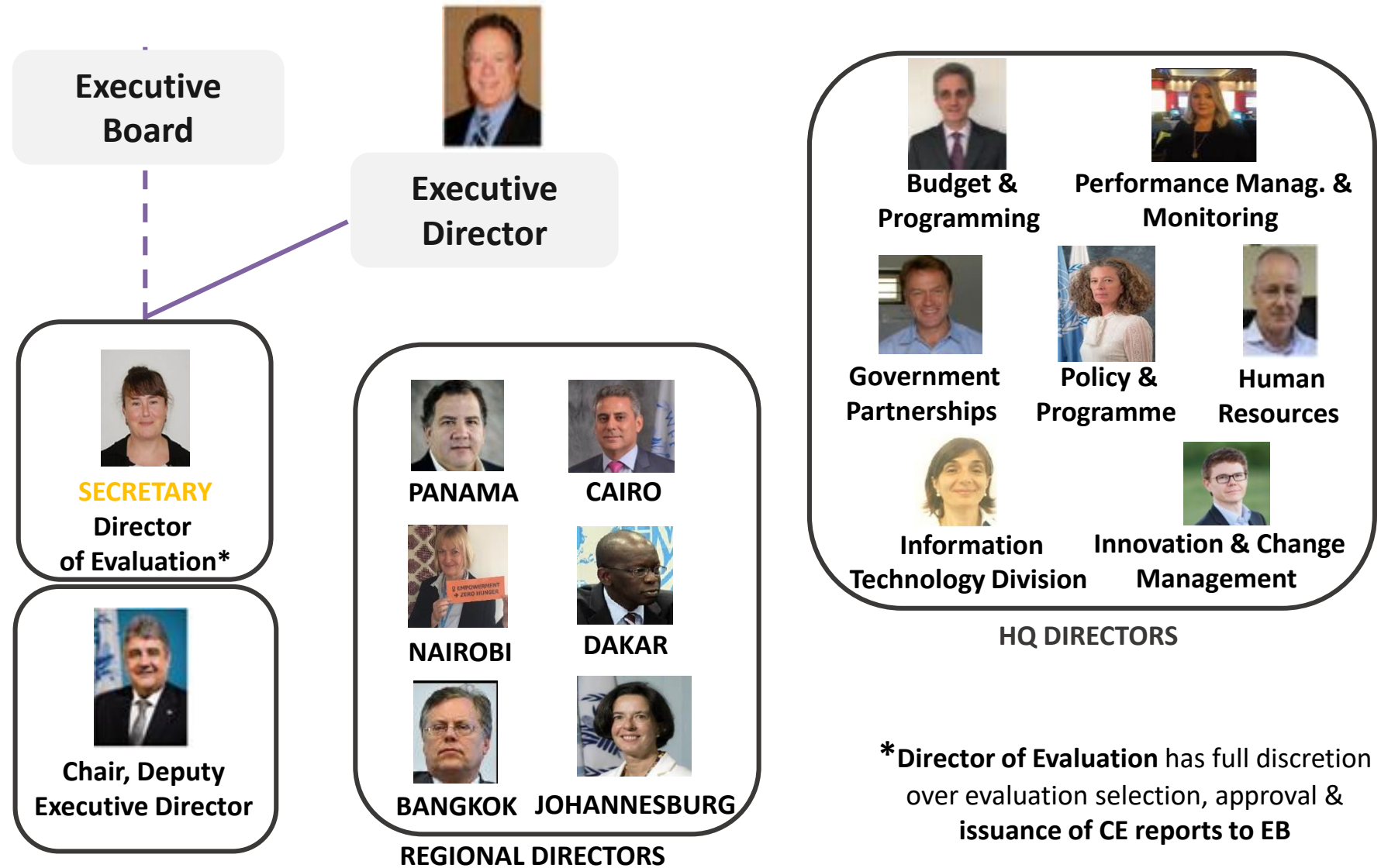

WFP Evaluation Function oversight: Executive Board Role in evaluation

Oversight

- Exercise oversight of evaluation function
- Guide management in policy implementation
- Consider AER & all centralized evaluation reports
- Consider management responses & follow-up action reports

Normative Framework

- Approve evaluation policy and safeguard provisions
- Approve appointment, made by the ED, of Director of Evaluation
- Provide strategic guidance through Annual Consultation on Evaluation
- Foster evaluation culture as members of WFP Governing Body

Resourcing

- Approve OEV's budget
- Review trends in human & financial resources dedicated to evaluation

Planning

- Review OEV's work plan & priorities within WFP's Management Plan

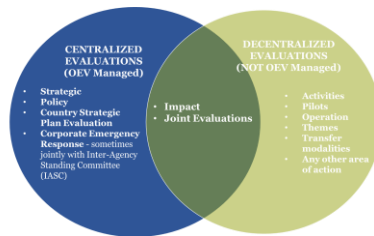
Use
