<sup>\*</sup> As agreed with the Bureau, the Director of Evaluation will provide an overarching presentation on the evaluations of CSPs (CSPEs) for countries in the Latin America and the Pacific regions, focusing on systemic issues and highlighting elements of interest for each CSPE. There will be no individual presentations on the evaluations of the CSPs covered by the overarching presentations. Neither will there be, in the case of countries for which new CSPs will be presented at the current session, separate presentations on the management responses to the recommendations in the CSPEs covered by the overarching presentations; such management responses will instead be covered by the presentations on the new CSPs. CSPEs and management responses for countries for which no new CSP is on the agenda will be presented separately.
