





## MEETING OF THE FAO COUNCIL, IFAD EXECUTIVE BOARD AND WFP EXECUTIVE BOARD Friday, 14 February IFAD Headquarters, Rome

## NOTE

- Background: Within the context of the United Nations efforts to promote a more effective and efficient United Nations system, the ongoing collaboration between the Rome-based agencies (RBAs) – the Food and Agriculture Organization of the United Nations (FAO), the International Fund for Agricultural Development (IFAD) and the World Food Programme (WFP) – is of particular significance in achieving the objectives of the 2030 Agenda and the Sustainable Development Goals (SDGs). This is because, inter alia, the RBAs' complementary mandates and areas of expertise in the food and agriculture sector are at the core of achieving the SDGs, in particular SDGs 1 and 2.
- 2. **Objectives**: Against this backdrop, Member States' representatives called upon the three RBAs to organize a joint informal meeting of the FAO Council and the Executive Boards of IFAD and WFP. The broad aim was to exchange insights on RBA collaboration and discuss issues of common concern to the three organizations across Memberships and with the principals of the RBAs.
- 3. **Past meetings:** The First Joint Informal Meeting took place at FAO headquarters in September 2017, and the second was hosted by IFAD. These meetings were appreciated by both the Member States and the Management of the RBAs. It was agreed that further such meetings would be held on an annual basis. It was also agreed that such events should be hosted on a rotational basis by the RBAs and chaired by the Chair/President of the respective Council/Executive Boards.
- 4. **Host, chair, date and venue of the 2025 meeting:** IFAD will host the Eighth Joint Informal Meeting on Friday, 14 February, at IFAD headquarters. Building on the feedback of Member States at the seventh joint meeting and from subsequent conversations and consultations, the eighth joint meeting will be a half-day event focused on strategic topics and interactive dialogue across the three governing bodies, the respective Memberships and Management, and with the principals of the RBAs. While past joint meetings were generally held in the latter part of the year, the Eighth Joint Informal Meeting has purposefully been scheduled in early 2025 to allow Membership and Management to have strategic discussions with a forward-looking focus.
- 5. The **Chairperson of the IFAD Executive Board and President of IFAD** will chair the overall meeting, while specific segments will be chaired by the **Independent Chairperson of the FAO Council** and the **President of the WFP Executive Board**. The interactive segments will involve active discussions with the Membership and Management of the RBAs.

- 6. **Structure and topics for the meeting:** The proposed agenda aims to provide space for informal interaction among participants. Two priority items for discussion have emerged from feedback, conversations and consultations with Member States, the governing body Chairs/Presidents and Management for 2025: first, to focus on the RBAs and the humanitarian-development-peace (HDP) nexus, and second, to provide an opportunity for reflections on how the RBAs can accelerate the achievement of the 2030 Agenda in the current global context through initiatives such as the G20 Global Alliance Against Hunger and Poverty.
- 7. The President of the Executive Board of WFP will moderate and chair the segment on the RBAs and the HDP. The segment will begin with a moderated panel of Member States and RBA representatives, followed by interactive discussions with the floor.
- 8. The Independent Chairperson of the FAO Council will moderate and chair the segment on reflections on how the RBAs can accelerate the achievement of the 2030 Agenda in the current global context. The segment will open with a briefing on the Global Alliance Against Hunger and Poverty by the 2024 and 2025 G20 Presidencies. This will be followed by an interactive discission with the floor, including reflections by the RBAs.
- 9. The 2024 RBA Award of Excellence will be presented jointly by the Director-General of FAO, the President of IFAD and the Executive Director of WFP on Thursday, 13 February, at the forty-eighth session of the IFAD Governing Council.
