For indicators measuring direct beneficiaries reached and transfers given to them to improve their food security and nutrition status (most Category A and B output indicators), planned or target values are typically based on assessed needs, while the planned or target values for other indicators are based on the ability to implement the assessed needs within the forecast resources.
 - d) 2024 actual: the aggregated actual value.
 - e) Performance: percentage of the target achieved.
 - f) Improvement or stability rate: percentage of measurements that improved or were stable compared with their baseline.
 - g) Achievement rate: percentage of measurements that met or exceeded their target.
