1. The findings and recommendations of the Impact Evaluation of WFP Support to School Feeding in Côte d'Ivoire were discussed on 17 May during the round table discussion on evaluation reports submitted to EB.A/2011.
2. The recommendations are well received by WFP management and significant lessons drawn from the findings. However, due to the prevailing situation since December 2010 following the outbreak of post-election violence, full engagement with the counterparts to take forward and implement the recommended actions is not feasible at this time.
3. Management recognizes both the challenges and opportunities of the new political situation in Côte d'Ivoire and will engage in building partnerships with the new authorities as soon as the situation allows, with the aim of developing a new school feeding programme for Côte d'Ivoire. The findings and recommendations of this impact evaluation will provide a foundation for such a programme.
4. The Secretariat suggests that the discussion on the evaluation be deferred to a later date and considered in conjunction with the new school feeding programme, which is expected to be presented to the First Regular Session of 2012.
