### **BACKGROUND**

1. This document presents the Secretariat's detailed response to the recommendations of the evaluation of protracted relief and recovery operation (PRRO) 103881 in Timor-Leste.

- 2. The Secretariat takes note of the evaluation recommendations and will take action to ensure sustainable funding and improved government capacity to manage food assistance programmes.
- 3. The Secretariat advocates joint resourcing by the Government and donors and actions to enhance the Government's capacity to manage the programmes after hand-over.

1.	Continue to advocate with donors and the Government for funding for PRRO 103881: current resources are insufficient for completion and the Government is not yet able to take responsibility for food security.	Country office	Agreed. WFP has proposed a joint resourcing model for 2010–2013 to the Government and donors that involves greater government responsibility for funding, with donors contributing less in proportion. At the end of 2013, all responsibilities will be assumed by the Government.  Meetings are taking place with government officials at the highest	June 2010

2.	Continue WFP's presence with a further PRRO that focuses on enhancing government capacity development to manage food security and nutrition, and consider ways of supporting the Government in food security issues in the long term; some form of funding to support capacity development should be provided; pending improved capacity, food-based programmes should continue.	Country office	Agreed. A new two- or three-year PRRO will be designed in May/June 2010. The types of food-based activities will depend on the outcome of the discussions on the proposed joint resourcing model. The main component will be a strong government capacity enhancement programme that will include continued assistance for the Government in establishing a food security monitoring and response system; separate funding will be required for this. 3.	Improve the supply chain by: i) developing warehouses at extended delivery point (EDP) sub-offices; ii) pre-arranged deliveries to final delivery points (FDPs); iii) better storage at schools and MCHN centres; iv) abandonment of alternative distribution points (ADPs); and v) direct contracting of Oecussi transporters.	Country office	Partly agreed: i) new EDPs were identified for the Maliana and Baucau sub-offices; rehabilitation of stores at EDPs was not possible because of insufficient funding; ii) and iii) improved storage at FDPs is considered for funding under the current logistics Special Operation (SO) 10797; iv) the ADP option is kept to a mínimum; v) a transporter based in Oecussi was contracted in September 2009.
