#### **Antoine ANTOUN**

#### Nationalities: Lebanese and French

#### Languages (written and spoken): French, English and Arabic

#### **Professional Experience**

I am currently working as an independent management consultant. I am an advisor to various companies in France and abroad. In January 2008, I was appointed as a member of the Standing Committee of the International Centre for Expertise of the ICC (International Chamber of Commerce). From 2006 to 2008, I acted as chairman of the audit committee of TGP (Transportation de Gas del Peru), in Lima – Peru.

#### **Experience with Ernst & Young**

Previously, I was the Chief Executive Officer (CEO) of Ernst & Young Continental Western European Area until December 2003.

I joined Ernst & Young in 1977 as Managing Partner of the Management Consulting Practice. In 1997, I was appointed Managing Partner of the French firm (audit, tax, legal, and consulting), and in 2000, CEO of Ernst & Young Continental Western European Area, which includes France, Belgium, Italy, Spain, Portugal, Greece plus 20 other countries.

During my career with Ernst & Young and apart from my managerial responsibilities, I have been in charge of numerous audit and consulting projects.

I was also a member of the Ernst & Young International Energy Committee whose role was to develop an approach and a methodology tailored to the Energy sector and to strengthen relations between Ernst & Young and the major players in the sector, in particular petroleum companies.

I was also involved in numerous international arbitrations as an expert, such as:

-arbitration between an international oil company and an engineering company about a claim (more than 500 million US dollars) for cost overruns presented by the engineering company. I assisted the oil company and its international lawyers in the arbitration process including participating in the hearings.

-arbitration between an African government and two international oil companies about a claim related to the interpretation of a production sharing contract (PSC). I assisted the African Government and its international lawyers in the arbitration process.

#### **Experience with the UNCC**

In 1995, I was appointed by the United Nations Security Council as a Commissioner sitting on a three-member panel, within the United Nations Compensation Commission (UNCC), established in accordance with United Nations Security Council resolution 692 of 20 May 1991. The UNCC was established to pay compensation for losses and damages suffered by individuals, corporations and governments as a direct result of the Kuwait-Iraq conflict. My panel was in charge of oil sector claims (amounting to more than 100 billions US dollars). Our work was to examine and report our recommendations on these claims. We concluded our work in 2003.



#### **Prior Experience**

I began my professional career with an audit firm in Beirut (Russell & Co).

In 1968, while I was working for Arthur Andersen in Beirut, I took part in a project on behalf of Sonatrach, the Algerian petroleum company, to assist them in the development of the first accounting procedure that they negotiated with an international petroleum group (Elf). This accounting procedure has subsequently provided a general framework for other contracts in Algeria and other countries.

From 1971 to 1976 I was a full-time consultant for Sonatrach in Algiers where I took part in the creation and development of the Audit and Systems Department, the purpose of which was to define and implement the audit policy of Sonatrach, as well as developing and implementing management information systems.
