

Between 1 January and 30 June 2008, the Executive Director authorized within her delegated authority 38 budgetary increases to approved development activities. The total food value of these increases was US\$53,103,327; the total cost to WFP was US\$84,229,337. Budget figures and reasons for each increase are shown in the attached tables.
