

- 1. At its Third Regular Session of 2001, the Board asked to be regularly informed about emergency operations (EMOPs) approved either jointly by the Executive Director (ED) and the Director-General (DG) of the Food and Agriculture Organization of the United Nations (FAO) or under the delegated authority of the Executive Director. Since the Board's Second Regular Session of 2002 this information has been provided twice a year.
- 2. This report covers EMOPs approved between 1 January and 30 June 2008.
- 3. All EMOPs approved in the first semester of 2008 are shown in the attached tables. Table A lists those projects with a food commitment value of more than US\$3 million approved jointly by the Executive Director and the Director-General of FAO. Table B lists those with a food value of less than US\$3 million approved by the Senior Deputy Executive Director (DED) under the delegated authority of the Executive Director. Table C lists EMOPs with an individual value of less than US\$500,000 approved by Regional Directors (RDs) or country directors (CDs) under the authority delegated to them by the Executive Director.
- 4. During the period under review, eight EMOPs were approved: two by the Executive Director and the Director-General of FAO; two under the delegated authority of the Senior Deputy Executive Director; one by a Regional Director and three by country directors. These operations represent a commitment of 107,633 mt of food to assist 2.9 million people at a food cost of US\$70.5 million; total costs to WFP were US\$117.6 million.

EMOPS APPROVED JOINTLY BY THE EXECUTIVE DIRECTOR AND THE DIRECTOR-GENERAL OF FAO

- 5. Philippines EMOP 10489.1 started in June 2008 and is scheduled to end in May 2009, covering the needs of 1.6 million beneficiaries at a cost to WFP of US\$25.1 million. The EMOP's objective is to continue food assistance previously provided by EMOP 10489.0 to targeted vulnerable groups affected by the conflict in the region of Mindanao.
- 6. Myanmar EMOP 10749.0 is WFP's response to the deadly effects of Cyclone Nargis, which struck the coast of the country on 2 and 3 May 2008. The operation, which started in May 2008 and is scheduled to end in April 2009, supports 924,000 beneficiaries, at a cost to WFP of US\$69.5 million.

EMOPS APPROVED BY THE SENIOR DEPUTY EXECUTIVE DIRECTOR

- 7. Cameroon EMOP 10735.0 provides emergency food assistance to 85,000 refugees originating from both Chad and the Central African Republic for the period April 2008 to March 2009. The total WFP cost of the operation is US\$18.3 million.
- 8. EMOP 10742.0 in Ecuador aims to assist 30,100 victims of heavy rain and floods in the coastal areas of the country. The operation started in June 2008 and will end in December 2008. Total cost to WFP is US\$3.2 million.



IMMEDIATE-RESPONSE EMOPS APPROVED BY REGIONAL DIRECTORS OR COUNTRY DIRECTORS

- 9. Ecuador IR-EMOP 10738.0 was the immediate response of WFP to the torrential rains and subsequent floods in the coastal areas of Ecuador; it started in March 2008 and closed in May 2008. WFP supported 100,000 beneficiaries by providing high-energy biscuits, which were incorporated into food rations distributed by the Government. WFP also provided technical cooperation for emergency assessment, warehousing and local purchases. The total cost to WFP was US\$480,000.
- 10. Cameroon IR-EMOP 10729.0 was launched in response to fighting between Chadian rebels and government troops, which led to most United Nations staff being evacuated and left hundreds of thousands of refugees in need of assistance. The operation started in February and ended in April 2008, assisting 50,000 beneficiaries at a total cost to WFP of US\$500,000.
- 11. Myanmar IR-EMOP 10748.0 addressed the immediate needs of 40,000 beneficiaries affected by Cyclone Nargis at the beginning of May 2008. The operation started in May and ended in June 2008, at a total cost to WFP of US\$500,000.
- 12. China IR-EMOP 10753.0 was WFP's response to the devastating earthquake that struck Wenchuan County in the Sichuan Province of China. WFP procured 55 mt of instant noodles to complement the emergency food ration distributed with the Government and other partners to 100,000 victims of the earthquake. Total cost of the operation to WFP was US\$100,000.
