

Between 1 January and 30 June 2005, the Executive Director authorized 41 budgetary increases within his delegated authority for approved projects. The total food value of these increases amounted to US\$65.2 million; the total cost to WFP was US\$119.5 million. Detailed budget figures and reasons for each increase are given overleaf.
