## **BIENNIAL PROGRAMME OF WORK OF THE EXECUTIVE BOARD 2006–2007**

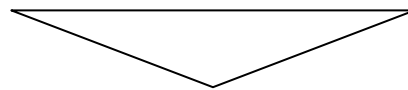

1. At its Annual and Third Regular sessions of 2000, the Executive Board approved several recommendations for strengthening the governance of the World Food Programme. Among others, the Board made the decision that “strategic planning of the Board business should be undertaken by the Board itself. Each October the Board should review its programme of work for the forthcoming biennium and look back on its operations over the previous 12 months.”<sup>1</sup>
2. When reviewing the Biennial Programme of Work the Board should:
  - decide which matter should be the subject of preliminary discussions or informal consultations;
  - consider the case for a symposium on food aid and;
  - look back at its work over the previous 12 months and draw out any lesson that will improve its function in the future. In that regard, Board members are expected to assess the impact of the document size limitation and implemented at the Annual session of 2004.
3. Through the same Governance recommendation<sup>2</sup>, the Board requested that items for information should not be discussed unless a Board member specifically requests it and the President accepts the request on the grounds that it is a proper use of the Board’s time.
4. The attached Biennial Programme of Work which is presented in two different formats, a summary and an annotated version, is in conformity with Board decision 2004/EB.A/10 by which Board sessions are reduced from four to three.
5. Also attached is the draft FAO/IFAD/WFP Calendar of Governing and Other Bodies, 2006-2007, prepared by the three organizations in an effort to harmonize their calendars of meetings. The dates of meetings of each organization are subject to the approval of those organizations’ respective governing bodies.

## ANNOTATED BIENNIAL PROGRAMME OF WORK OF THE EXECUTIVE BOARD (2006–2007)

(classified by subject and session)

### POLICY ISSUES

#### EB.1/2006 (20–24 February)

➤ *Food for Training (A/C)*

This paper, for consideration, examines lessons learned from experience, including implementation of the commitment to ensure that women and adolescent girls constitute at least 70 percent of the participants in food-assisted training activities, articulated in the Gender Policy approved by the Board at its Third Regular Session of 2002.

➤ *Humanitarian Access (C)*

This paper informs the Board of processes that clarify WFP's approach, in collaboration with its United Nations partners, to securing safe and unhindered access to people affected by emergencies, and to seeking guidance where needed. The paper is prepared in response to the Board's request, in its discussion of the first "Consolidated Framework of WFP Policies" at its 2002 Annual Session, that the Secretariat present proposals for policy topics to be discussed at future sessions, with particular focus on topics related to emergencies.

➤ *Targeting in Emergencies (A/C)*

This paper reviews and assesses WFP's targeting policies and practices, updates the Board on the latest trends in this area and identifies issues or areas upon which the Board might wish to focus particular attention. The paper would be for approval or consideration, depending on whether or not the conclusions of the paper require Board approval of any specific policy changes in the "Consolidated Framework of WFP Policies".

➤ *Food Aid Sources (C)*

This paper, for consideration, reviews trends in the availability and sources of food aid, and the implications of those trends for WFP.

➤ *Annual Report to ECOSOC and the FAO Council (A)*

The Annual Report to the Economic and Social Council (of the United Nations) (ECOSOC) and the Food and Agriculture Organization of the United Nations (FAO) Council is presented at the First Regular Session every year in accordance with the Board's 2004 decision on streamlining corporate reporting to the Board and WFP parent bodies (WFP/EB.A/2004/5-F). The report provides a comprehensive picture of WFP's engagement in United Nations system-wide activities, organized according to the common format for United Nations funds and programme reports to ECOSOC and taking into account the comments expressed by the WFP Board on the desired content of the report. This report is presented to the Board for approval.

➤ *Food Procurement in Developing Countries (C)*

This paper, for consideration, clarifies WFP's procurement of food commodities and its potential for making a positive contribution in developing countries.

➤ *Engagement in Poverty Reduction Strategies (C)*

The paper considers the experience with and options for active WFP engagement with Poverty Reduction Strategies, based on its comparative advantages. It places participation within the context of the ongoing reform of the United Nations system towards joint programming, harmonization and simplification and recommends options for further consideration.





## EB.A/2006 (12–16 June)

### ➤ *Annual Performance Report for 2005 (A)*

General Rule VII.2 states: "Each year the Executive Director shall submit to the Board for its approval an Annual Report and other reports as directed by the Board". Governance recommendation (h), approved by the Board at its Third Regular Session in 2000 (decision 2000/EB.3/1—Follow-up to Executive Board decision 2000/EB.A/6 on Governance), states: "An Annual Performance Report should be developed" based on the Biennial Management Plan previously approved.

The Annual Performance Report for 2005 aims to present a relevant and credible analysis of WFP's performance in terms of the commitments made for the year, as defined in the Strategic and Management Plans for 2004–2007.

### ➤ *Mainstreaming Economic Analysis (C)*

The paper, for consideration, will define the role and application of economic analysis in WFP, including in formulating country programmes and operations, and in designing sectoral strategies. It will draw lessons from ongoing initiatives, including: ensuring WFP's activities support Poverty Reduction Strategy Papers and national sectoral development programmes; and, applying market analysis within the emergency needs assessment process.

### ➤ *Food for Education (C)*

This paper, for consideration, highlights the role that food aid interventions (including school feeding) can play in support of food for education objectives. The paper also clarifies the difference between food for education and school feeding.

### ➤ *Status Report on Emergency Needs Assessment (I)*

At its Third Regular Session in 2004, the Board took note of the proposed 30-month implementation plan for strengthening WFP's emergency needs preparedness. This document provides an overview of progress and achievements of the implementation plan and describes the next steps for the transition period that will result in the mainstreaming of core activities into WFP regular functions in 2008–2009. This document is submitted to the Board for information.

### ➤ *Update on HIV/AIDS (C)*

At its First Regular Session in 2003, the Board requested to be kept informed each year on the status of WFP HIV/AIDS activities and relations with the Joint United Nations Programme on HIV/AIDS (UNAIDS). Moreover, in 2005, the UNAIDS Executive Board urged all governing bodies of the organization's co-sponsors to consider and endorse the recommendations of the Global Task Team (GTT) on improving AIDS coordination among multilateral donors and international donors. The present update is therefore submitted to the Board for consideration and for endorsement of the GTT's recommendations.

## EVALUATION REPORTS

### EB.1/2006 (20–24 February)

The evaluation document submitted under this item is presented to the Board for consideration. The Board is requested to take note of the report and the associated information note summarizing the action taken so far by management in implementing the recommendations.

➤ *Evaluation of WFPs Assistance to China (1979-2005)*

The evaluation took place between May 2004 and October 2005 including a preparatory mission in June 2004 and a three-week field mission in May 2005. As WFP is ending operational activities in China in December 2005, the summary report includes a desk review of the period 1979–2000 as well as an evaluation of the last country programme in order to resume findings and lessons to be learned from the entire period. The report focuses on the results achieved and the partnerships with the Government of China and other partners, particularly the International Fund for Agricultural Development (IFAD).

➤ *Thematic Evaluation of Targeting in Relief Situations*

In cooperation with the Strategy, Policy and Programme Support Division (PSP), OEDE will undertake in 2004-2005 a thematic evaluation on challenges and constraints facing WFP in the effort to ensure efficient and effective targeting. The evaluation results should support new corporate policy formulation, especially in relation to relief targeting. It will focus on selected relief situations that are on-going or that have recently been completed.

➤ *Thematic Evaluation of Nutrition Interventions*

As a follow-up to the “Desk Review of Mother-and-Child Nutrition (MCN) Activities” undertaken in 2002, the Nutrition Service (PSPN) has requested OEDE to carry out a thematic review of current approaches in WFP-supported nutrition interventions, based on four case studies in different geographical regions. The review, carried out between January and August 2005, assessed the extent to which the four principles essential for the success of MCN programmes have been applied and their effectiveness in reaching programme objectives.

➤ *Joint UNHCR-WFP Evaluation of the Pilot Food Distribution Projects*

The main objective of the evaluation jointly undertaken by the Office of the United Nations High Commissioner for Refugees (UNHCR) and WFP was to assess the effectiveness of the new arrangement under which WFP assumes responsibility for food distributions in refugee operations, piloted in five countries. Evaluation findings should facilitate future decisions by UNHCR and WFP on whether food distributions should be handed over to WFP.

### EB.A/2006 (12–16 June)

The evaluation documents submitted under this item are presented to the Board for consideration. The Board is requested to take note of the reports and the associated information note summarizing the action taken so far by management in implementing the recommendations.

➤ *Evaluation of the Niger EMOP*

Evaluation of WFP's response to the Niger emergency (EMOP 10398.0 – “Assistance to Populations Affected by the Drought and Locust Infestations in 2004”). The evaluation will take into account the results of the After Action Review organized jointly by the Government and WFP's Operations Department and scheduled for late November 2005. The evaluation is intended to be a joint undertaking with United Nations (UN) partners.



➤ *Evaluation of the Yemen CP*

The evaluation of the second CP in Yemen intends to assess the extent to which the CP as designed and implemented has provided the best possible modalities of reaching intended objectives, on the basis of results to date. With respect to findings regarding relevance, efficiency, effectiveness and sustainability of the current CP, the evaluation will provide leads for designing the next WFP CP in Yemen.

➤ *Evaluation of the Bhutan CP*

The evaluation of Bhutan's first CP undertaken in September 2005, will provide guidance for the future direction of WFP activities in Bhutan.

➤ *Evaluation of the Somalia PRRO*

The evaluation of the Somalia protracted relief and recovery operation (PRRO), conducted in-country in July 2005, focused on the relevance and effectiveness of intervention approaches in order to respond to vulnerability in the Somali context. In this context, other issues such as coordination, partnership and monitoring and evaluation (M&E) were also examined.

➤ *Evaluation of the Central American PRRO*

The evaluation took place between November 2004 and November 2005 including a preparatory mission in November 2004 and a four-week field mission to all four countries included in the PRRO in April 2005. The evaluation assesses progress towards results with the purpose of contributing to the design of the next phase of the PRRO, particularly as with regards nutrition interventions and food-for-work activities.

## **EB.2/2006 (6–10 November)**

The evaluation documents submitted under this item are presented to the Board for consideration. The Board is requested to take note of the reports and the associated information note summarizing the action taken so far by management in implementing the recommendations.

➤ *Evaluation of the Darfur EMOP*

The evaluation of the first phase of WFP's EMOP in Darfur will cover the period January to December 2005. Scheduled for implementation in early 2006, it follows a 2004 evaluation of WFP's emergency activities in the Sudan, and will draw heavily on this as well as several key partner evaluations undertaken in 2005.

➤ *Evaluation of the Colombia PRRO*

The evaluation of this PRRO in support of internally displaced persons in Colombia is planned to take place in the second half of 2005 and the first half of 2006 in order to contribute to the preparation of a possible new PRRO. Together with the country office and key stakeholders, a concept paper will be developed and a preparatory mission will take place to identify the key issues. The evaluation mission will take place in April 2006.

➤ *Evaluation of Impact of Evaluation Work in WFP*

The evaluation will be undertaken at the request of the Board as expressed during the annual informal consultation on evaluation held in May 2005. It will take into consideration OEDE's "Study on WFP's follow-up to evaluation recommendations" submitted to the Annual Session in 2005, and is expected to be one of the building blocks for the external peer review scheduled for 2007.

## **EB.1/2007 (19–23 February)**

The evaluation document submitted under this item is presented to the Board for consideration. The Board is requested to take note of the report and the associated information note summarizing the action taken so far by management in implementing the recommendations.

➤ *Evaluation of the India CP*

The evaluation is planned to take place in the second half of 2005 and the first half of 2006 in order to contribute to the preparation of a possible new country programme. At the time of writing, a concept paper is being developed and a preparatory mission will take place in early November 2005 to identify the key issues of the evaluation in collaboration with the country office and key stakeholders. It is anticipated that the evaluation will focus on the country office's efforts to build partners' capacity in food aid management and advocate for food security. The evaluation mission will take place in April 2006.



➤ *Thematic Evaluation of School Feeding in Emergency Situations*

The Office of Evaluation will undertake a thematic evaluation of its school feeding programme in emergencies, with the aim of assessing its relevance, effectiveness and sustainability in such contexts. The evaluation should be based on a combination of desk research and field-based case studies among WFP's ongoing PRROs and EMOPs.

➤ *Evaluation of the Sierra Leone CP*

This is a mid-term evaluation of Sierra Leone's first CP, which is a continuation of the two ongoing development projects dealing with mother-and-child health and nutrition and primary school feeding. Particular emphasis will be given to the effectiveness of recovery strategies to rehabilitate, create and maintain assets, facilitating the transition towards peace. The evaluation is tentatively scheduled for the second half of 2006.

➤ *Evaluation of Haiti PRRO*

The evaluation of this PRRO is tentatively planned for the first half of 2006. It will examine whether the intervention approach has adequately addressed the immediate food needs of those most affected by crises and helped them to recover their food security.

➤ *Evaluation of the Indonesia PRRO*

The evaluation of this PRRO is planned to take place in the second half of 2006 in order to contribute to the preparation of a possible new PRRO. Together with the country office and key stakeholders, a concept paper will be developed and a preparatory mission will take place to identify the key issues.

## **EB.A/2007 (4–8 June)**

The evaluation document submitted under this item is presented to the Board for consideration. The Board is requested to take note of the report and the associated information note summarizing the action taken so far by management in implementing the recommendations.

➤ *Evaluation of the Palestinian Territory PRRO*

As in the case of the Sierra Leone CP, the Palestinian Territory PRRO will be subjected to a mid-term evaluation tentatively scheduled for the second half of 2006. It shall look at progress towards stated objectives and factors that have positively or negatively affected this progress.

➤ *Evaluation of Ethiopia PRRO 10362.1*

The mid-term evaluation of the Ethiopia PRRO tentatively scheduled for the second half of 2006 shall examine in particular the effectiveness of the intervention approaches and their potential impact on people's livelihood, including graduation from chronic vulnerability.

➤ *Evaluation of the Southern Africa Regional PRRO*

The evaluation of the Southern Africa regional PRRO — "Assistance to Populations in Southern Africa Vulnerable to Food Insecurity and the Impact of Aids" is on OEDE's programme of work for the second time (the first evaluation took place in 2002) in view of the size and scope of this PRRO (US\$404.5 million). It is planned for the second half of 2006. Among other things, the findings will serve as an input to the thematic evaluation of WFP's HIV/AIDS interventions.

➤ *End-of-term Evaluation of WFP's Enhanced Commitments to Women*

In line with the Gender Policy (2003–2007), an end-of-term evaluation of WFP's enhanced commitments will be conducted in the first half of 2007. This evaluation will assess the extent to which the gender policy has been fully applied and commitments implemented, as well as the difference they have made on institutional mechanisms.





## EB.2/2007 (22–26 October)

The evaluation document submitted under this item is presented to the Board for consideration. The Board is requested to take note of the report and the associated information note summarizing the action taken so far by management in implementing the recommendations.

➤ *Evaluation of Emergency Needs Assessment in WFP*

The evaluation of the Strengthening of Emergency Needs Assessment Capacity project (SENAC) will be undertaken at the request of the Emergency Needs Assessment Branch (ODAN) and SENAC's steering committee, including the European Community Humanitarian Office (ECHO) and other donors. The report was originally scheduled to be presented to the Board's Second Regular Session in 2006, but the September 2005 interim review recommended rescheduling the evaluation to the first half of 2007.

➤ *Evaluation of WFP's HIV/AIDS Interventions*

This evaluation, tentatively planned for 2007, intends to take stock of WFP's growing experience with regard to HIV/AIDS in order to identify best practices. The focus will be on strategic and operational approaches with regard to prevention, care and treatment. Targeting issues, particularly for orphans and children will also be assessed.

➤ *Meta-Evaluation of EMOPs*

Following the thematic evaluation of the CP (2002) and PRRO (2004) programme categories, the Office of Evaluation plans to undertake a meta evaluation of the EMOP programme category in the first half of 2007. This evaluation will look at generic issues.

➤ *Evaluation of Southern Sudan PRRO*

At time of writing, the exact vehicle (EMOP/PRRO) for continued assistance to Southern Sudan in the first full year following the 2005 peace agreement is not yet determined. However, WFP activities are certain to include significant efforts to reintegrate long-term refugees and displaced people, as well as to rebuild, enhance and protect their livelihoods. Last evaluated in 2004, OEDE will lead a fresh evaluation of these critical efforts by late 2007.
