Between 1 January and 30 June 2002, the Executive Director authorized 15 budgetary increases within his delegated authority for approved projects. The total food value of these increases amounts to US\$7,485,202 and the total cost to WFP to US\$11,640,960. Detailed budgetary figures and reasons for each increase are given overleaf.
