At the Third Regular Session of the Executive Board, in October 2001, the Board requested to be regularly informed about emergency operations (EMOPs) approved either under the delegated authority of the Executive Director or jointly by the Executive Director and the Director-General of the Food and Agriculture Organization of the United Nations (FAO).

- 2. The first such report was presented to the Board at its Second Regular Session of 2002, and concerned the previous year. The information will now be provided twice a year. At this, the Third Regular Session of the Board, a report is provided for the period January to June 2002, and at the First Regular Session of the Board in 2003, in February, a report will be provided for the second half of 2002.
- 3. To ensure that Executive Board members are adequately informed without duplicating information already provided through other sources, the reports will include the list of approved emergency operations with the main project statistics and a brief overview of figures and key trends. More-detailed country-specific information is not provided, because it is already shared with Board members through the Yellow Pages document issued at each Board session.
- 4. A total of 25 EMOPs were approved from 1 January to 30 June 2002, to assist more than 28.2 million vulnerable people in urgent need of food aid, in 20 countries. Ten of these EMOPs were approved jointly by the Executive Director and the Director-General of FAO and 15 were approved under the delegated authority of the Executive Director, including five immediate-response EMOPs approved locally, by Country Directors, under the authority delegated to them by the Executive Director. These 25 operations represent a commitment of over 2.1 million tons of food, with a food cost of US\$428 million and an expected overall operational and support cost to WFP of over US\$1.1 billion.
- 5. Appropriate information for all emergency operations approved during the first half of 2002 has been listed in the attached tables, according to their approval level.
- 6. The Executive Director and the Director-General of FAO jointly approved ten emergency operations with an individual value of committed food in excess of US\$3 million, in: Afghanistan, the Democratic Republic of the Congo, Ethiopia, Kenya, Malawi, Mozambique, Pakistan, Palestinian Territory, southern Africa¹ and Sudan. More than 27.6 million² vulnerable people are expected to receive relief assistance from WFP through these EMOPs, which have a cumulative food commitment of over 2 million tons, valued at US\$412 million. The overall cost of these operations to WFP, including transport and support costs, is expected to be over US\$1 billion, representing over 97 percent of the value of all EMOPs approved.
- 7. Ten emergency operations with an individual food value below US\$3 million were approved under the delegated authority of the Executive Director, in: Cape Verde, Central African Republic, Ethiopia, Guatemala, Lesotho, Malawi (two), Mauritania, Namibia and Swaziland. These ten EMOPs will help more than 1 million vulnerable people in

immediate need of food aid. The food value of these operations is US\$15.4 million, representing a commitment of approximately 63,700 tons of food. The overall cost to WFP of these EMOPs is expected to reach US\$29 million. The beneficiaries in Lesotho and Swaziland, and some in Malawi, have also received subsequent WFP assistance under the regional EMOP for southern Africa.³

- 8. WFP Country Directors used the authority delegated to them by the Executive Director to approve five immediate-response EMOPs, each with an overall cost of up to US\$200,000, in: Cape Verde, Central African Republic, Mauritania, Senegal and Syria. Almost 78,000 vulnerable people were assisted through the WFP immediate-response EMOPs. The food value of these projects was just over US\$535,000, representing a commitment of approximately 2,100 tons of food. The overall cost to WFP of these operations was over US\$875,000. The beneficiaries in Cape Verde and Mauritania were also assisted through subsequent EMOPs approved under the delegated authority of the Executive Director.
- 9. Of the 25 emergency operations approved (in 20 countries), 20 operations were in Africa (in 15 countries), four in the Mediterranean, Middle East and Central Asia Region and one in Latin America and the Caribbean Region. Africa remains the continent with the highest number of emergency operations, many of which are in the eastern and southern Africa region.
- 10. Requirements for emergency operations in the ten countries listed below represented over 90 percent of the overall emergency needs of WFP during the first half of 2002. WFP's focus was on southern Africa, where seven emergency operations covering six countries (Lesotho, Malawi, Mozambique, Swaziland, Zambia and Zimbabwe) were approved, representing almost half of all the emergency resources approved. The other main EMOPs approved during the first six months of 2002 included those for Afghanistan, representing 25 percent of the overall emergency requirements, Sudan (11.8 percent), Ethiopia (4.5 percent) and Kenya (3.2 percent).
- 11. Around 87 percent of the emergency food needs have resulted from drought and crop failures, including those in Afghanistan, Cape Verde, Ethiopia, Guatemala, Kenya, Mauritania and southern Africa. WFP emergency resources required in response to conflict situations represented almost 12 percent of the emergency needs, mainly in Afghanistan, Central African Republic, Ethiopia, Namibia, Palestinian Territory and Sudan. In some countries, the food crisis was the result of a combination of factors. In Afghanistan, Ethiopia and Sudan, WFP has been assisting populations affected by both conflict and crop failures. In southern Africa, the food crisis caused by environmental factors such as drought and flooding was exacerbated by a complex interplay of economic and political factors.
