Between 1 January and 30 June 1999, the Executive Director authorized ten budgetary increases within her delegated authority for approved projects. The food value of these increases amounts to US\$3 million, and the total cost to WFP to US\$14.8 million. Detailed budgetary figures and reasons for each increase are given overleaf.
